#### **RACE COMMENTS**

# Race 1 RICCARTON PARK FUNCTION CENTRE 2600m

PRINCE ALBY (K Mudhoo) - Slow to begin.

**NOBLE KNIGHT** (K Chowdhoory) – Over raced in the early and middle stages on a moderate tempo. When questioned regarding performance, the rider advised that the gelding had failed to handle today's testing track conditions. A post-race veterinary inspection did not reveal any obvious abnormality.

**MADISON ROSE** (C Barnes) - Began awkwardly and was then hampered shortly afterwards when crowded losing some ground. Commenced to over race passing the 1600 metres and was allowed to improve forward to lead passing the 1200 metres.

**DUNHILL** (L Douglas) - Steadied off the heels of the weakening IDLE LADY near the 600 metres.

**IDLE LADY** (T Comignaghi) - Rider reported that the mare had failed to handle today's testing track conditions.

**L Douglas** (DUNHILL) - Admitted a charge in that he struck his mount DUNHILL 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

#### Race 2 SPEIGHT'S ULTRA ON TAP 1400m

**PLATINUM ROAD** (C Lammas) - Jumped away awkwardly. Dictated outwards by SURCHARGE near the 200 metres. Rider C Lammas viewed film footage following the race but did not proceed with an objection.

AREYOUOKAY (B Rogerson) - Bounded at the start losing ground. Raced three wide without cover throughout.

**ROYAL KHAN** (T Taiaroa) - Slow to begin.

**GOODANYA** (T Moseley) - Bumped with TAIL LIGHTS near the 350 metres when both runners shifted ground. Placed in restricted room near the 300 metres.

**TAIL LIGHTS** (T Comignaghi) - Bumped with GOODANYA near the 350 metres when both runners shifted ground, with TAIL LIGHTS then having to steady and shift inwards across heels.

LA RAPIDE (L Callaway) - Rider dropped his whip passing the 350 metres.

### Race 3 COUPLAND'S BAKERIES MAIDEN 1400m

**PEARL OPULENCE** (K Mudhoo) - Began awkwardly losing ground.

**PEUT RESPIRER** (K Chowdhoory) - Jumped away awkwardly getting its head up.

**RUBY SUNRISE** (T Moseley) - Shifted inwards abruptly at the start making firm contact with SATELLITE which in turn contacted BELLA ROSE.

**PERIA'S LEGACY** (D Bothamley) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**LOQUITA** (K Williams) - Lay in throughout the run home having to be straightened on a number of occasions, with the rider reporting that the mare had hung inwards throughout the running giving her a difficult ride.

**BALTIMORE** (T Jonker) - Was not persevered with over the concluding stages dropping out to finish a distant last. When questioned regarding performance rider advised that the gelding had got its tongue over the bit. A post-race veterinary inspection did not reveal any obvious abnormality.

**S Muniandy** (LADY'S LEGACY) - Admitted a charge in that he struck his mount LADY'S LEGACY 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

## Race 4 POLYTRACK RACING SEASON STARTS 4 MAY 1600m

FINAL SAVINGS (T Taiaroa) - Began awkwardly losing ground.

**SEA SHEPHERD** (C Campbell) - Raced wide without cover throughout. When questioned regarding performance, the rider advised that the gelding had never travelled well in today's testing, holding track conditions. A post-race veterinary inspection did not reveal any obvious abnormality.

**TAKE THE DEEL** (G Jogoo) - Over raced when disputing the pace through the middle stages.

**LINCOLN COUNTY** (R Elliot) - Rider advised that the gelding had failed to handle today's testing track conditions.

## Race 5 D REYNOLDS ELECTRICAL 2YO 1000m

**ON THE ROAD AGAIN** (C Campbell) - Bounded at the start then further hampered losing ground when inside runners shifted out. Raced greenly throughout and was not persevered with in the run home, with the rider reporting he felt there may have been something amiss. A post-race veterinary inspection did not reveal any obvious abnormality.

**WEST VIRGINIA** (T Moseley) - Bounded at the start losing ground.

**GWYNVER** (K Mudhoo) - Blundered leaving the barriers.

**CU CHULAINN** (J Laking) - Began awkwardly shifting outwards forcing DOMPERION outwards into the line of ON THE ROAD AGAIN which was hampered. Was inclined to lay outwards in the straight. Rider reported that the gelding had not been entirely comfortable in today's testing track conditions in combination with its clear top weight.

**DOMPERION** (T Comignaghi) - Contacted and unbalanced leaving the barriers then being inclined to over race in the early stages getting its head up.

## Race 6 ARDROSSAN AT WAIKATO STUD HANDICAP 1200m

**OKAY PAL** (R Elliot) – Stood flat footed as the start was effected losing several lengths. Connections were advised that the gelding would be required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. Co-Trainer M Pitman advised it was their intention to spell the gelding before returning to the trials.

**ZOULANDER** (K Chowdhoory) - Began awkwardly losing ground.

**HENRY HUBBER** (K Williams) - Shifted outwards at the start crowding and contacting IHU.

**IHU** (D Bothamley) - Crowded and contacted at the start. When questioned regarding performance, rider advised that the gelding had failed to handle today's track conditions. A post-race veterinary inspection revealed a slow recovery rate.

**AVAQUINELLA** (T Comignaghi) - Inconvenienced approaching the 400 metres when HENRY HUBBER shifted outwards to obtain clear running.

**CONOR O'CEIRIN** (C Barnes) - When questioned regarding performance, rider advised that the gelding had failed to handle today's track conditions.

#### Race 7 ANZAC DAY TUESDAY – LEST WE FORGET 1400m

**TOMYTURBO** (K Chowdhoory) - Began awkwardly losing ground. Steadied when awkwardly placed near the heels of FATHER LENIHAN (B Rogerson) which shifted outwards slightly near the 300 metres. B Rogerson was advised to exercise greater care.

CHEEKINI (C Barnes) - Jumped away awkwardly making contact with NIGHT RAIDER.

HIGHLAND FLING (K Mudhoo) - Slow to begin.

NIGHT RAIDER (C Lammas) - Crowded at the start when runners either side shifted ground.

**ANNELIESE** (R Elliot) - Raced ungenerously in the early stages getting its head up.

KOPUTAROA (T Taiaroa) - Over raced in the early stages.

**CHARBANO** (T Comignaghi) - Raced greenly under pressure in the straight.

**ROYAL VALOUR** (J Laking) - Raced wide without cover. When questioned regarding his ride, J Laking advised that the gelding had not felt to be travelling particularly well in the going rounding the final turn, but once balanced early in the straight and after shifting back towards the inside for clear running found the line better than he had anticipated over the concluding stages. J Laking agreed with Stewards that he should have shown more vigour inside the final 200 metres, with his explanation being noted.

Trainer **S Marsh** (NIGHT RAIDER) was fined \$50 under the Minor Infringement Schedule after presenting NIGHT RAIDER without the notified pre-race ear covers.

#### Race 8 NEW ZEALAND BLOODSTOCK WARSTEP STAKES 2000m

SEVEN ELEVEN (K Chowdhoory) - Slow to begin.

**CHAPINTEEL** (T Moseley) - Slow to begin.

ZA BEAUTEOUS (L Douglas) - Slow to begin.

**LUELLA CRISTINA** (C Lammas) - Raced in restricted room having to be steadied near the 1800 metres. Struck a heel of MISS LAYLA and blundered badly near the 600 metres when MISS LAYLA shifted outwards after making contact with GENERATION JOY. Lay inwards under pressure in the straight.

MISS DUNSFORD (S McKay) - Checked near the 1750 metres.

**FAMILY TIES** (C Barnes) - Raced three wide without cover for the majority of the race. Hampered near the 750 metres.

**BETTY SPAGHETTI** (K Mudhoo) - Hampered near the 750 metres.

MISS LAYLA (L Callaway) - Contacted and forced wider by GENERATION JOY near the 750 metres then continued to come together with that runner for some distance. Steadied near the 500 metres when held up behind the weakening INFLAMED.

**GENERATION JOY** (S Muniandy) – Made contact with MISS LAYLA near the 750 metres then continuing to come together with that runner for some distance.

**INFLAMED** (C Campbell) - When questioned regarding performance, rider advised that the filly had failed to cope with the step up in distance and today's testing track conditions. A post-race veterinary inspection revealed a slow recovery rate.

- **L Callaway** (MISS LAYLA) Admitted a charge of careless riding in that he permitted his mount MIS LAYLA to shift inwards forcing GENERATION JOY across the heels of INFLAMED approaching the 600 metres. After considering submissions the Adjudicative Committee imposed a suspension of L Callaway's licence to ride in races from the conclusion of racing on Thursday 27 April until the conclusion of racing on Wednesday 3 May, 4 national riding days.
- **S Muniandy** (GENERATION JOY) An information alleging a charge of careless riding was filed with the Adjudicative Committee in that S Muniandy permitted his mount GENERATION JOY to shift inwards when not sufficiently clear of MISS DUNSFORD which was checked passing the 1700 metres.
- **S Muniandy** (GENERATION JOY) An information alleging a charge of careless riding was filed with the Adjudicative Committee in that S Muniandy permitted his mount GENERATION JOY to shift outwards making contact with and forcing MISS LAYLA outwards onto BETTY SPAGHETTI and FAMILY TIES which were both hampered losing ground approaching the 750 metres. Due to S Muniandy's travel commitments, the hearing of these two informations was adjourned to a date to be set.

# Race 9 COCA-COLA CANTERBURY GOLD CUP (G3) 2000m

PLATINUM INVADOR (R Elliot) - Slow to begin.

**TIMES TICKING** (J Lowry) - Slow to begin.

**ASATHOUGHT** (C Campbell) - Crowded at the start losing ground.

**DEELS DONE** (K Mudhoo ) - Shifted out at the start crowding outside runners.

VERNANME (C Lammas) - Over raced in the early to middle stages and wide throughout.

TIMES TICKING (J Lowry) – Held up rounding the final turn.

**J Lowry** (TIMES TICKING) - Admitted a charge in that he weighed in 0.8 kg in excess of his weigh out weight and was fined \$200 under the Minor Infringement Schedule.

**R Elliot** (PLATINUM INVADOR) - Admitted a charge in that he struck his mount PLATINUM INVADOR 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

### Race 10 RACECOURSE HOTEL & MOTOR LODGE 1800m

**SASSY CHOUXS** (G Jogoo) - Delayed the start when reluctant to load and being inclined to kick out. SASSY CHOUXS is now required to barrier trial to the Satisfaction of a Stipendiary Steward prior to racing next. Rider reported that the mare had been making abnormal breathing noises during the running.

IT'S THE VIBE (K Mudhoo) - Began awkwardly.

**VULTURE STREET** (J Lowry) - Slow to begin.

**POMANDER** (T Taiaroa) - Jumped away awkwardly then being further hampered when crowded between runners shortly after the start.

**UGO** (K Chowdhoory) - Jumped away awkwardly then steadied when crowded shortly after leaving the barriers. Was inclined to over race in the middle stages.

**K Chowdhoory** (UGO) - Admitted a charge in that he struck his mount UGO 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of K Chowdhoory's licence to ride in races from the conclusion of racing on Thursday 27 April until the conclusion of racing on Wednesday 3 May, 4 national riding days, and in addition imposed a fine of \$500.
