**Race 7 RIVERSTONE CAFE MAIDEN 1600** 

**WIND IN MY WINGS** (D Turner) – Trainer Ms. Lucy Tanner advised Stewards she was satisfied with the post-race condition of the gelding, and it is her intention to continue on with WIND IN MY WING'S current preparation.

#### **RACE COMMENTS**

### Race 1 POWERWORX OPUNAKE CUP SATURDAY 23<sup>RD</sup> JULY (2000M)

**TAHI TAMA** (L Douglas) – Fractious in the barrier prior to the start.

**SPANISH HARLEM** (J Mudhoo) – Slow away.

**QUOTA** (L Allpress) – Slow away.

BRICKIE'S MOJO (A Lawson-Carroll) - Slow away.

**SHEZ SUPER** (M McNab) – Raced wide throughout. When questioned regarding performance rider advised that after being caught wide the mare had been a beaten runner prior to entering the final straight in today's testing track conditions and he was of the opinion that it may be better suited to dropping back in distance to 1600 metres. A post-race veterinary examination did not reveal any abnormalities.

**BODACIOUS** (J Chung) – When questioned with regards to performance rider could offer no tangible excuse.

## Race 2 BC 2 BAYLEYS REAL ESTATE TARANAKI 2000 (2000M)

**COLIN OSCOPY** (A Lawson-Carroll) – Jumped away awkwardly getting its head up then refusing to gallop taking no active part in the race. The connections were advised COLIN OSCOPY will be required to barrier trial to the satisfaction of a Stipendiar Steward prior to next racing.

**CAPALDI** (R Beemud) – Crowded shortly after the start.

ESTABLISHMENT (M McNab) - Lay in near the 200 metres inconveniencing FORTUNE WINGS.

FORTUNE WINGS (T Mitchell) – Inconvenienced near the 200 metres.

**HOLD MY BEER** (D Turner) – When questioned regarding performance rider was unable to offer any excuse advising that the gelding had felt disinterested in today's testing track conditions. Underwent a post-race veterinary inspection which not reveal any abnormality.

**D Turner** – Fined \$300 by the Adjudicator after admitting a charge in that he failed to make the weight for HARD TIMES having to be replaced on that runner by K Hercock.

**C Grylls** – Fined \$100 under the Minor Infringement schedule in that he failed to make the weight for OCEANIDES having to be replaced on that runner by C Dell.

### Race 3 GRANGEWILLIAM STUD MAIDEN (1200M)

**FLEMING** (L Allpress) – Jumped away awkwardly. Had a tendency to over race when being restrained in the early to middle stages.

**LEON ROUGE** (J Parkes) – Slow away.

**CASTLE ESS OH ES**S (M Sanson) – Slow away. When questioned regarding performance rider advised the gelding failed to handle today's existing track conditions.

**PASHAMALA** (B Rogerson) – Raced ungenerously in the early and middle stages. Lay out rounding the final turn and was then inclined to lay inwards under pressure in the straight.

**TURNAROUND** (C Dell) – Awkwardly placed on heels having to be steadied near the 900 metres.

**UNLEASHED** (C Grylls) – Made the bend awkwardly near the 600 metres placing SOVIET WONDER in restricted room.

**SOVIET WONDER** (L Sutherland) – Placed in restricted room near the 600 metres.

**B Rogerson** – Taking into account her clear record was issued with a warning for striking her mount PASHAMALA six times prior to the 100 metres.

#### Race 4 REVITAL FERTILISER 1200

**SHOWSHANELLE** (K Hercock) – Slow away.

LITTLEREDCORVETTE (L Douglas) – Restrained to the rear shortly after the start.

**THATZ DAISY** (L Allpress) – Placed in restricted room around the final turn near the 350 metres when CATSACHARMER shifted inwards when not fully clear. Apprentice A Bohorun was advised to exercise greater care when shifting ground.

**TINY TERROR** (K Hannan) – When questioned into performance rider advised that she felt the gelding had held its breath and had not been suited to the fast tempo of the race through the early and middle stages in today's testing track conditions.

#### Race 5 PLATINUM HOMES TARANAKI 1400

**MIGHTY CASTLE** (M McNab) – Was removed from the barriers to undergo a veterinary inspection after kicking out at the back gate being declared a late scratching on veterinary advice at 2.02 pm. Received post-race veterinary treatment for superficial abrasions to the right hock.

**ODYSSEUS** (V Jalalkuncha) – Slow away.

**REGAL ROCK** (L Douglas) – Began awkwardly.

**Vikas Jalalkuncha** – Taking into account his clear record was issued with a warning for striking his mount ODYSSEUS six times prior to the 100 metres.

#### Race 6 STELLA ARTOIS MAIDEN (1400M)

**CHERRY ROSE** (A Bohorun) – Crowded at the start losing ground.

MISS RAINEY (C Grylls) – Had to be steadied passing the 1300 metres when awkwardly placed near the heels of TAVI ANN.

**JUST A TIPPLE** (N Parmar) – Jumped away awkwardly. Over raced in the middle stages with the saddle shifting forwards near the 800 metres, badly inconveniencing the rider for the remainder of the race and not being persevered with.

**TAVI ANN** (A Mudhoo) – Inconvenienced near the 350 metres when CYA MARIA was taken out by LOOX LIKE A PRO which lay out entering the final straight.

LOOX LIKE A PRO (C Dell) – Lay out under pressure in the straight.

**MANDIRANCAN** (L Allpress) – When questioned regarding performance rider advised that the filly had travelled well enough but once placed under pressure had been unable to quicken in today's track conditions. A post-race veterinary inspection did not reveal any abnormality.

## Race 7 NEXT RACEDAY SATURDAY 23<sup>RD</sup> JULY MAIDEN (1600M)

ARICINA (A Bohorun) – Began awkwardly losing ground.

**ZEEFA ZED** (C Grylls) – Slow away.

**KASUDA** (M McNab) – Came under pressure approaching the 600 metres but failed to respond and commenced to give ground not being persevered with in the straight dropping out to finish a distant last. When questioned into performance rider was unable to offer any excuse advising that the mare had been a beaten runner passing the 600 metres. A post-race veterinary examination did not reveal any abnormality.

### Race 8 POWERWORX 1600

INDIE'S JOY (T Taiaroa) – Hampered at the start when FAYE'S WARRIOR jumped inwards.

KHANT CATCH HER (L Allpress) – Hampered shortly after the start when KAPONGA lay out.

KAPONGA (K Hercock) – Began awkwardly hampering KHANT CATCH HER.

**RONIN POROTENE** (L Douglas) – Crowded shortly after the start.

FLIGHT PLAN (D Turner) - Began awkwardly.

**FAYE'S WARRIOR** (M McNab) – Began awkwardly hampering INDIE'S JOY. When questioned into performance rider was unable to offer any excuse other than failing to handle today's track conditions. A post-race veterinary examination did not reveal any abnormality.

**ZADANE** (N Parma) – Raced in restricted room near the 1200 metres.

WHEELITIN (A Mudhoo) - Raced in restricted room near the 1200 metres.

**L Douglas – A**dmitted a charged in that he struck his mount RONIN POROTENE 8 times prior to the 100 metre mark. The Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing today Friday 1 July until the conclusion of racing on Saturday 9 July, 5 national riding days.
