**GENERAL**

Rider **B May** did not attend today's meeting with replacements as per the above Summary.

**RACE COMMENTS****Race 1 KN COOLAINER PREMIER 1400m**

**SWISSWATCH** (L Sutherland) - Began awkwardly losing ground.

**KHIMAR WAR** (R Elliot) – Lost its footing and blundered at the start losing ground.

**MY WORLD** (K Chowdhury) - From a wide draw restrained shortly after the start to obtain cover.

**LIGHTNING JACK** (M Taylor) - Commenced to race ungenerously and when doing so improved onto heels clipping a heel and blundering near the 1100 metres.

**ROCK SENSATION** (D Montes de Oca) - Raced wide without cover.

**AVAQUINELLA** (T Comignaghi) - Held up early in the straight having to shift ground inwards to obtain clear running near the 200 metres.

**PHELAN THE POWER** (J Laking) - When asked to comment on the performance of this favoured runner, rider advised he had had a good run throughout but when placed under pressure had failed to respond, and in his opinion the gelding had not backed up from its previous run at last Wednesday's meeting.

**Race 2 WUHAN JOCKEY CLUB TROPHY PREMIER 1200m**

**CANDIDATE** (C Campbell) - Slow to begin.

**KAPALKA** (K Chowdhury) - Slow to begin.

**CATALINA BAY** (M McNab) - Slow to begin.

**ZOULANDER** (S Wynne) - Began awkwardly losing ground.

**TWIN SHOT** (K Asano) - Began awkwardly making contact with HELSINKI and was then further hampered when crowded losing ground.

**OH NO NO NO** (T Moseley) - Began very awkwardly losing considerable ground.

**GELATO** (L Allpress) - Lost its footing at the start losing ground.

**HEMI RIDAPEST** (C Grylls) - When questioned regarding performance, rider was unable to offer any excuse other than possibly not backing up from its win on the first day of the meeting.

**LORNA DOON** (S Spratt) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection LORNA DOON was confirmed to have bled. LORNA DOON shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**D Stackhouse** (HELSINKI) - Admitted a charge in that he struck his mount HELSINKI 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Stewards also viewed footage of D Stackhouse's ride over the concluding stages as to possible whip use in two consecutive strides, but were satisfied after viewing the head-on film that in the second movement no contact had been made with the horse.

Race 3	<b>CASHMERE ESTATE LIVE WITHOUT COMPROMISE PREMIER 1200m</b>

**RADIANT ROSIE** (T Moseley) - Reared as the start was effected making contact with JUSTANACE and as a result lost ground.

**STREET FIGHTIN MAN** (J Laking) - Slow to begin.

**BENAUD** (D Montes de Oca) - Slow to begin. Held up rounding the final turn and early in the straight before obtaining clear running near the 200 metres.

**LEROY** (R Mudhoo) - Slow to begin.

**NO ROCK NO POP** (K Mudhoo) - Began awkwardly losing ground.

**JUSTANACE** (K Asano) - Contacted shortly after the start losing ground.

**SHEZZACATCH** (S Wynne) - Hampered and then buffeted shortly after the start losing ground. When questioned regarding performance, rider was of the opinion the mare may now be better suited over more ground. A post-race veterinary examination did not reveal any obvious abnormality.

**I AM A ROCK** (L Sutherland) - Firmly restrained to avoid the heels of KEEN TO RUN which was dictated inwards by WILD ROVER (K Chowdhury) near the 50 metres.

**K Chowdhury** (WILD ROVER) - Issued with a warning after permitting his mount WILD ROVER to shift inwards when not fully clear of KEEN TO RUN near the 50 metres.

Race 4	<b>BARNESWOOD FARM 50<sup>TH</sup> NZ 1000 GUINEAS (G1) 1600m</b>

The start was delayed approximately 7 minutes after a strap on the bridle of LEGARTO broke, with all runners being removed from the barriers while the bridle was replaced.

**KIKIMORA** (K Chowdhury) - Began awkwardly losing ground. Was inclined to over race in the early and middle stages getting its head up.

**LEGARTO** (R Elliot) - Began awkwardly losing ground.

**O'RIORDAN** (L Allpress) - Began awkwardly shifting outwards hampering PERFECTLY SUITED and as a result lost ground.

**PERFECTLY SUITED** (S Wynne) - Hampered shortly after the start being forced wider on the track losing ground and was then restrained behind runners to obtain cover.

Race 5	<b>AVON CITY FORD PREMIER 2500m</b>

**RIVIERA ROCK** (D Stackhouse) - Anticipated the start making contact with the front gate of its barrier stall which opened marginally ahead of the remainder of the starting gates, however Stewards were satisfied that RIVIERA ROCK did not gain any advantage.

**POLAR NIGHT** (T Comignaghi) - Blundered leaving the barriers.

**KHAFEEF** (S O'Malley) - Slow to begin. Over raced in the middle stages then hampered near the 1100 metres having to shift outwards to avoid heels when continuing to over race and raced wide from that point being forced wider rounding the final turn.

**SECOND THOUGHT** (M McNab) - Began awkwardly losing ground.

**YOUNEVERKNOW** (S Toolooa) - Raced three wide without cover throughout.

**EAVESDROP** (C Johnson) - Over raced passing the 1200 metres becoming awkwardly placed on heels and further restrained going back onto KHAFEEF which then shifted outwards hampering ZAMBEZI ZIPPER.

**ZAMBEZI ZIPPER** (M Taylor) - Hampered near the 1100 metres. Steadied when placed in restricted room between PINHEAD and EAVESDROP near the 600 metres.

**LETSBRINGITON** (S Wynne) - Crowded between DR VELOCIOUS and POLAR NIGHT near the 450 metres.

**PINHEAD** (K Chowdhury) - Held up near the 350 metres.

Race 6	<b>LINDAUER STEWARDS STAKES (G3) 1200m</b>

**OKAY PAL** (K Asano) - Slow to begin.

**BUOYANT** (M McNab) - Slow to begin.

**KOPUA** (T Comignaghi) - Blundered shortly after the start losing ground. Lost the right front plate during the running.

**LINCOLN'S KRUZ** (L Allpress) - Over raced badly through the early and middle stages with rider L Allpress advising that had proved detrimental to its chances. Held up passing the 450 metres continuing to have difficulty obtaining clear running until near the 300 metres.

**ROCKLAND** (K Williams) - Raced keenly through the early and middle stages.

**GOLDEN HARVEST** (S Wynne) - Steadied to avoid the heels of CAN I GET AN AMEN which was dictated outwards by OKAY PAL (K Asano) which shifted outwards when not fully clear near the 300 metres. Also hampered as a result was CHALLA.

**CHALLA** (S Spratt) - Hampered near the 300 metres.

**K Asano** (OKAY PAL) - Issued with a warning after permitting his mount OKAY PAL to shift outwards near the 300 metres when not fully clear of CAN I GET AN AMEN.

**D Montes de Oca** (EPTIMUM) - Admitted a charge in that he was unable to make the contract weight for EPTIMUM being replaced by S O'Malley. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 7	<b>VERNON VAZEY TRUCK PARTS PREMIER 1600m</b>

**MATSCOT** (T Moseley) - Very slow to begin losing several lengths. Held up early in the straight.

**TREYBON** (J Laking) - Slow to begin and was then further hampered when crowded shortly after the start losing ground.

**YAMUNA** (K Williams) - Made contact with LARPOWER shortly after the start.

**LARPOWER** (T Comignaghi) - Made contact with YAMUNA shortly after the start.

**FIREGLOW** (K Asano) - Began very awkwardly shifting outwards having to be corrected by its rider losing ground. Over raced in the middle stages.

**NAMIBIA MISS** (R Mudhoo) - From its wide barrier draw was restrained behind runners to obtain cover shortly after the start.

**FETTERCAIRN** (S Wynne) - Over raced through the early and middle stages.

**RUBY'S LAD** (C Grylls) - Hung outwards rounding the final bend and ran off, not being persevered with throughout the final straight. The connections were advised the gelding will now be required to trial to the satisfaction of Stipendiary Stewards prior to racing next. A post-race veterinary examination did not reveal any obvious abnormality.

**DA VINCI GIRL** (D Montes de Oca) - Made contact with AERIAL BLUE for a distance when attempting to shift to the outside of LIGHT UP near the 700 metres then having to be steadied to avoid the heels of LIGHT UP.

**AERIAL BLUE** (M Taylor) - Contacted for a distance near the 700 metres.

**SACRED GIANT** (M McNab) - Held up passing the 400 metres until passing the 250 metres.

**LIGHT UP** (C Johnson) - When questioned regarding the improved performance, trainer P Robson advised that the gelding had been suited by today's wide draw and being able to dictate terms in front after being annoyed in the lead after jumping from an inside barrier at its most recent start.

**D Montes de Oca** (DA VINCI GIRL) - Issued with a warning after attempting to shift outwards near the 700 metres when there was insufficient room to do so, making contact with AERIAL BLUE.

**WANNABE 'N' PARIS** (K Chowdhury) - Slow to begin.

**HIT THE ROAD JACK** (R Elliot) - Slow to begin.

**BROOKBOURNE** (R Beemud) - Began awkwardly making contact with ALJAY. Raced three wide without cover throughout.

**ALJAY** (T Comignaghi) - Contacted at the start. Made contact with INMYSHADOW when both runners shifted ground approaching the 100 metres.

**EKSTREMEMISS** (G Jogoo) - Crowded shortly after the start losing ground.

**HEIDI HI** (K Williams) - Over raced when being restrained near the 2600 metres and shifted outwards making contact with LEITRIM LAD.

**LEITRIM LAD** (T Moseley) - Contacted near the 2600 metres. When questioned regarding performance, rider advised that the gelding had been making abnormal breathing noises. A post-race veterinary examination revealed a slow rate of recovery.

**QUOTA** (S Spratt) - On a moderate tempo improved forward to lead near the 1300 metres.

**DAYTONA RED** (D Bradley) - Raced wide without cover from the 1100 metres.

**MAUNA LOA** (S Wynne) - Held up when improving onto the heels of the tiring BROOKBOURNE then having to shift outwards approaching the 400 metres.

**INMYSHADOW** (M Hudson) - Made contact with ALJAY when both runners shifted ground approaching the 100 metres.

**D Bradley** (DAYTONA RED) - Admitted a charge in that he struck his mount DAYTONA RED 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$300.

Race 9	<b>SPEIGHT'S SUMMIT ULTRA PREMIER 1400m</b>

**IMAGE OF YOU** (C Zackey) - Underwent a veterinary examination at the barriers and was declared a late scratching at 5.38pm after showing signs of lameness in the left front leg. Connections were advised that a veterinary clearance is required prior to the mare trialling or racing next.

**IN VEGAS** (K Mudhoo) - Slow to begin then crowded shortly after the start.

**SANTISSIMA** (L Allpress) - Began awkwardly shifting outwards crowding SHARPIE.

**SHARPIE** (K Chowdhury) - Began awkwardly then crowded losing ground shortly after the start.

**VAN DIESEL** (T Moseley) - Slow to begin and was then restrained behind runners to obtain cover shortly after the start.

**ROYCE ROCA** (S Wynne) - Raced three wide without cover.

**THE BOLD LOOK** (J Laking) - Held up rounding the final turn and for the majority of the straight.

**CAITLYN JAY** (K Asano) - Held up rounding the final turn and did not obtain clear running until near the 200 metres.

**JUNE BUG** (L Sutherland) - Unbalanced when coming together with SHOW BAZZ near the 350 metres.

**SHOW BAZZ** (C Grylls) - Made contact with JUNE BUG near the 350 metres then also making contact with CEDDY SMITH.

**CEDDY SMITH** (D Montes de Oca) - Contacted passing the 350 metres.

**DUSHKU** (C Campbell) - Held up until near the 300 metres.

**S Wynne** (ROYCE ROCA) - Issued with a warning after striking her mount ROYCE ROCA in two consecutive strides over the concluding stages, with her clear record under this section of the rule being taken into account.
