Race 4 - RACECOURSE HOTEL & MOTOR LODGE KORAL STPL CHASE 4250m

SUPER SPIRIT (P Matthews) -Trainer M Oulaghan advised Stewards that the gelding has recovered well and will be continuing his preparation, racing next at a North Island jumps meeting.

RACE COMMENTS

Race 1 | **SPEIGHT'S SUMMIT ULTRA ON TAP 0-1 WIN HURDLES 3100m**

OCEANS AWAY (N Downs) - Crowded at the start losing ground.

KHAFAEF (D Parker) - Over raced badly in the early to middle stages.

WAIAGARA (J Power) - Was inclined to run its fences down during the running. Put in a poor jump at the second to last fence.

AFTERALLTHISTIME (S Fannin) - Misjudged the fence near the 800 metres landing awkwardly losing ground. The rider's whip broke during the running, with the flap becoming detached over the concluding stages.

Race 2 | **ZILCO HANDICAP 1400m**

Trainer **A Carston** (SEVEN TWENTY) - Fined \$50 under the Minor Infringement Schedule for late declaration of rider.

CLASSIC DIVA (K Mudhoo) - Slow to begin. Over raced in the early stages.

SEVEN TWENTY (L Allpress) - Began awkwardly losing ground. Over raced in the early stages. Had to be checked to avoid the heels of **EMANON** near the 1100 metres. Rider reported that the mare had not felt comfortable in today's track conditions.

EMANON (D Montes de Oca) - Over raced in the early stages on a slow tempo.

LOUIE LOUIE (J Doyle) - Raced three wide without cover throughout. Lay out under pressure in the straight.

K Hercock (CHOKITO) - Reminded of her obligation to ride her mounts out fully to the finish after narrowly holding 5th placing.

MAKE TIME (L Sutherland) - Returned to the enclosure with blood present in the right nostril. Following a veterinary inspection which included an endoscopy, **MAKE TIME** was confirmed to have bled. **MAKE TIME** shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

D Montes de Oca (**EMANON**) - Admitted a charge of careless riding in that he permitted his mount **EMANON** to shift inwards when insufficiently clear of **SEVEN TWENTY** which was checked near the 1100 metres. After considering submissions the Adjudicative Committee imposed a suspension of D Montes de Oca's licence to ride at races from the conclusion of racing on Saturday 12 August until the conclusion of racing on Friday 25 August, 7 national riding days, and in addition D Montes de Oca was directed to meet with a NZTR Rider Skills Review Panel under the provisions of Rule 343 given his poor recent riding record.

Race 3	VERNON & VAZEY TRUCK PARTS 1200m
<p>BLUE VEIN (M Hudson) - Bounded at the start.</p> <p>BENAUD (D Montes de Oca) - Slow away.</p> <p>BELLA ROSE (J Doyle) - Crowded leaving the barriers losing ground.</p> <p>MIDNIGHT JANE (T Moseley) - Had some difficulty obtaining clear running early in the run home. Inconvenienced near the 150 metres when BLUE VEIN (M Hudson) lay inwards under pressure. M Hudson was advised to exercise greater care.</p> <p>TENGIZ (K Hercock) - Raced keenly in the early stages. When asked to comment on performance, the rider advised that the mare was not entirely comfortable in today's track conditions.</p> <p>MAKABAR (T Comignaghi) - Lost the right front plate during the running.</p> <p>The siren was sounded following the running of the race whilst the trainer of the 5th placed horse MIDNIGHT JANE, Mr P Harris, viewed Stewards' films with regard to interference by the 3rd placed horse BLUE VEIN near the 150 metres, before electing not to proceed with a protest.</p>	
Race 4	HOSPITALITY NZ CBRY 133RD GRAND NATIONAL HURDLE 4200m
<p>ROAD DIVA (S Karnicnik) – Jumped indifferently throughout. Put in a poor jump at the fence near the 1100 metres.</p> <p>SULIMAN (J Power) - Put in a poor jump at the fence at the 700 metres on the first occasion, flattening a panel of the jump. Under pressure passing the 1000 metres then being retired from the race prior to jumping the second last fence. A post-race veterinary inspection found SULIMAN to have bled during the running. SULIMAN shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.</p> <p>P Matthews (BERRY THE CASH) - Issued with a warning for her whip use on a horse that was clearly winning.</p> <p>N Downs (ODYSSEUS) - Admitted a charge in that he struck his mount ODYSSEUS 14 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of N Downs' licence to ride in races from the conclusion of racing on Tuesday 22 August until the conclusion of racing on Sunday 3 September, 2 national jumping days, and in addition imposed a fine of \$125.</p> <p>P Matthews (BERRY THE CASH) - Admitted a charge in that she made a celebratory gesture prior to the winning post and was fined \$300 under the Minor Infringement Schedule.</p>	
Race 5	SCENIC HOTEL GROUP 1600m
<p>MAGDALA (C Barnes) - Slow to begin.</p> <p>REDFORD (L Callaway) - Crowded at the start losing ground.</p> <p>POWERFUL MOSS (D Montes de Oca) - Began awkwardly shifting outwards crowding outside runners.</p> <p>FAME SHINES (Y Atchamah) - Began awkwardly. Held up near the 400 metres then being further hampered when HEIDI HI was taken out by ZACAT.</p> <p>BUDAI (J Doyle) - Crowded at the start losing ground.</p>	

ZADANE (L Allpress) - Raced keenly in the early stages.

HEIDI HI (K Hercock) - Crowded passing the 400 metres.

K Williams (ZACAT) - Issued with a warning after permitting her mount ZACAT to shift outwards crowding HEIDI HI onto FAME SHINES passing the 400 metres.

Race 6 | **RACECOURSE HOTEL 148TH GRAND NATIONAL STEEPLE 5600m**

WEST COAST (S Fannin) - Misjudged the fence near the 1800 metres on the final occasion and blundered badly on landing.

IZYMYDAAD (S Karnicnik) - Knuckled on landing after jumping the second of the Kennels Double dislodging its rider then fell. S Karnicnik was immediately attended to by ambulance personnel and found to be uninjured other than some general soreness. IZYMYDAAD lay on the track for some time with the Veterinarian present, before regaining its feet appearing to have been winded. The horse ambulance was deployed, transporting IZYMYDAAD back to the saddling area. A subsequent veterinary inspection revealed a small amount of blood in the right nostril consistent with IZYMYDAAD having hit its head on falling. Other than that no other obvious abnormalities were detected apart from the gelding being fatigued. Stewards will follow up with the stable in coming days and a veterinary clearance is required prior to IZYMYDAAD racing again.

BLACK EYED SUE (E Farr) - Misjudged the fence near the 1100 metres on the first occasion.

Race 7 | **STEPHANIE MURRAY MORTGAGES 1400m**

Trainer **K Shearing** (IN DISGUISE) - Fined \$50 under the Minor Infringement Schedule for late declaration of rider.

Trainer **S March** (FAH SAI) - Fined \$200 for late declaration of rider.

VICTOR ROUGE (K Williams) - Began awkwardly losing ground. Over raced in the early stages getting its head up on a number of occasions. When questioned regarding performance, the rider was of the opinion the gelding had not been suited by the holding nature of today's track.

GLOBAL BEAUTY (Y Atchamah) - Began awkwardly losing ground.

KAPALKA (K Hercock) - Taken back from its wide draw to obtain cover shortly after the start.

ARDOUR (T Comignaghi) - Raced wide without cover throughout.

VINDERSTERN (R Mudhoo) - Under pressure turning for home finishing a distant last. When questioned regarding performance, the rider advised that the mare had become wound up prior to the race and may have been feeling the effects of recent racing. A post-race veterinary inspection did not reveal any obvious abnormality.

Race 8 | **HEATSTORE OPEN HANDICAP 1800m**

PRINCE ALBY (K Mudhoo) - Slow to begin.

HIT THE ROAD JACK (H McNeill) - Got its head up when being steadied to obtain cover in the early stages. Raced in restricted room approaching the 100 metres when BELARDO BOY lay outwards under pressure.

ALJAY (T Comignaghi) - Over raced on a slow tempo through the early stages, with the rider advising that this had been detrimental to the gelding's chances.

PROSERVE (K Williams) - Lay out throughout the run home hampering BURNVUE passing the 150 metres. K Williams was advised to exercise greater care.

BURNVUE (L Callaway) - Hampered passing the 150 metres.

Race 9 AIRPARK CANTERBURY 1800m

WEE TADHG (A Balloo) - Slow to begin. Lost the right front plate during the running.

BAILADOR (R Jaun) - Slow to begin.

BLOOD DIAMOND (T Moseley) - Slow to begin.

HARMONIOUS (L Sutherland) - Raced ungenerously when being steadied approaching the 1000 metres.

WAY ABOVE (M Hudson) - Held up entering the final straight and did not obtain clear running until near the 200 metres.

HALLELUJAH BROTHER (K Kwo) - Lay out throughout the run home and was unable to be fully ridden out as a result.

CARIGNAN (T Comignaghi) - Was inclined to lay out in the run home.

Race 10 GROUP 1 RACEDAY PARTY – 16 SEPTEMBER 2000m

SPINDLESHANKS (L Callaway) - Slow to begin.

FIVE PRINCES (T Moseley) - Slow to begin.

TAKE THE DEEL (G Jogoo) - Crowded shortly after the start losing ground when inside runners shifted out.

JAY BEE GEE (M Hudson) - Over raced in the early to middle stages.

BILLY BOY (L Allpress) - Over raced in the early to middle stages when wide without cover.

HEY MICKEY (J Doyle) - Held up rounding the final turn before angling outwards across heels to obtain clear running passing the 400 metres.

LOQUITA (K Williams) - Held up rounding the final turn and in the straight, not obtaining clear running until near the 250 metres.

DEELS DONE (L Douglas) - When questioned regarding performance rider advised that in his opinion the gelding had failed to handle the holding nature of today's track.
