RACE COMMENTS

Race 1 GO RACING 20 STAKES PERFORMANCES 2022 (1550 metres)

TRUST IN YOU (J Bayliss) - Slow to begin.

JIMMY DEAN (K Asano) - Slow to begin.

RISING ROAD (T Mitchell) – Raced keenly in the early stages.

Race 2 SHARES AVAILABLE NOW @GORACING.CO.NZ (1550 metres)

BUBBLE TROUBLE (A Goindasamy) - Slow to begin.

ANNIE (V Colgan) - Restrained in the early stages to obtain cover from a wide barrier. Had difficulty obtaining clear running entering the straight.

REGAL BELLE (K Asano) – Restrained in the early stages to obtain cover from a wide barrier.

TRAMONTO (J Bayliss) – Raced wide without cover in the early stages. When questioned regarding performance the rider could offer no excuse.

KING MONDO (L Satherley) - Raced in restricted room for a distance between DANZA which shifted out slightly, and BAMBOO BAR having to be steadied approaching the 350 metres. W Kennedy was advised to exercise greater care in similar circumstances.

COME TOGETHER (R Elliot) - When questioned regarding performance rider reported that the filly was disappointing and could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 3 GO RACING 20 YEARS INTERNATIONAL SUCCESS (1300 metres)

RUBY'S LANDED (J Kamaruddin) – Crowded shortly after the start having to be steadied.

COVERMEINSUNSHINE (J Bayliss) – Slow to begin.

SIDE BY SIDE (N Parmar) - Commenced to buck shortly after the start losing ground. Raced three wide without cover for majority of the race. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

ELUSIVE EMPIRE (A Goindasamy) - Improved onto heels having to be steadied approaching the 800 metres.

ALFRISTON (J Fawcett) - Raced keenly in the middle stages. Lay out under pressure near the 50 metres making contact with the hindquarters of MONZA which then lay in, placing ALFRISTON in restricted room. J Fawcett was advised to exercise greater care in similar circumstances.

THATCHER (K Asano) – Underwent a post-race veterinary examination including an endoscopic examination which revealed the mare to be suffering from a respiratory issue. Connections were advised that a veterinary clearance would be required prior to THATCHER racing or trialling next. Connections indicated that they would not be persevering with the mare as a racing proposition.

Following this race connections of the 4th placed horse ALFRISTON viewed Stewards footage before electing not to proceed with a protest.

Race 4 RACE IN SYDNEY WITH GO RACING & JOHN O'SHEA (1300 metres)

JODAN (L Satherley) – Declared a late scratching at 2.40 pm after refusing to enter its barrier stall. Connections were advised that JODAN would be required to barrier trial on more than one occasion to the satisfaction of Stewards prior to racing next.

VENT VERT (N Parmar) – Began awkwardly losing ground. Raced wide without cover for the majority of the race.

HERE'S JOHNNY (V Colgan) – Slow to begin losing ground. Improved onto heels near the 900 metres having to be steadied.

STUNNING MAIRE (J Bayliss) - Raced wide without cover until improving to sit outside the leader approaching the 800 metres.

GOOD TIME GARRY (W Pinn) - When questioned regarding performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 5 RACE A SAVABEEL COLT IN MELBOURNE @GORACING.CO.NZ (970 metres)

The start of this race was delayed by approximately 8 minutes after a strapper was injured in the birdcage following the running of Race 4 requiring medical attention.

ROCA FUNDEEDA (M McNab) - Raced three wide without cover throughout.

INQUISITIVE (H Kamaruddin) - Held up for clear running until near the 100 metres.

Race 6 GO RACING \$4M IN PRIZEMONEY 2022 (970 metres)

BURN TO SHINE (K Asano) – Raced three wide without cover throughout. Lay in when placed under pressure in the final straight.

APRILIA (M McNab) - Had some difficulty obtaining clear running rounding the turn and early in the final straight.

MEGATRENDZ (W Pinn) – Lay in under pressure in the straight.

Race 7 RACE A PROISIR FILLY @GORACING.CO.NZ (970 metres)

MIDNIGHT BELLE (C Barnes) - Slow to begin. Lay out rounding the final turn.

SACRED ROSE (K Asano) - Slow to begin.

DIAMONDS FOR JEN (T Thornton) – Checked losing ground near the 700 metres. Held up entering the final straight.

STAR TRAIL (A Goindasamy) - Hampered near the 700 metres when being dictated inwards by SWEET TALKING.

VILLON (B Rogerson) - Steadied when placed in restricted room passing the 250 metres by POUR SUM MOUR which lay out when weakening.

POUR SUM MOUR (S Spratt) - Trainer reported that the mare had been galloped on.

SWEET TALKING (O Bosson) - Lay in under pressure over the concluding stages making it difficult for its rider to fully ride out the finish.

O Bosson (SWEET TALKING) - Admitted a charge of careless riding in that he allowed his mount to shift in when not sufficiently clear of STAR TRAIL which was dictated inwards checking DIAMONDS FOR JEN near the 700 metres. After considering submissions the Adjudicator imposed a suspension of O Bosson's licence to ride in races from the conclusion of racing on Saturday 11 February up to and including racing on Thursday 23 February, 6 national riding days.

Race 8 RACE A FASTNET ROCK COLT IN SYDNEY @GORACING.CO.NZ (2000 metres)

SADLER'S CHICK (S Spratt) - Raced keenly in the early stages when being restrained.

TEXAS (J Bayliss) - Raced keenly in the early and middle stages.

YELLOW JERSEY (R Elliot) - Raced keenly in the early stages when being restrained. When questioned regarding performance the rider could offer no explanation.

Race 9 RACE A SAVABEEL FILLY IN NZ @GORACING.CO.NZ (2000 metres)

GO BRO (B Rogerson) - Stewards permitted B Rogerson to replace J Fawcett as there was no other suitable senior riders available. Lost contact with the body of the field near the 1000 metres. Trainer was advised that the gelding would have a warning placed on its record for poor performance. When questioned regarding performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

FIRESTOCK (T Mitchell) - Contacted at the start. Raced three wide without cover throughout.

BRONTES GOLD (J Bayliss) - Began awkwardly making contact with FIRESTOCK.

MATRIARCH (M McNab) - When questioned regarding performance the rider could offer no explanation. Trainer C Isdale advised that the mare had pulled up with an abrasion on its off-hind leg and the mare would now be retired from racing.

J Fawcett (GO BRO) - Admitted a charge in that without reasonable cause, she broke a riding engagement on GO BRO with the Adjudicator imposing a fine of \$400.
