Following the running of Race 3, N Parmar advised Stewards he was unwell and would not be able to fulfil his engagements with replacements above. N Parmar was advised a medical clearance would be required prior to riding next.

RACE COMMENTS

Race 1 RUAKAKA – NZ'S BEST BET IN WINTER MAIDEN 1600

STOKES (R Elliot) – Began awkwardly losing ground. Over-raced through the early and middle stages. Inconvenienced near the 1000 metres when MATAI BAY checked off the heels of EMPIRE STATE.

MATETSI (M McNab) – Restrained to obtain cover in the early stages after jumping from the outside barrier. Forced wider near the 1000 metres. Hung outwards rounding the final bend.

DANZINO (O Bosson) – Slow to begin. When questioned regarding the performance rider advised that the gelding was unsuited by the improved track conditions. Underwent a post-race veterinary examination which revealed no abnormalities.

MS MCRAE (V Colgan) - Slow to begin.

CANULOVEMEAGAIN (L Satherley) – Over-raced through the early stages.

FOODIE BROTHERS (D Cooper) – Raced three wide without cover throughout.

KEREOPA (T Newman) - Over-raced through the early and middle stages when racing outside the leader.

MATAI BAY (T Thornton) - Checked off the heels of EMPIRE STATE approaching the 1000 metres.

GOOD TIME GARRY (S Weatherley) – Briefly lay out over the concluding stages having to be corrected by its rider.

RUSTIC (W Kennedy) - Briefly came together with KEREOPA near the 100 metres.

T Moodley (FOODIE BROTHERS) – Assisted by Trainer D Walker, admitted a charge in that he was unable to make the weight on FOODIE BROTHERS with the Adjudicator imposing a fine of \$200 under the Minor Infringement Schedule.

A Lawson-Carroll (EMPIRE STATE) - Assisted by Co-Trainer E Clotworthy, admitted a charge of careless riding in that he permitted his mount to shift in when not sufficiently clear of MATAI BAY which had to be checked to avoid that runner's heels approaching the 1000 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 5 August up to and including racing on Friday 18 August, 6 national riding days.

Race 2 | **LION MAIDEN 1200**

ON THE WALL (O Bosson) - Removed from the barriers to undergo a pre-race veterinary examination being cleared fit to race.

ATLANTIC CHARM (S Weatherley) - Removed from the barriers to undergo a pre-race veterinary examination being cleared fit to race.

RICHIE'S DREAM (T Thornton) – Began awkwardly contacting SUPER WRAITH shortly after the start.

TIDE AND TIME (T Abel) – Began awkwardly hampering DAY IN LIEU.

DAY IN LIEU (A Goindasamy) - Hampered leaving the barriers losing ground before settling at the rear of the field.

PURE DELIGHT (J Allen) – Began awkwardly losing ground.

SUPER WRAITH (V Colgan) – Contacted leaving the barriers. Raced wide without cover throughout.

LA PARISIENNE (A Lawson-Carroll) – Improved onto heels entering the home straight having to be steadied, then shifted across heels to obtain clear running near the 300 metres.

WINDSOR CASTLE (T Newman) – Lay out rounding the final bend.

Race 3 | **FIRECO 1100**

INFRINGEMENT (S Weatherley) – Began awkwardly losing ground. Commenced to buck near the 900 metres losing considerable ground and was retired from the race. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

VITA AMOROSA (L Satherley) - Began awkwardly contacting the barriers. Over-raced through the early and middle stages. Had to be steadied near the 350 metres when BEZIQUE shifted outwards when not fully clear, then lay in when placed under pressure.

CHARM ZAFARM (N Parmar) - Slow to begin. Steadied off heels near the 600 metres when there was an easing of tempo. When questioned regarding the performance rider advised that the filly raced greenly during the running.

DANCING DREAM (T Newman) - Raced ungenerously for a distance from near the 700 metres.

CROCETTI (W Kennedy) - Raced wide in the early stages before improving forward to lead near the 700 metres.

BEZIQUE (A Goindasamy) - Improved onto heels having to be steadied approaching the 600 metres.

RUSH OF WIND (A Lawson-Carroll) - Had to be steadied off heels approaching the 600 metres when there was an easing of the tempo.

A Goindasamy (BEZIQUE) - Issued with a warning for permitting his mount to shift outwards when not fully clear of VITA AMOROSA which had to be steadied near the 350 metres.

R Elliot (JUST AS SHARP & NEW ARRANGEMENT) - Admitted a charge in that he was unable to make the weight on JUST AS SHARP & NEW ARRANGEMENT. After considering submissions the Adjudicator imposed a suspension of R Elliot's licence to ride in races from the conclusion of racing on Saturday 5 August up to and including racing on Wednesday 16 August, 5 national riding days.

Race 4 | **9 SEP ALIBABA'S FLYNG CARPETS KERIKERI 1100**

DRAGON LEAP (O Bosson) – Began awkwardly losing ground.

EVER SO EASY (J Allen) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

DEPLOY (A Lawson-Carroll) – Reared as the start was effected losing ground. Over-raced through the early to middle stages. Connections were advised that the mare would be required to barrier trial again to the satisfaction of Stewards prior to racing next.

DIAMOND GIRL (T Newman) – Restrained to the rear of the field in the early stages. Held up for clear running early in the final straight.

TOP BRASS (W Kennedy) – Over-raced through the early and middle stages. Rider reported that the gelding lay inwards during the running.

JOEY'S GIFT (S Spratt) – Raced three wide without cover throughout.

Race 5 | **MOUNTFIELD QUARRY 2100**

ONEZEDBEE (L Satherley) - Slow to begin.

NEW ARRANGEMENT (S Weatherley) - Began awkwardly losing ground.

LEITRIM LAD (T Abel) – Raced wide in the early stages before improving forward to settle outside the leader near the 1700 metres.

CHEVRON (M McNab) – Lay in when placed under pressure over the concluding stages proving difficult for its rider.

TIMBERLAKE (W Kennedy) – Raced three wide without cover from the 1200 metres to the 1000 metres when improving forward to lead.

Race 6 | **NORTHLAND BUSINESS SYSTEMS 1600**

LA DOLCE VITA (M McNab) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

VEGAS STRIP (T Newman) – Raced wide through the early and middle stages.

FOLLOW YOUR DREAMS (J Allen) – Raced three wide without cover from the 800 metres. Lay in when placed under pressure early in the final straight placing SULABELLA in restricted room. Rider J Allen was shown the replay in the presence of O Bosson and advised that she must stop riding and correct her mounts once they commence to shift ground when not sufficiently clear of other runners.

SULABELLA (W Kennedy) – Raced keenly through the middle stages. Hampered early in the final straight when FOLLOW YOUR DREAMS lay inwards. Had to be steadied off heels near the 200 metres when CAKEBYTHEOCEAN briefly shifted out simultaneously to FOLLOW YOUR DREAMS shifting inwards. Riders J Allen and O Bosson were advised to exercise greater care in similar circumstances.

CAKEBYTHEOCEAN (O Bosson) - Held up for clear running until approaching the 200 metres.

RUBYSHOWOFF (A Lawson-Carroll) - When questioned regarding the improved performance Trainer S Cole advised that the mare had been caught wide at its previous start and appreciated a drop back in class today.

Race 7 | **19 AUG HARCOURTS FOR HOSPICE BOOKINGS 1300**

WARSAW (O Bosson) - Began awkwardly.

SUPER TIME (S Spratt) – Knuckled at the start. Raced three wide without cover throughout.

CON ARTIST (T Abel) - Began awkwardly then crowded shortly after.

QUARTZ QUEEN (T Thornton) – Began awkwardly crowding CON ARTIST.

PILLAR OF SOCIETY (L Satherley) – Over-raced through the early and middle stages. Raced in restricted room near the 900 metres having to be steadied.

STAGE THREE (S Weatherley) – Made the bend near the 900 metres awkwardly shifting outwards placing PILLAR OF SOCIETY in restricted room having to be steadied off heels. Briefly brushed with MISSYWOOD approaching the 100 metres. When questioned regarding the performance rider advised that the mare would derive benefit from today's fresh up race.

MISSYWOOD (W Kennedy) - Raced keenly through the middle stages. Had to be steadied off heels rounding the final bend. Briefly brushed with STAGE THREE approaching the 100 metres. When questioned regarding the performance rider advised that the mare raced keenly with the addition of blinkers, however he was disappointed with the effort.

MALFY ROSA (J Allen) - Had to be steadied off heels near the 600 metres. Had difficulty obtaining clear running until approaching the 100 metres.

LOVE AFFIRMATIONS (M McNab) – Lay out when placed under pressure near the 200 metres having to be corrected by its rider.

Race 8 | **19 AUG CAMBRIDGE STUD NORTHLAND BREEDER'S STAKES 2100**

This race ran approximately 4 minutes late due to a mechanical issue with the tractor that removes the barriers at the start.

Stewards spoke advisedly to staff in relation to the camera operator being positioned too close to the inside running rail near the 250 metres.

HEART OF ALLADIN (S Weatherley) – Restrained to obtain cover in the early stages after jumping from an outside barrier. Held up rounding the final bend. Checked off the heels of NAGA EYE unbalancing its rider and losing ground near the 250 metres.

EVE'S SONG (B Rogerson) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

FLY MY WEY (M Sanson) - Raced wide without cover throughout.

MISCHIEF MANAGED (M McNab) - When questioned regarding the performance rider advised that in his opinion the mare was feeling the effects of recent racing. Underwent a post-race veterinary examination which revealed no

abnormalities. Stewards will follow up on the post-race condition of the mare with Co-Trainer K Rae in the coming days.

A Lawson-Carroll (NAGA EYE) - Assisted by Trainer C Gibbs, admitted a charge of careless riding in that he permitted his mount to shift inwards when insufficiently clear of HEART OF ALLADIN which had to be checked to avoid that runner's heels near the 250 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Friday 18 August up to and including racing on Thursday 31 August, 9 national riding days.
