### Avondale Trials

#### Tuesday, 15 August 2023 - Trial 25

**V Jalalkuncha** (JANKA) - Admitted a charge in that he struck his mount 10 times prior to the 100 metres with the Adjudicator imposing a suspension of V Jalalkuncha's licence to ride in races from the conclusion of racing on Wednesday 16 August up to and including racing on Thursday 24 August, 5 national riding days.

## RACE COMMENTS

Race 1 **WAIPA EARTHWORKS MAIDEN 1550**

**YESTERDAY'S GONE** (K Hannan) - Slow to begin.

**MONTEZUMA** (B Rogerson) – Crowded shortly after the start. Held up entering the final straight until approaching the 200 metres.

**MS CANDEE LANE** (J Doyle) – Improved into restricted room to the inside of THE ARCHITECT approaching the 1100 metres. Raced wide without cover for majority of the race.

**THE ARCHITECT** (T Newman) – Raced wide without cover throughout.

**COMPOSURE** (T Thornton) - Raced in restricted room approaching the 1100 metres.

**DONUT** (N Parmar) - Held up for clear racing room entering the final straight.

**OUR MILLY BEE** (W Kennedy) - Briefly steadied when improving onto the heels of THE ARCHITECT which was weakening near the 250 metres.

**T Newman** (THE ARCHITECT) - Issued with a warning after permitting her mount to shift inwards placing MS CANDEE LANE and COMPOSURE in restricted room near the 1100 metres. Stewards took into account the racing manners of MS CANDEE LANE when assessing the incident.

**Race 2** | **CAMBRIDGE EQUINE HOSPITAL 1550**

**FLAT TRACK BULLY** (W Kennedy) - Underwent a pre-race veterinary examination at the barriers after being kicked by another runner being declared a late scratching at 1.06 pm.

**CHAMPAGNES ON ME** (T Newman) - Began awkwardly losing ground.

**BRECKON POWER** (S Weatherley) – Lay out entering the final straight.

**Race 3** | **PRYDE'S EASIFEED MAIDEN 1400**

**ENTERPRISE GEM** (B Rogerson) - Crowded shortly after the start losing ground.

**HANALEI STAR** (S Spratt) - Crowded shortly after the start losing ground.

**OUT OF SIGHT** (T Newman) – Began awkwardly losing ground.

**SATIN DOLL** (D Cooper) - Slow to begin.

**ROZEL** (J Doyle) - Raced three wide without cover throughout.

**SUPER GOLD** (K Hannan) - Lay out when placed under pressure in the final straight.

**Race 4** | **GROUP ONE TURF BAR 1300**

**APERITIF** (B Rogerson) – Crowded shortly after the start having to be steadied. Steadied to avoid heels approaching the 800 metres when LUXURIANT shifted in. O Bosson was advised to exercise greater care in similar circumstances.

**LUXURIANT** (O Bosson) - Restrained in the early stages to obtain cover from a wide barrier. Raced keenly in the early and middle stages.

**PAPENHUYZEN** (T Harris) - When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 5** | **RICHARD BRIGHT MEMORIAL CUP 1550**

**HEART OF GOLD** (K Hannan) - Slow to begin (4L).

**MEDINA** (W Kennedy) - Raced wide without cover throughout. When questioned regarding the performance the rider reported that the mare felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

**JIMMY DEAN** (K Asano) - Had some difficulty obtaining clear running until approaching the 100 metres.

**SIDE EYE** (J Allen) - Became awkwardly placed near the heels of POW WOW over the concluding stages when STONYBRECK lay in under pressure.

**C Wood** (SIDE EYE) - Issued with a warning after presenting SIDE EYE to race in incorrect gear.

**Race 6** | **BETAVET MAIDEN 970**

**FLOWER MOON** (J Doyle) - Began awkwardly then crowded shortly after, losing ground. Over-raced in the early stages. Briefly steadied over the concluding stages when awkwardly placed near the heels of LILI MARLENE.

**GIGI** (T Thornton) - Slow to begin.

**SHOW A MILLION** (K Asano) – Raced wide without cover throughout.

**Race 7** | **SADDLERY WAREHOUSE 2000**

**RED 'N' SURF** (C Barnes) - Slow to begin (8L). Connections were advised that a warning would be placed on the gelding's record.

**GOODO JO** (S Spratt) - Began awkwardly losing ground. When questioned regarding performance, rider reported that the gelding felt indifferent in its action entering the final straight. Underwent a post-race veterinary examination which did not reveal any abnormality.

**ELUSIVE CAPITAL** (V Colgan) - Slow to begin then crowded shortly after, losing ground.

**MISS INTERPRET** (K Hannan) – Began awkwardly.

**RISING ROAD** (W Kennedy) - Raced in restricted room over the concluding stages to the inside of ELUSIVE CAPITAL which was laying in.

**Race 8** | **THE OAKS STUD MAIDEN 2000**

**JIVETALKIN** (T Newman) - Began awkwardly then hampered shortly after, losing ground. Raced keenly for a distance when being steadied passing the 1650 metres. Hampered approaching the 600 metres when MYTURN shifted out.

**SHIMMERING** (N Parmar) - When questioned regarding the performance the rider could offer no explanation.

**KRIMINAL** (W Kennedy) - When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.
