RACE COMMENTS	
Race 1	MAKITA MAAT 1800m
THE DUTCH DAME (C Grylls) - Slow away.	

MR ROC (J Doyle) - Raced three-wide without cover. Finished some distance last. When questioned J Doyle was of the opinion the gelding may be feeling the effects of recent racing and didn't back up from its most recent run.

MAGGIESCLAN (L Allpress) - Lay outwards rounding the final bend and when being corrected shifted in marginally briefly placing **SWINGIT OUR WAY**, which was attempting to improve to its inside, in restricted room. L Allpress was advised to exercise more care.

CRAFTY COLIN (T Taiaroa) - Raced keenly in the early stages.

JERRICOOP (J Chung) - Raced keenly in the early and middle stages.

SWINGIT OUR WAY (A Bohorun) - Denied a marginal run near the 250 metres and had to switch ground outwards to improve.

Race 2 | **WINSTONE WALLBOARDS 1800m**

SHERWOOD FOREST (L Allpress) - Began awkwardly and was slow away.

EL NYMPH (L Douglas) - Inclined to get its head in the air when being restrained to take a trail in the early stages.

K Hercock (LIQUID LES) - Admitted a charge in that she struck her mount LIQUID LES once more than permitted prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 26 August until the conclusion of racing on Thursday, 31 August, 3 national riding days, and in addition imposed a fine of \$500.

Race 3 | **PSP 2000m**

TAKEITEASY (C Butler) - Jumped away awkwardly.

KING KHAN (M Hudson) - Lay outwards after jumping away, crowding **CHARMINGAFFAIR** on to **THE FIRST LINK**, which struck a heel and blundered.

CHARMINGAFFAIR (B Rogerson) - Crowded shortly after jumping away.

THE FIRST LINK (B Grylls) - Struck a heel and blundered when crowded shortly after the start.

ZEEFA ZED (K Hercock) - Slow away then being steadied shortly after the start.

RUN JAKKO RUN (L Sutherland) - Over-raced in the back straight.

Race 4 | **UNITED STEEL 1200m**

STOLEN SPIRIT (L Sutherland) - Lay outwards in the early stages making contact with **SPENCER**.

SPENCER (J Chung) - Contacted shortly after the start.

TANNER (L Allpress) - Disappointed for a run near the 250 metres having to steady and shift outwards across heels to obtain clear running.

M Singh (VESMART) - Issued with a warning after using his whip in an action that raised his arm above shoulder height on one occasion near the 400 metres.

Race 5 | **PASLODE 1200m**

LADIES MAN (A Bohorun) - Slow away.

DAWN PARADE (L Allpress) - When questioned regarding performance rider advised that in her opinion the gelding was unsuited to the holding track.

Race 6 | **STEEL & TUBE 1400m**

Trainer P Riley (MIRIELLA) - Fined \$300 under the Minor Infringement Schedule for neglect in saddling, omitting the lead bag.

CANHEROC (J Chung) - Slow away.

MADAME MOET (M Hudson) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

JUST A TIPPLE (L Douglas) - Shifted out under pressure over the concluding stages.

DIOGENES (A Bohorun) - When questioned regarding performance rider advised the gelding had been making abnormal breathing noises. A post-race veterinary examination did not reveal any obvious abnormality.

C Butler (THE WITCH) - Spoken to regarding her whip use in the home straight.

Race 7 | **ITM NEW PLYMOUTH INTERPROVINCIAL 1600m**

LILLY THUNDER (L Douglas) - Slow away.

MANOLO (T Taiaroa) - Slow away.

SONOFABUTCHER (M Sanson) - Jumped away awkwardly.

PUKE PARK (L Allpress) - When questioned regarding performance rider was unable to offer any excuse other than possibly not being suited to the step up in distance.

Race 8 | **NELSON PINE 1600m**

ROSIELICIOUS (M Hudson) - Slow away.

WHO'S COMPLAININ (J Riddell) - Made the crossing near the 1500 metres awkwardly and blundered. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

A Bohorun (TEQUILA SPIRIT) - Admitted a charge in that he struck his mount TEQUILA SPIRIT 5 times more than permitted prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 19 August, until the conclusion of racing on Wednesday, 30 August, 6 national riding days.
