GENERAL

H McNeill advised Stewards on race morning that due to transport difficulties he would be unable to attend today's race meeting at Waverley and was replaced as above.

RACE COMMENTS

Race 1 EGMONT WANGANUI HUNT INC MAIDEN HURDLE 3000m

RUN JAKKO RUN (D Parker) - Over-raced in the early stages. Improved on to heels rounding the home turn on the final round and had to be steadied when there was insufficient room to improve. Landed awkwardly after the second-last hurdle and blundered, unbalancing the rider, who lost the use of the near-side iron.

CANBITEABIT (M Cropp) - Slow to begin. M Cropp advised Stewards the gelding travelled well throughout, jumped well, but failed to respond when placed under pressure passing the 800 metres. Underwent a post-race veterinary examination which revealed a slow recovery rate.

HARRY HARRISON (P Matthews) - Jumped indifferently in the early stages.

DRUMSTORM (S Karnicnik) - Retired from the race prior to the second-last fence when tailed off and out of contention.

WHISKEY TANGO (E Farr) - Jumped the second-last fence awkwardly and shifted into the line of CHEEKY AZZ.

MR BEANS THE NAME (B Lammas) - Landed awkwardly at the fence near the 800 metres and lost ground. Retired from the race prior to the last fence when out of contention. B Lammas advised the gelding jumped indifferently throughout.

Race 2 MAKOHAU STABLES PRE-TRAINING NIALL & EMMA QUINN MAIDEN STEEPLECHASE 4000m

KENTUCKY BOY (P Matthews) - Restrained to the rear from its wide barrier. Over-raced in the early stages.

FANTASY FLIGHT (J Power) - Jumped the first fence indifferently.

SUPER SPIRIT (E Farr) - Over-raced in the middle stages due to the slow tempo. Contacted the fence near the 1400 metres. Made contact with MR FAHRENHEIT jumping the final fence.

POITIN (S Karnicnik) - Raced wide without cover from the 1400 metres.

CALL ME JACK (D Parker) - Lay outwards under pressure over the concluding stages. D Parker was advised to exercise greater care when shifting ground.

MR FAHRENHEIT (S Mynott) - Made contact with SUPER SPIRIT jumping the final fence. Had to be steadied approaching the 60 metres when CALL ME JACK lay outwards.

Race 3 PEKO CONTRACTING 2010 LTD MAIDEN 1200m

SHEAF (L Sutherland) - Slow to begin.

FLICKERING NEON (E Nicholas) - Over-raced in the early and middle stages.

HIGH FIVE (J Parkes) - Over-raced through the middle stages. Raced three-wide without cover from the 600 metres.

Race 4 ACTION MOTO MAIDEN 1200m

DANZIG'S CHOICE (M Singh) - Restrained to the rear of the field from its wide draw. Improved on to heels passing the 800 metres, having to be steadied.

HYMDOWN (K Hercock) - Over-raced in the middle stages and raced wide without cover throughout.

FRANK THE TANK (J Parkes) - Crowded shortly after the start.

LADDIE BOY (C Barnes) - Over-raced in the early and middle stages, proving difficult for its rider.

RITA BONITA (C Butler) - Raced wide throughout.

JESTIN CASE (L Allpress) - Raced wide throughout.

TRIGGER HAPPY (L Douglas) - Improved on to heels approaching the 500 metres having to be steadied.

SUPERCELL (J Riddell) - Hung outwards rounding the final bend.

Track upgraded to Heavy 8 following Race 4.

Race 5 TREADWELL GORDON MAIDEN 2200m

IZZIE'S BEAU (S Kumar Paswan) - Removed from its barrier to undergo a pre-race veterinary examination and was cleared to start. Over-raced in the middle stages.

HAMISH (A Scott) - Stood flat–footed at the start.

SUNSET SAM (A Riddell) - Crowded shortly after the start.

THINK AHEAD (N Jenkins) - Raced wide throughout.

KARA ZOR EL (M Northcott) - Over-raced in the early and middle stages.

E Taiaroa (OVERAGAIN) - Admitted a charge under Rule 638(3)(i) in that he used his whip on two occasions with his hand detached from the rein. E Taiaroa was fined \$100.

Race 6 SANDFORDS RURAL CARRIERS HANDICAP 1400m

MADAM MOET (M Hudson) - Began awkwardly then crowded for racing room shortly after. Momentarily held up entering the home straight.

NEVER FEAR (C Carmine) - Began awkwardly losing ground. Over-raced in the early and middle stages.

PACE ATTACK (J Chung) - Over-raced in the early stages when racing wide.

HELLUVAH RETURN (C Butler) - Raced wide throughout.

Race 7 CORSON MAIZE 1650m

WINNIE ROSE (L Allpress) - Slow to begin.

ZA'FARAN (C Butler) - Restrained to the rear from its wide barrier. Raced wide from the 400 metres.

REGAL ROCK (K Hercock) - Raced three-wide without cover from the 600 metres.

Race 8 EVERYONE BACK TO POCKETS AFTER THE LAST RACE MAIDEN 1650m

NAME THE GAME (C Carmine) -Restrained to the rear shortly after the start.

EYE TUNES (C Butler) - Over-raced in the middle stages.

MOMENTS LIKE THESE (L Allpress) - Over-raced in the middle stages. Inclined to lay outwards when placed under pressure over the concluding stages.

SHOCKIFF (E Nicholas) - Raced wide throughout.

VERARDINO (J Riddell) - Over-raced middle stages.

RAVENNA ROSE (L Sutherland) - Inclined to lay outwards entering the home straight, proving difficult for its rider.

ROULADE (K Hercock) - Improved on to heels approaching the 600 metres having to be steadied. Momentarily held up for clear running early in the home straight.
