Race 7 - RACECOURSE HOTEL & MOTOR LODGE HANDICAP 1400m

BLACK CHEETAH (J Fawcett) - Trainer Mr J Blackadder advised Stewards he was satisfied with the post-race condition of the gelding, however, has now been retired from racing.

Race 1 - SPEIGHT'S SUMMIT ULTRA ON TAP 1800m

BAD FLAMINGO (K Asano) - Stable Foreman Mr R Carston reported to Stewards that BAD FLAMINGO underwent a veterinary examination on Monday 4 September which included blood tests, with no abnormalities being detected. R Carston further advised it is the stable's intention to continue on with the gelding's current preparation.

RACE COMMENTS

Race 1 | **SPEIGHT'S MAIDEN 2200m**

NELLIE GREY (G Jogoo) - Crowded at the start losing ground.

WOTARIPPER (B Murray) - Slow to begin. Raced wide without cover through the early stages before being allowed to improve forward to lead near the 1800 metres.

ALL TICKETYBOO (T Jonker) - Raced keenly through the early and middle stages.

OUR PRINCESS BOOT (K Mudhoo) - Hampered then having to steady when placed in restricted room when runners to either side shifted ground passing the 400 metres.

TARZEFFIC (T Moseley) - Steadied off heels near the 400 metres.

Race 2 | **POSITIVE SIGNS + PRINT 1200m**

PISCO SOUR (K Williams) - Began awkwardly losing ground. Raced ungenerously through the early and middle stages.

NOBELLEM (E Nicholas) - Raced three wide without cover for the majority of the race.

PENVOSE LAD (K Chowdhoo) - Raced ungenerously in the early stages and near the 1100 metres had to be steadied away from heels and in doing so hampered the trailing TAP 'N' GO. Lost the near front plate during the running.

TAP 'N' GO (B May) - Hampered 1100 metres.

TADITA (K Hercock) - Over raced into the bend near the 900 metres having to be steadied away from heels and shifting wider on the track.

MORE THAN WORDS (T Comignaghi) - Rider reported the mare had hung throughout the running.

Race 3 | **DRUMMOND & ETHERIDGE OAMARU MAIDEN 1200m**

VOLT EDGE (L Callaway) - Slow to begin. Improved onto heels having to be briefly steadied approaching the 350 metres.

POMALO (K Mudhoo) - Slow to begin. Held up approaching the 400 metres and was unable to obtain clear running until early in the final straight.

QUINTABELLE (C Barnes) - Crowded shortly after the start losing some ground. Placed in restricted room having to steady near the 150 metres, and was then hampered by the fallen runner passing the 100 metres.

CHRISTOPHE VERMEER (T Moseley) - Over raced through the early and middle stages.

ENTRENCH (G Jogoo) - Over raced through the early and middle stages having to be restrained off heels on a number of occasions.

WARM BREEZE (A Balloo) - Raced three wide without cover throughout. Clipped a heel of PERFECT MOMENT passing the 100 metres dislodging its rider. A Balloo was attended to by on-course Paramedics and stood down from his

remaining rides suffering an arm injury. A Balloo was advised that a medical certificate will be required prior to riding next.

EL CHAPEAU (K Chowdhury) - Raced four wide without cover. Raced greenly throughout the final straight.

OUCH (T Comignaghi) - Lay out rounding the final bend.

VAUDEVIRE (S Wynne) - Held up rounding the final bend. Lay in under pressure passing the 150 metres.

PONZI PONY (T Jonker) - Held up rounding the final bend.

GRECIAN CHARM (K Kwo) - Held up early in the final straight having to shift inwards to obtain clear running.

WOTACHATTABOX (B May) - When questioned regarding performance, the rider reported the gelding had raced greenly throughout.

K HercocK (PERFECT MOMENT) - Admitted a charge of careless riding in that she permitted her mount PERFECT MOMENT to shift inwards when insufficiently clear of WARM BREEZE which clipped a heel and dislodged its rider passing the 100 metres. After considering submissions the Adjudicator imposed a suspension of K HercocK's licence to ride in races from the conclusion of racing on Saturday 16 September until the conclusion of racing on Saturday 14 October, 4 weeks.

Race 4	PROPERTY BROKERS DUNEDIN 1600m

TAIMATE DIVA (B May) - Declared a late scratching at 2.30pm after refusing to load. Connections were advised that TAIMATE DIVA must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. As a result of the late scratching the race ran approximately four minutes late.

EAVESDROP (C Campbell) - Slow to begin.

NAMIBIA MISS (K Williams) - Got its head up when being restrained to obtain cover passing the 1000 metres when TANNAHILL was not quite fully clear. D Wilson was advised to exercise greater care.

HONESTY (D Tait) - Raced three wide without cover from the 1000 metres.

LADY TELENA (E Nicholas) - Was inclined to lay out throughout the run home.

Race 5	OAMARU JOCKEY CLUB MAIDEN 1600m

FAKEITTILLUMAKEIT (B Murray) - Slow to begin then raced three wide without cover for the majority of the race.

GANGSTA GRANNY (E Nicholas) - Raced greenly in the early stages losing momentum as the field made the crossing near the 1400 metres, becoming detached from the field in the middle stages despite the efforts of its rider.

MAYBE I'M DREAMING (R Mudhoo) - Shied and shifted in abruptly at the crossing near the 1400 metres hampering SNORKEL which had to take evasive action. Rider reported the mare had hung throughout the running.

SNORKEL (T Moseley) - Hampered near the 1400 metres having to be steadied. Was again steadied away from heels passing the 1200 metres.

MISTER WALT (T Jonker) - Under pressure passing the 600 metres finishing a clear last. When questioned regarding performance the rider could offer no excuse. A post-race veterinary inspection did not reveal any obvious

abnormality. Trainer P Harris advised that MISTER WALT would no longer be persevered with as a training proposition by his stable.

CHEX MY NONO (K Williams) - Rider reported the mare had hung outwards throughout the running proving a difficult ride once placed under pressure. Trainer J Burrows advised the mare will undergo chiropractic treatment upon return to the stable. Stewards will follow up in coming days.

J Laking (MR PHOTOGENIC) - Was reprimanded after making contact with a member of the public prior to weighing in.

Race 6 | **NELLIES RESTAURANT & BAR 1200m**

AUTHORITY (B May) - Began awkwardly losing ground.

VALYRIAN (D Montes de Oca) - Slow to begin.

MUMBO JUMBO (R Mudhoo) - Began awkwardly losing ground.

BLUE SOLITAIRE (K Chowdhoo) - Slow to begin.

EYE SPY (C Campbell) - Over raced through the early and middle stages. Raced three wide without cover throughout. When questioned regarding performance, the rider advised the mare had hung throughout the running. Co-trainer S Anderton advised the mare had returned to the stabling area with a small laceration inside the mouth, adding he would be inspecting the mare's mouth area and teeth in coming days.

LADY'S LEGACY (C Barnes) - When shifting inwards made contact with ALBY PARK near the 1000 metres.

ALBY PARK (Y Atchamah) - Contacted 1000 metres.

OUR CLARRY (J Laking) - When asked to comment on the apparent improved performance, the rider advised that the gelding was aided by a gear change today with the addition of a tongue tie, and a senior rider.

B Murray (ELLE AYE LADY) - Issued with a warning after weighing in 0.6 kg in excess of his weigh-out weight.

Retrospective to this race the track was upgraded to Good 3.

Race 7 | **ENTAIN – NZB INSURANCE PEARL SERIES RACE MAIDEN 1200m**

K Mudhoo - Admitted a charge of being unable to make the contract weight for IDEAL DREAMS, being replaced and issued with a fine of \$100 under the Minor Infringement Schedule.

STEVIE NIX (K Hercock) - Hampered at the start and was then taken back to obtain cover. Crowded and had to steady passing the 75 metres when CHIPPEWA shifted outwards under pressure.

LUV ROSAY (E Nicholas) - Raced keenly through the early and middle stages.

CHIPPEWA (D Montes de Oca) - Raced three wide without cover throughout.

WATER LILIES (K Williams) - The rider's whip became entangled in the reins for the majority of the final straight.

CALLISSIDENT (C Barnes) - When questioned, the rider could offer no excuse for the disappointing performance. A post-race veterinary inspection did not reveal any obvious abnormality.

WEST VIRGINIA (T Moseley) - When questioned regarding performance, the rider advised the filly may not have handled the firmer track conditions.

D Montes de Oca (CHIPPEWA) - Issued with a warning after permitting his mount CHIPPEWA to shift outwards when not sufficiently clear of STEVIE NIX passing the 75 metres.

Race 8	DUNEDIN CITY MOTORS 1600m

OHIWA SUNSET (E Nicholas) - Slow to begin from an outside barrier then improved forward but was obliged to race wide without cover throughout. When questioned regarding performance, the rider advised that although she had been trapped wide throughout, the mare was not comfortable in today's firm track conditions.

KING OF THE DANCE (D Wilson) - Slow to begin.

POMANDER (D Montes de Oca) - Shifted in at the start crowding WATTABREEZE and ZADANE.

WATTABREEZE (T Comignaghi) - Crowded at the start losing some ground.

ZADANE (G Jogoo) - Crowded at the start losing some ground.

HAGGLE (C Campbell) - Over raced in the early stages and had to be heavily restrained away from heels near the 1300 metres.

DIAMOND RIVIERE (R Mudhoo) - Inconvenienced near the 350 metres when runners to its inside shifted out on the point of the turn.

D Montes de Oca (POMANDER) - Was spoken to regarding his whip use above shoulder height.
