<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>COLLIERS COMMERCIAL HAWKE'S BAY PREMIER 2000m</b>
<p><b>RED 'N' SURF</b> (J Chung) - Slow to begin (5L). Improved wide from the 900 metres.</p> <p><b>SO CALL ME</b> (N Parmar)- Lost the right front plate during the running.</p> <p><b>LILLY LAGUNA</b> (W Kennedy) - Had to be steadied when improving on to heels near the 900 metres.</p> <p><b>ALL IN ALL</b> (C Grylls) - Lost the left front plate during the running.</p>	
<b>Race 2</b>	<b>HASTINGS – HEART OF HAWKE'S BAY PREMIER 1600m</b>
<p><b>JUST A TIPPLE</b> (L Douglas) - Very slow to begin, losing considerable ground. Trainer G Opie was advised the gelding is now required to barrier trial satisfactorily prior to racing again. Over-raced in the middle stages.</p> <p><b>FLAMENCO</b> (M McNab) - Jumped away awkwardly before being further hampered when crowded.</p> <p><b>SEFTON</b> (J Riddell) - Slow away.</p> <p><b>BELCAMINA</b> (S Weatherley) - Went back to obtain cover after jumping from the outside barrier.</p> <p><b>TIDAL RUSH</b> (E Nicholas) - Raced three-wide without cover throughout.</p> <p><b>CANHEROC</b> (J Chung) - Lay inwards rounding the final turn and continued to do so in the straight, shifting inwards abruptly after being struck with the whip passing the 200 metres, hampering GRAND PROSPECT, which then shifted away from CANHEROC, having to be checked to avoid the heels of FARRENC.</p> <p><b>GRAND PROSPECT</b> (W Kennedy) - Inclined to lay inwards in the straight before being hampered passing the 200 metres, having to be checked when becoming awkwardly placed near the heels of FARRENC approaching the 150 metres.</p> <p><b>SACRED DREAM</b> (O Bosson) - When questioned regarding performance, rider was unable to offer any excuse, advising that the mare had received every opportunity in the running but had failed to finish the race off and in his opinion may still be showing signs of immaturity.</p> <p><b>BROOKBOURNE</b> (J Parkes) - Inconvenienced near the 50 metres when SEFTON shifted inwards away from INFER, which had been taken in by FLAMENCO.</p>	

**J Chung** (CANHEROC) - Issued with a warning after permitting his mount to shift inwards passing the 200 metres.

**Race 3** | **REMEMBER 'JOOKY' PREMIER 1300m**

**CHASE 'N' GOLD** (S Spratt) - Slow to begin.

**DUNCAN CREEK** (L Douglas) - Crowded shortly after the start having to be steadied.

**DON PAULY** (L Allpress) - Began awkwardly losing ground.

**PEPEHA** (J Chung) - Crowded shortly after the start having to be steadied. Raced three-wide without cover throughout.

**AGERA** (M McNab) - Held up throughout the final straight.

**ROCKBURN** (J Riddell) - Badly held up until near the 150 metres.

**PIZZAZZ** (W Kennedy) - Held up for the majority of the final straight.

**SO SURREAL** (J Doyle) - Held up in the straight until passing the 150 metres.

**COLORADO SILVER** (R Elliot) - Contacted and unbalanced when placed in restricted room near the 400 metres to the outside of SUPERCELL. Crowd when weakening passing the 200 metres, then not being persevered with for the remainder of the race. R Elliot was reminded of his obligations to ride his mounts out fully to the end of the race when circumstances permit. Underwent a post-race veterinary examination which did not reveal any abnormality.

**SUPERCELL** (V Colgan) - Rider reported the gelding had hung outwards throughout the race.

**V Colgan** (SUPERCELL) - Issued with a warning after attempting to shift outwards to obtain clear running, making contact with COLORADO SILVER near the 400 metres.

**Race 4** | **J SWAP STOCKFOODS PREMIER MAAT 1200m**

**PEGAU** (W Kennedy) - Slow to begin.

**RISING TIDE** (M McNab) - Began awkwardly.

**MALDINI** (V Colgan) - Jumped away awkwardly from the outside barrier, getting back as a result. When questioned regarding performance rider advised that after a poor beginning the gelding had then raced greenly and been unable to recover.

**SPENCER** (J Parkes) - Raced three-wide without cover.

**MOMOSA** (J Kamaruddin) - Steadied when awkwardly placed near heels passing the 600 metres.

**EYEGEEGEE** (C Grylls) - When questioned regarding performance rider was of the opinion the gelding may have held its breath but had been disappointing. Trainer G Lowry advised he would be looking to make an appropriate gear change. A post-race veterinary inspection did not reveal any abnormality.

**ALL FIRED UP** (K Asano) - Rider reported that the gelding had hung outwards throughout.

**L Douglas** (KAREHANA BAY) - Issued with a minor infringement and fined the sum of \$100 after failing to make the contracted weight. L Douglas was replaced by J Chung.

**Race 5** | **EL ROCA – SIR COLIN MEADS TROPHY 1200m (Listed Race)**

**LORD WEYBURN** (V Colgan) - Slow to begin.

**TOKYO TYCOON** (O Bosson) - Knuckled shortly after the start.

**CODIGO** (M McNab) - Raced three-wide without cover throughout.

**BURN TO SHINE** (W Kennedy) - Held up until near the 200 metres.

**OVERDRAWN** (S Weatherley) - Had difficulty obtaining clear running for the majority of the final straight.

**SOLIDIFY** (R Elliot) - Inclined to lay inwards in the straight.

**Race 6** | **VET SERVICES EQUINE HAWKE'S BAY PREMIER 1200m**

**NOD OF THE HEAD** (J Chung) - Slow to begin. Had difficulty obtaining clear running early in the final straight before improving on to heels just prior to the winning post, having to be steadied.

**REAL SLIM TRADIE** (J Parkes) - Slow to begin.

**MAZZOLINO** (S Weatherley) - Began awkwardly.

**FASHION SHOOT** (N Parmar) - Had some difficulty obtaining clear running until near the 200 metres.

**CHURCHILLIAN** (V Colgan) - Lay inwards away from FASHION SHOOT approaching the 100 metres, having to be corrected by its rider.

**THE STONEY ONE** (T Taiaroa) - Raced three-wide without cover throughout.

**Race 7** | **HBPB THOROUGHBRED BREEDERS ASSN GOLD TRAIL STAKES (G3) 1200m**

**IMPENDABELLE** (K Asano) - Contacted shortly after the start and forced inwards onto the hind quarters of CHANTILLY LACE, having to be firmly restrained when placed in restricted room and clipped a heel, blundering losing ground.

**ROSALITA** (K Hercock) - Crowded shortly after the start, losing ground. Made the turn near the 800 metres awkwardly.

**TULSI** (M McNab) - Began very awkwardly becoming further unbalanced when making contact with IMPENDABELLE.

**CHANTILLY LACE** (L Sutherland) - Began awkwardly, then being further hampered when contacted shortly after the start, becoming unbalanced. Raced three-wide without cover.

**FULL TILT** (J Doyle) - Contacted shortly after leaving the barriers. When questioned regarding performance rider was unable to offer any excuse. A post-race veterinary examination revealed the filly to be lame in the left hind leg. Connections were advised a veterinary clearance is required prior to FULL TILT racing next.

**CHICA MOJITO** (L Allpress) - Raced greenly passing the 600 metres.

**ORCHESTRAL** (W Kennedy) - When questioned regarding performance rider advised that after receiving a nice enough run, he had attempted to follow **QUINTESSA** into the race, but the filly had failed to quicken and had been disappointing. A post-race veterinary inspection did not reveal any abnormality.

**O Bosson** (**QUINTESSA**) - Issued with a minor infringement notice, being fined the sum of \$200 after weighing in 0.9kg in excess of the weight at which he had weighed out.

**L Sutherland** (**CHANTILLY LACE**) - Spoken to regarding her whip action in the straight.

**Race 8** | **WORLDS BEST SPRINTER – LUCKY SWEYNESSE PREMIER 1400m**

**BELLE OF THE BALL** (N Parmar) - Slow away.

**APOSTROPHE** (W Kennedy) - Jumped away awkwardly.

**BEST SELLER** (J Riddell) - Jumped away awkwardly. Contacted by **ONE DREAM ONE SOUL** near the 300 metres, when that runner was taken in by **BOLD IRIS** (J Kamaruddin). J Kamaruddin was advised to exercise care. When questioned regarding performance rider advised that after suffering slight interference near the 300 metres, the filly had failed to finish the race off and had been disappointing.

**DURHAM LAD** (T Davies) - Raced three-wide without cover.

**SLIPPER ISLAND** (M McNab) - Held up early in the straight, continuing to have difficulty obtaining clear running until passing the 100 metres.

**PENNY ROYAL** (J Chung) - Shifted inwards under pressure making contact with **SLIPPER ISLAND** near the 100 metres then making contact with **DISS IS DRAMATIC**.

**DISS IS DRAMATIC** (S Spratt) - Bumped 100 metres.

**DEEBEE ZAPOWER** (O Bosson) - Held up early in the straight.

**SPRING TIDE** (J Kamaruddin) - Held up early in the straight making contact with **CALLSIGN MAV** when attempting to obtain clear running.

**ONE DREAM ONE SOUL** (L Allpress) - Rider reported that the mare had felt indifferent in its action. A subsequent veterinary examination revealed lameness in the left foreleg with a veterinary clearance now required prior to racing again.

Following the running of the race the trainer of the second placed horse **ELECTRIC TIME**, Mr L Te Keeti lodged a protest with the Adjudicative Committee alleging interference over the concluding stages by the first placed horse **APOSTROPHE**. After considering submissions the Adjudicative Committee dismissed the protest.

**Race 9** | **WESTBURY STUD TARZINO TROPHY (G1) 1400m**

**SPRING TIDE** (J Kamaruddin) - Underwent a veterinary examination behind the barrier after becoming fractious in the birdcage and was cleared to run.

**PENNYWEKA** (K Hercock) - Crowded shortly after the start losing ground.

**LA CRIQUE** (C Grylls) - Crowded shortly after the start losing ground.

**HE'S A DOOZY** (K Asano) - Over-raced in the early and middle stages.

**LICKETY SPLIT** (L Allpress) - Raced three-wide without cover throughout. When questioned regarding performance rider advised the mare had received a tough run and had failed to finish the race off. Underwent a post-race veterinary examination which did not reveal any abnormality.

**BRANDO** (J Parkes) - Raced wide without cover from near the 800 metres. When questioned regarding performance, J Parkes advised that the gelding had received a tough run but was also of the opinion would be better suited by further easing of the ground.

**O Bosson** (SKEW WIFF) - Admitted a charge in that he weighed in excess of 0.5kg above the weight at which he had weighed out. After hearing submissions, the Adjudicative Committee imposed a fine of \$750.

**Race 10**

**LIVAMOL – INTERNATIONAL ANIMAL HEALTH PRODUCTS PREMIER 1600m**

**CHARMS STAR** (C Grylls) - Slow to begin.

**NOT IDEAL** (M McNab) - Raced three-wide without cover throughout.

**MONZA** (M Sanson) - Had to be steadied to the avoid heels of SAGUNTO passing the 1100 metres when that runner shifted inwards when not fully clear.

**CAMPIONESSA** (O Bosson) - Held up early in the home straight.

**WHITE NOISE** (J Doyle) -When questioned regarding performance rider advised the gelding had travelled well enough but when placed under pressure had failed to respond and been disappointing. Underwent a post-race veterinary examination did not reveal any abnormality.

**L Allpress** (SAGUNTO) - Issued with a warning after permitting SAGUNTO to shift inwards when not fully clear of MONZA passing the 1100 metres.
