RACE COMMENTS

Race 1 CAMBRIDGE EQUINE HOSPITAL MAIDEN 1550

MS CANDEE LANE (J Doyle) - Began awkwardly losing ground. Improved onto heels near the 900 metres having to be steadied.

MONTEZUMA (B Rogerson) – Raced three wide without cover throughout.

BLACK OPAL (A Goindasamy) - Over-raced through the middle stages.

Race 2 ASCOT FARM 1550

MERSEY BEAT (A Goindasamy) - Restrained in the early stages to obtain cover from a wide barrier. Raced keenly through the early and middle stages.

MCENROE (V Jalalkuncha) - Began awkwardly. Raced keenly in the early stages.

LA DOLCE VITA (M McNab) – Lay inwards when placed under pressure in the final straight.

Race 3 MANNING INVESTMENTS LTD MAIDEN 1300

PRINCESS TERESA (A Goindasamy) - Slow to begin. Improved into restricted room to the outside of ISLEBEFINE hampering JADE which was forced wider near the 600 metres. Inconvenienced near the 350 metres when ISLEBEFINE shifted outwards when not sufficiently clear. S Spratt (ISLEBEFINE) was advised to exercise greater care in similar circumstances.

ALADDIN SANE (W Kennedy) - Slow to begin then crowded shortly after, losing ground.

HIGHLY VINDICATED (J Doyle) – Raced wide without cover for majority of the race.

JADE (V Colgan) - Hampered approaching the 600 metres when PRINCESS TERESA improved into restricted room. A Goindasamy (PRINCESS TERESA) was advised to exercise greater care in similar circumstances.

ELTON ROCKS (L Satherley) - Placed in restricted room having to be steadied near the 200 metres to the inside of HIGHLY VINDICATED which had shifted inwards when insufficiently clear, and the outside of KING'S MOUNT which had shifted outwards slightly. C Grylls (KING'S MOUNT) was advised to exercise greater care in similar circumstances.

J Doyle (HIGHLY VINDICATED) - Issued with a warning for permitting his mount to shift inwards when insufficiently clear of ELTON ROCKS which had to be steadied near the 200 metres.

R James & R Wellwood (SUDBINA) - Issued with a warning for failing to scratch SUDBINA by the required time.

Race 4 GARRARD'S HORSE & HOUND 1300

GOLDBURG (N Hailey) – Raced three wide without cover throughout.

SPELLCRAFT (C Grylls) - When questioned regarding performance the rider could offer no excuse.

Race 5 SHAW'S WIRE ROPES MAIDEN 970

SHEZZADREAM (E Nicholas) - Reared at the start losing ground (5L). Raced wide without cover throughout. Connections were advised a warning would be placed against the mare's barrier manners.

FLOWER MOON (J Doyle) – Slow to begin. Had difficulty obtaining clear running throughout the final straight.

HIGHLY ANTICIPATED (W Kennedy) - Began awkwardly. Held up until passing the 350 metres.

LA CERVEZA (M McNab) - Lay outwards when placed under pressure in the final straight.

Race 6 GROUP ONE TURF BAR MAIDEN 970

GOLD COUTURE (J Fawcett) - Ducked inwards abruptly shortly after the start, losing ground. Then trailed the field for the remainder of the race. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

ROZEL (M McNab) - Began awkwardly losing ground.

Race 7 MARTIN COLLINS NEW ZEALAND 2000

BRONTES GOLD (J Doyle) – Knuckled on jumping away.

LIQUID FIRE (C Grylls) – Raced keenly in the early stages when being restrained.

Race 8 CAMBRIDGE REAL ESTATE 2000

BRECKON POWER (S Weatherley) - Began awkwardly losing ground.

CHARRED (N Hailey) - Began awkwardly losing ground.

THE BAMBINO (K Asano) – Raced wide without cover throughout.

TURNMEON (A Goindasamy) – Lay out when placed under pressure in the final straight.

MILLENNIUM DAWN (J Doyle) - Returned to the enclosure with blood present in both nostrils. Following a veterinary examination MILLENNIUM DAWN was confirmed to have bled. MILLENNIUM DAWN shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a veterinarian.
