GENERAL

S Muniandy advised Stewards on the morning of the races he was unwell and would not be attending the races today. He was replaced on his one ride as per the Summary above. K Selvan was briefly shown as the replacement rider due to a miscommunication. S Muniandy was advised he would require a medical clearance prior to riding next.

L Callaway (LEROY) - Admitted a charge under Rule 330(3)(c) in that he was unable to make the contracted weight for his ride in Race 4 today and was fined \$100 under the Minor Infringement Schedule. L Callaway was replaced as per the Summary above.

Race 2 CANTERBURY WESTLAND RACING OWNERS ASSOCIATION 1200m

SHINTO (T Moseley) – Trainer Ms. M Cunneen advised Stewards, SHINTO underwent a veterinary examination on Monday 18 September which included x-rays, with results showing bone chips to both front knees. M Cunneen further advised the gelding will now undergo an operation next week.

Race 6 ELMWOOD TRADING COMPANY 2000m

MR PHOTOGENIC (K Williams) – Stable representative Mr. J Best reported to Stewards, the stable was satisfied with the post-race condition of the gelding, however, has now been sent for a spell.

Race 8 NEW ZEALAND BLOODSTOCK CANTERBURY BELLE STAKES 1200m

MIS SPEAKS (B Murray) – Trainer Ms. M Cunneen advised Stewards that post-race the filly was showing signs of jarring up with MIS SPEAKS now being sent for a spell.

AMIINIT (K Hercock) – Trainer Mr. J Blackadder reported to Stewards, the filly pulled up post-race distressed, and upon return was showing signs of jarring up and shin soreness. J Blackadder further advised AMIINIT has now been sent for a spell.

RACE COMMENTS

Race 1 PADDY'S BINS MAIDEN 1200m

ENTRENCH (B May) - Began awkwardly, shifting out and crowding outside runner.

MRS LAWRENCE (C Campbell) - Crowded shortly after the start losing ground.

MISS PEARL (T Comignaghi) - Raced three-wide without cover throughout.

Race 2 GRANT FARMING PARTNERSHIP 1200m

BUSH MILLS BILLY (G Jogoo) - Blundered on jumping.

SACRED KITTY (R Jaun) - After initially being slow to begin was ridden forward to lead passing the 1000 metres.

ALBY PARK (Y Atchamah) - Taken back from a wide draw to obtain cover in the early stages. When questioned regarding the improved performance trainer P Corbett advised that the gelding had performed well in a higher grade two starts ago and today got track conditions to suit with the performance not unexpected.

ROSY CLARK (K Rathoar) - Rider reported the mare had been uncomfortable in today's heavy track conditions. K Rathoar was reminded of his obligations to ride his mount out fully to the end of the race where circumstances permit.

Race 3 JJS GORE 1200m

WATTABREEZE (Y Atchamah) - Escaped riderless from the birdcage and returned to the tie up stalls being quickly recaptured. Underwent a subsequent Veterinary examination and was cleared to start. Lost ground when shifting in abruptly at the start, crowding an inside runner.

ZAC BLACK (S Khetoo) - Crowded at the start losing ground.

DARCI VINO (K Chowdhoo) - Dipped passing the 400 metres.

LIPA MALA (T Comignaghi) - Raced three-wide without cover throughout. Placed in restricted room passing the 100 metres when BLEAKHOUSE BURTIE was dictated inwards at this point.

BLEAKHOUSE BURTIE (L Callaway) - Crowded and checked passing the 125 metres when THE GREY GOOSE shifted in under pressure.

R Mudhoo (THE GREY GOOSE) - Admitted a charge of careless riding in that he permitted THE GREY GOOSE to shift ground inwards near the 125 metres when not sufficiently clear of BLEAKHOUSE BURTIE which was crowded and checked. After hearing submissions, the Adjudicative Committee suspended Mr Mudhoo's licence to ride in races from the conclusion of racing today until the conclusion of racing on Saturday 30 September, 4 national riding days.

Race 4 | **KEVIN COYLE MEMORIAL 1100m**

SILENT BATTLER (Y Atchamah) - Slow to begin.

SEA SHEPHERD (C Campbell) - Slow to begin.

LEROY (R Mudhoo) - Raced three-wide without cover in the early stages.

HENRY HUBBER (D Montes de Oca) - Raced wide without cover from the 600 metres.

THE GOOD SHEPHERD (G Jogoo) - Contacted and briefly unbalanced when SEA SHEPHERD shifted out on the point of the bend near the 250 metres. Rider reported in his opinion the gelding needed more ground than the distance of today's race.

MIDNIGHT RUNNER (K Williams) - Crowded and had to steady passing the 225 metres when EMANON shifted in before being straightened by its rider.

S Wynne (EMANON) - Issued with a warning after permitting EMANON to shift in passing the 225 metres crowding MIDNIGHT RUNNER which had to steady.

Race 5 | **GORE ELITE PLUMBING MAIDEN 1100m**

Trainer **D Stalker** (CHRISTOPHE VERMEER) – Issued with a warning under Rule 613(c) after presenting the gelding in racing plates which required farrier attention prior to the start.

RADIANT REACH (K Williams) - Hampered at the start losing ground.

IDEAL DREAMS (K Chowdhoo) - Knuckled leaving the barriers and shifted out crowding RADIANT REACH. When questioned regarding the performance of favoured runner rider could offer no tangible excuse for the disappointing run.

REDDINGTON (K Mudhoo) - Taken back from a wide draw to obtain cover shortly after the start.

CHRISTOPHE VERMEER (S Wynne) - Over-raced when leading through the early to middle stages.

HOWBADCANUB (T Comignaghi) - Had difficulty obtaining clear running throughout the run home and went to the line untested by its rider.

Race 6 | **JAMES ENGINEERING MAIDEN 1335m**

ZA BEAUTEOUS (S Khetoo) - Slow to begin.

VOLT EDGE (L Callaway) - Slow to begin.

MIA ROSSI (S Wynne) - Slow to begin and was then outpaced, becoming detached from the body of the field through the middle stages. Rider reported that the mare was not suited by today's testing track conditions.

THE RED KRACKEN (K Kwo) - Taken back from a wide draw to obtain cover shortly after the start. When questioned regarding the performance rider advised that after being obliged to get back from the wide draw it had been hard to make ground in today's testing track conditions.

CHEX MY NONO (K Williams) - Raced wide from the 700 metres.

LEO'S HIPPO (D Montes de Oca) - Raced wide without cover for the majority of the event.

RHYOLITE (C Campbell) - Lost the off-hind racing plate during the running.

Race 7 | **ADVANCE AGRICULTURE 1335m**

UPHOLD (K Rathoar) - Slow to begin.

SO MUCH MOUR (S Khetoo) - Slow to begin. Lost the near front racing plate during the running.

ZOEY SATIN (C Campbell) - Inclined to lay in over the concluding stages when placed under pressure.

OUR CLARRY (Y Atchamah) - When questioned regarding the performance rider advised that the gelding had failed to handle today's track conditions.

Race 8 | **ROOFCRAFT INDUSTRIES 1335m**

SHEJENGAR (D Montes de Oca) - Began awkwardly. Raced keenly in the early stages and was shifted outwards across heels approaching the 800 metres. When questioned regarding the performance rider advised that the mare is better suited when ridden with cover.

BELLA ROSE (L Callaway) - Slow to begin.

CASTLE ON THE HILL (K Williams) - Slow through the early stages then tailed the field throughout and was not persevered with in the run home. Rider advised she could offer no tangible excuse for the performance other than the mare had been under pressure throughout. Connections advised they would be reassessing the racing future of the mare.

MORMAIRE (Y Atchamah) - Briefly steadied to avoid the heels of SHEJENGAR (D Montes de Oca) which shifted ground outwards approaching the 800 metres. D Montes de Oca was advised to exercise greater care.

Race 9 | **HOKONUI SUZUKI 1800m**

VAGUE (Y Atchamah) - Raced three-wide without cover in the early stages before improving forward to sit outside the leader passing the 1400 metres.

GABBY DIAZ (C Campbell) - Over-raced badly in the early stages on a slow tempo, getting its head up on a number of occasions.

CHOUX IN (T Comignaghi) - Rider reported that the mare had failed to handle the testing nature of today's track conditions.

Race 10 | **AB LIME 2000m**

DIVOVSKI (K Mudhoo) - Began awkwardly contacting the hind quarters of CAMPING and losing ground as a result. When asked to comment on the performance rider could offer no tangible excuse other than the gelding had made abnormal breathing noises throughout. A post-race Veterinary examination revealed no abnormalities.

PINHEAD (R Jaun) - Slow to begin.

SKYROCKETSINFLIGHT (G Jogoo) - Slow to begin. When asked to comment on the performance rider could offer no tangible excuse however advised in his opinion the mare would take natural improvement from its first up run after a brief spell.

HALLELUJAH BROTHER (K Kwo) - Over-raced through the early stages and had to be restrained when improving on to heels near the 1400 metres.

EXTREME POWER (B Murray) - Slow to begin. Under pressure passing the 800 metres and tailed the field throughout, not being persevered over the concluding stages. When asked to comment on the performance rider advised that the gelding had been under pressure passing the 800 metres and had not responded to his riding. Stewards will follow up with connections in the coming days.

HIDALGO (C Campbell) - When questioned regarding the improved performance trainer J Phillips advised that he had made some gear changes, the gelding had been working well during the week and this combined with being able to gain a soft run today and a drop in class had led to the improved run.
