**Race 5 CRAIGS INVESTMENT PARTNERS MILE 1600** 

**DEFIBRILLATE** (M Kareem) – Co-trainer R Norvall advised Stewards, that after the gelding's run DEFIBRILLATE had his eyes treated for seven days. R Norvall further advised the gelding may have an exhibition gallop at the Waikato RC meeting on Friday 29 September and from there the stable will look to nominate DEFIBRILLATE for the Hawke's Bay RI meeting on Saturday 14 October.

#### **RACE COMMENTS**

### Race 1 CAMBRIDGE EQUINE HOSPITAL MAIDEN 1550

ESTELLA KHAN (K Asano) - Slow to begin.

**RASANTE** (W Kennedy) - Began awkwardly. Briefly steadied after improving into a marginal run passing the 50 metres.

MONTEZUMA (B Rogerson) - Slow to begin.

**HIGHLY VINDICATED** (J Doyle) - Raced keenly in the early stages. Lay out when placed under pressure in the final straight.

**MCENROE** (A Goindasamy) - Raced wide without cover throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

VA DANSER (B Grylls) - Improved onto heels approaching the 1100 metres having to be steadied.

MS CANDEE LANE (V Colgan) – Lay out when placed under pressure in the final straight.

NASHOBA (S Spratt) - Hampered near the 125 metres.

**BRUCEY LEE** (L Satherley) - Inconvenienced approaching the 50 metres after improving onto the heels of HIGHLY VINDICATED.

**LUCKY CHARM** (C Grylls) - Gave ground over the concluding stages. Trainer advised that the gelding would not be persevered with as a racing proposition from their stable.

J Doyle (HIGHLY VINDICATED) - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of NASHOBA which was hampered near the 125 metres. After considering submissions the Adjudicator imposed a suspension of J Doyle's licence to ride in races from the conclusion of racing on Sunday 1 October up to and including racing on Wednesday 11 October, 5 national riding days.

# Race 2 WAIPA EARTHWORKS 1550

**ROCK MY HEART** (L Satherley) – Slow to begin.

**UP 'N' GONE** (C Grylls) – Slow to begin.

**SIDE EYE** (J Allen) – Raced keenly in the early stages when being restrained.

**THE WOMAN KING** (A Goindasamy) - Steadled to avoid heels approaching the 400 metres when SIDE EYE shifted out. J Allen was advised to exercise greater care when shifting ground.

**BRONTES GOLD** (J Doyle) – Lay in when placed under pressure.

**GUNNAR** (S Spratt) - Lay out when placed under pressure in the final straight.

### Race 3 MARSH RACING MAIDEN 1300

**ROC ANTHEM** (K Asano) - Slow to begin (5L). Trainer I George was advised a warning was placed on the gelding's barrier manners.

AVIGNON (S Weatherley) - Slow to begin. Raced keenly through the middle stages.

**KAJITSU** (V Colgan) – Crowded at the start losing ground.

**SWEET TALKING** (S Spratt) – Raced wide without cover throughout.

**RECRUIT** (J Doyle) - Shifted outwards entering the final straight making contact with SONIC BOOM which was forced outwards with SONIC BOOM then shifting inwards making contact with RECRUIT for a distance. Held up for clear racing room entering the final straight.

**SONIC BOOM** (M McNab) - Came together with RECRUIT entering the final straight on a number of occasions. When questioned regarding the performance the rider advised that the gelding had made abnormal breathing noises during the run.

### Race 4 MAGNUM INDUSTRIES 1300

**HASSTOBEPERFECT** (V Colgan) – Slow to begin then crowded shortly after losing ground. Held up until near the 150 metres and again over the final 50 metres.

VINO VALENTINO (S Weatherley) - Slow to begin. Held up early in the final straight.

JUSTASCOOTA (S Spratt) - Slow to begin.

ROCABURY (L Satherley) - Raced three wide without cover throughout.

**SEAMSEW** (J Doyle) - Made the final bend awkwardly. Lay out when placed under pressure in the final straight.

**ELUSIVE NATION** (E Nicholas) - Rider reported that the gelding felt indifferent in its action. Underwent a post-race veterinary examination which found the gelding to be lame in the left foreleg. Trainer M Da Cruz was advised that a veterinary clearance would be required prior to racing next.

# Race 5 ENTAIN – NZB INSURANCE PEARL SERIES MAIDEN RACE 1300

MARIA (C Barnes) - Slow to begin.

**BOOM BOOM** (T Newman) – Raced three wide without cover throughout.

FASHION DELIGHT (W Kennedy) - Held up until near the 250 metres.

**COMPOSURE** (J Doyle) - Held up until approaching the 150 metres.

**TOSCA** (C Grylls) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

# Race 6 FORSMAN RACING MAIDEN 970

**TRUECOLOURS** (S Spratt) - Was fractious in its barrier stall. Trainer C Isdale was advised that a warning would be placed on the mare's barrier manners.

YOUNG DIVA (T Abel) - Crowded shortly after the start losing ground.

MISS SOLIATIRE (N Parmar) – Began awkwardly losing ground. Rider dropped his whip passing the 200 metres.

**GOOD SOUL** (L Satherley) – Raced wide without cover.

LA CERVEZA (M McNab) - Lay out when placed under pressure in the final straight.

**HIGHLY ANTICIPATED** (W Kennedy) - Rider reported that the mare had felt indifferent in its action. Underwent a post-race veterinary examination which found a laceration to the right fore heel.

**SHEZZADREAM** (E Nicholas) - Returned to the enclosure with blood present in both nostrils. Following a veterinary examination SHEZZADREAM was confirmed to have bled. SHEZZADREAM shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a veterinarian.

### Race 7 SADDLERY WAREHOUSE MAIDEN 970

**CONFETTI** (M McNab) - Began awkwardly then crowded shortly after, losing ground. When questioned regarding the performance the rider advised that the filly raced greenly and would derive benefit from the experience.

ARABIAN SONGBIRD (W Kennedy) - Slow to begin.

LISE PAREE (V Jalalkuncha) - Raced keenly in the early stages.

# Race 8 COOKIES KITCHEN 2000

**TURNMEON** (A Goindasamy) - Crowded shortly after the start losing ground. Steadied away from heels passing the 1300 metres. Raced keenly for a distance passing the 1000 metres.

BEAU ARCHERS ROSE (E Nicholas) - Slow to begin.

**CORDYCEPS KING** (W Kennedy) - Raced three wide without cover until improving forward to lead near the 1300 metres. Lay out rounding the final bend.

**POSTER BOY** (T Newman) - Held up until near the 300 metres.

WAIHI WARRIOR (C Grylls) - Underwent a post-race veterinary examination which did not reveal any abnormality.
