#### RACE COMMENTS

Race 1 POSITIVE SIGNS + PRINT 1200m

AVAQUINELLA (T Comignaghi) - Slow to begin.

ADANNAYA (C Barnes) - Slow begin.

EMANON (S Wynne) - Over-raced in the early stages.

**REDMOND** (Y Atchamah) - Rider reported the gelding had been making abnormal breathing noises during the running. A post-race Veterinary examination did not reveal any abnormality.

**S Wynne** (EMANON) – Admitted a charge in that she struck her mount EMANON 7 times prior to the 100 metres mark, 2 more than permitted, with a further additional 4 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$250.

#### Race 2 NELLIES RESTAURANT & BAR MAIDEN 1200m

WARRIORESS (A Balloo) - Slow to begin.

**UGET WHAT YOU GIVE** (T Comignaghi) - Shifted out at the start hampering outside runner.

**ABERLOUR** (K Williams) - Hampered at the start losing ground. Over-raced in the middle stages, making the bend near the 900 metres awkwardly.

HAKADECREE (C Campbell) - Over-raced when being restrained in the early stages. Raced greenly throughout.

**PINHEAD** (R Jaun) - Slow to begin.

**MISS INTERPRET** (W Kennedy) - Restrained to obtain cover in the early stages after jumping from an outside barrier. When asked to comment on the performance rider could offer no tangible excuse.

**CAMPING** (R Mudhoo) - Placed in restricted room to the inside of THE TUI TOILER (B Murray) near the 1900 metres. B Murray was advised to exercise greater care.

THE TUI TOILER (B Murray) - Raced keenly in the lead through the early to middle stages.

**ASTRADEEL** (K Hercock) - Briefly held up passing the 300 metres. Inclined to lay inwards under pressure in the home straight.

WIND IN MY WINGS (K Chowdhoory) - Rider dropped his whip near the 300 metres.

**TIGER FIRE** (T Comignaghi) - Briefly held up having to steady and shift outwards across the heels of THE TUI TOILER to obtain clear running near the 250 metres. Post race was reported to have suffered an injury to a near front tendon. A subsequent Veterinary examination revealed the gelding to have suffered a right fore suspensory injury. A Veterinary Clearance will be required prior to the gelding racing next.

EAVESDROP (C Campbell) - When asked to comment on the performance rider could offer no tangible excuse.

## Race 4 SPEIGHT'S 1200m

The start of this event was delayed approximately 7 minutes due to the incident with WAIPAPA.

**WAIPAPA** (E Nicholas) - Proved reluctant to proceed to the start and reared over backwards. The mare was immediately attended to be the on-course Veterinarian and lay on the track for some time before regaining its feet. Declared a late scratching at 2.22pm. After receiving Veterinary treatment and initially responding, the mare continued to be monitored, undergoing a follow up examination which revealed WAIPAPA to be suffering from cranial deterioration with the mare being humanely euthanised. Rider E Nicholas was attended to by St John Ambulance personnel and stood down from her remaining riding engagements with an ankle injury. Miss Nicholas was advised a Medical Clearance will be required prior to her resuming riding.

ARCEUS (S Khetoo) - Began awkwardly losing ground.

SOOO DUSTY (R Jaun) - Began awkwardly losing ground.

**MADAM DUBAI** (K Williams) - Briefly held up passing the 275 metres, having to be angled out across heels passing the 150 metres to find clear racing room.

**CHEYENNE DREAMS** (J Kamaruddin) - Held up early in the home straight having to shift outwards across heels to obtain clear running near the 250 metres.

**MISS SAILOR** (T Comignaghi) - Had difficulty obtaining clear running throughout the final straight and was unable to be fully tested by its rider.

Trainer **M House** (MISS SAILOR) - Fined \$100 under the Minor Infringement Schedule after presenting the mare to race in pre-race ear covers instead of racing ear covers.

### Race 5 DUNEDIN CITY MOTORS MAIDEN 1200m

The start of this event was delayed approximately 6 minutes due to the delay in the previous race and a number of runners proving reluctant to load.

**DEEP STREAM** (K Williams) - Slow to begin.

MISS MULLIGAN (C Barnes) - Jumped away awkwardly making contact with ELOQUENT LASS.

**ELOQUENT LASS** (R Mudhoo) - Contacted leaving the barriers when MISS MULLIGAN shifted inwards. Held up by a tiring runner near the 500 metres and when being steadied came back onto CHERRYVILLE which also had to be restrained.

MATTRIC (S Wynne) - Briefly steadied to avoid heels passing the 1100 metres.

**RUTHLESS ROYAL** (T Comignaghi) - Over-raced in the early stages, having to be steadied off heels near the 900 metres. Lost the right hind racing plate during the running.

CHERRYVILLE (K Rathoar) - Steadied off heels near the 500 metres.

**SWEYBANA** (A Balloo) - Hung outwards throughout the running proving a difficult ride.

BOWLER (C Campbell) - Held up passing the 200 metres having to be steadied outwards off heels.

**A Balloo** (SWEYBANA) - Issued with a warning after permitting his mount SWEYBANA to shift inwards near the 1100 metres when not fully clear of MATTRIC which had to be steadied to avoid heels.

**B Murray** (MACCEDES) - Issued with a warning after permitting his mount MACCEDES to shift inwards near the 900 metres crowding RUTHLESS ROYAL which had to be steadied to avoid heels.

Race 6 BE MY GUEST DESIGN 1400m

**RHONDA WOOD** (Y Atchamah) - Began awkwardly.

**LEAVE IT TO ME** (S Wynne) - Began awkwardly losing ground. Steadied off heels near the 800 metres when the pace of the race eased slightly.

**SEVEN TWENTY** (K Chowdhoory) - Hampered leaving the barriers losing ground.

**ZAC BLACK** (S Khetoo) - Steadied to obtain cover in the early stages after jumping from a wide barrier.

KEEN TO RUN (K Hercock) - Raced keenly in the middle stages.

**RICHARD STOMPER** (R Mudhoo) - Had difficulty obtaining clear running until near the 200 metres, then lay out under pressure for the remainder of the race.

**NOBELLEM** (K Williams) - Not persevered with in the final straight, dropping out to finish a distant last. When questioned regarding performance rider advised that the mare had never travelled well throughout the race and had been very disappointing. A post-race Veterinary examination revealed the mare to have suffered cardiac arrhythmia. Connections were advised a Veterinary Clearance would be required prior to NOBELLEM racing next.

Race 7

ENTAIN – NZB INSURANCE PEARL SERIES RACE MAIDEN 1600m

MIA ROSSI (S Wynne) - Slow to begin and was then outpaced through the early stages despite the efforts of its rider.

PULL THE PIN (B Murray) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

**HOWBADCANUB** (K Mudhoo) - Ducked inwards abruptly near the 1400 metres having to be corrected by its rider and was then inclined to over-race for a distance. Held up in the final straight until near the 100 metres.

BLUEGRASS DIXIE (J Kamaruddin) - Raced ungenerously in the middle stages when being restrained.

MIDORIYAMA (S Khetoo) - Raced wide without cover throughout.

WILD JAKKAL (C Campbell) - Raced in restricted room for the majority of the run home.

Race 8 GRAND CASINO 1600m

**MORMAIRE** (S Khetoo) - Slow to begin. Ducked outwards near the 1400 metres hampering BELLANO and DEVIL IN DISGUISE.

**DEVIL IN DISGUISE** (K Mudhoo) - Slow to begin. Hampered near the 1400 metres.

**BAUBLE** (C Campbell) - Slow to begin. Had difficulty obtaining clear running early in the home straight, having to shift ground outwards passing the 150 metres to find clear racing room. Shifted in under pressure passing the 25 metres crowding DARCEE QUE which had to steady in the shadows of the post. Also inconvenienced was DARCI VINO.

BELLANO (R Mudhoo) - Hampered near the 1400 metres.

**DARCEE QUE** (T Comignaghi) - Raced three wide without cover throughout. Crowded and steadied in the shadows of the winning post.

**CHOUX MACHER** (Y Atchamah) - Lay out rounding the final turn.

JIBBITY (S Wynne) - Held up rounding the final turn and early in the home straight.

DARCI VINO (K Williams) - Inconvenienced concluding stages.

**C Campbell** (BAUBLE) – Issued with a warning after allowing his mount BAUBLE to shift inwards passing the 25 metres crowding DARCEE QUE and DARCI VINO.
