Race 1 TE RAPA EVENT CENTRE 1400

PAUL DAVID (C Grylls) – Trainer C Cole advised Stewards the gelding pulled up post-race showing signs of jarring up and underwent treatment on its back. C Cole further advised the gelding has now been sent for a freshen up.

Race 8 JAMIESON PARK SOLILOQUY STAKES 1400 (G2)

LUBERON (C Gaudray) – Trainer L Noble reported to Stewards LUBERON was examined by the Veterinarian on Monday 30 October, and the Physiotherapist on Tuesday 31 October, with no abnormalities being detected. L Noble further advised it is his intention to continue on with the filly's current preparation.

K Asano (IMPENDABELLE) - At a reconvened hearing at Te Aroha Racecourse on Friday 3 November, K Asano admitted a charge in that he struck his mount 8 times prior to the 100 metres. After considering submissions the Adjudicator imposed a fine of \$2,500.

RACE COMMENTS

Race 1 NOTTINGHAM CASTLE HOTEL MAIDEN 2200

ROC ANTHEM (N Parmar) - Began awkwardly.

ZEIGLAR (J Fawcett) - Attempted to improve into a marginal run to the inside of ROC ANTHEM near the 500 metres then lay outwards striking a heel of that runner and falling into the line of POLAMALU which was brought down with both runners dislodging their riders. Also severely hampered as a result was CRYSTAL FALLS. J Fawcett was attended to by the oncourse Ambulance personnel and found to be uninjured. Underwent a post-race veterinary examination which revealed the gelding to have suffered a laceration to its left fore heel. Connections were advised a veterinary clearance would be required prior to the gelding racing next.

POLAMALU (C Grylls) - Brought down dislodging its rider near the 500 metres. C Grylls was attended to by the oncourse Ambulance personnel and found to be uninjured. Underwent a post-race veterinary examination which did not reveal any abnormality.

CRYSTAL FALLS (C Barnes) - Severely hampered passing the 500 metres.

J Doyle (RASANTE) - Admitted a charge in that he struck his mount eight times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.

Race 2 ENTAIN – NZB INSURANCE PEARL SERIES MAIDEN RACE 1600

COURT OF APPEAL (N Parmar) - Slow to begin. Raced three wide without cover throughout.

BLUE BAY (K Asano) - Slow to begin.

FIFTY SHADES (T Newman) - Restrained at the start to obtain cover from its wide barrier.

TADWISE (A Lawson-Carroll) - Began awkwardly. Raced keenly through the early and middle stages. Had to be steadied when placed in restricted room passing the 1200 metres.

HARLOW ROCKS (C Grylls) – Lay out when placed under pressure in the final straight.

Race 3 | **DONAGHYS UDDERMAX MAIDEN 1600**

ZEFFERT (S Spratt) - Began awkwardly losing ground.

PROMISED LAND (M McNab) - Knuckled at the start. Came together with **ALADDIN SANE** passing the 50 metres.

ALADDIN SANE (C Grylls) - Began awkwardly making contact with **MISTA STITCH**. Came together with **PROMISED LAND** passing the 50 metres.

MISTA STITCH (K Asano) - Contacted at the start by **ALADDIN SANE** which began awkwardly.

LA GRANGE (A Lawson-Carroll) – Began awkwardly.

TERRYSAWUS (C Barnes) - Began awkwardly.

RUMEUR (M Cameron) – Raced three wide without cover throughout.

JUWALA (V Colgan) - Had some difficulty obtaining clear running until near the 200 metres.

Following this race, the track was downgraded to Soft 7.

Race 4 | **DONAGHYS N-BOOST MAIDEN 1600**

BAULETTO (S Weatherley) - Slow to begin.

SMILESPARKLESHINE (J Fawcett) - Slow to begin.

BENNETON (S Spratt) - Raced three wide without cover throughout.

OUTOVSTOCK (C Grylls) - Made the bend awkwardly near the 900 metres.

MORLICH (N Parmar) - Steadied when placed in restricted room to the outside of **LOOSE CHANGE** and inside of **ARTIST IMPRESSION** near the 50 metres.

MCENROE (K Asano) - Improved into restricted room passing the 100 metres having to be steadied.

J Doyle (**SHAKING STEVENS**) - Stewards questioned J Doyle into the reasons why he showed a perceived lack of vigour early in the final straight. J Doyle explained that the gelding had travelled comfortably entering the final straight, however when asked to quicken approaching the 350 metres, had not responded as anticipated, adding that the gelding may have been unsuited by the track conditions. Stewards noted J Doyle's comments.

Following this race, the track was downgraded to Heavy 9.

Race 5 | **MAINFREIGHT 1400**

KORO'S PRINCESS (J Fawcett) - Crowded at the start losing ground.

ANELA (J Doyle) - Over-raced in the early stages when being restrained. Held up until near the 250 metres.

THREE NINETY (A Lawson-Carroll) - Raced three wide without cover throughout.

BRIDGERTON (C Grylls) - Raced wide without cover throughout.

BEYOND VIOLET (A Goindasamy) - When questioned regarding the performance the rider advised that in his opinion the mare had failed to handle today's track conditions.

Race 6 | **DONAGHYS PRO-EQUINE 1400**

MISTER PUCCI (J Kamaruddin) - Began awkwardly losing ground.

INCUBO (M Cameron) - Restrained at the start to obtain cover from its wide barrier.

WHEAO (L Satherley) - Raced ungenerously in the early stages losing ground. Connections were advised that a warning would be placed on the geldings racing manners.

HAYATE (M McNab) - Raced three wide without cover throughout.

Race 7 | **DONAGHYS PRO-DAIRY MAIDEN 1180**

BEE ON TIME (K Bakker) - Began awkwardly losing ground. Lay out when placed under pressure in the final straight.

I'MUNSTOPPABLE (J Doyle) – Raced keenly through the early and middle stages when being restrained.

LET IT BEGIN (M Cameron) - Inconvenienced near the 900 metres by I'MUNSTOPPABLE which shifted inwards when not fully clear before being corrected by its rider. J Doyle was advised to exercise care in similar circumstances.

A Lawson-Carroll (LISA PAREE) – Reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

Race 8 | **DONAGHYS BUTCH COOMBE MEMORIAL CUP 1600**

WITHALLMYHEART (J Doyle) - Slow to begin.

IFFIN DOUBT DANCE (K Asano) - Slow to begin. When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

HELLY BELLY (S Spratt) - Briefly steadied when placed in restricted room to the inside of BECAUSE near the 100 metres. Lost the near fore plate during the running.

Race 9 | **DONAGHYS PRO-ABAMEC MAIDEN 1180**

COMPLIMENTERRY (C Barnes) - Slow to begin.

PERICLES (V Colgan) - When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 10 | **DONAGHYS TASMAN TIM MAIDEN 1180**

HE'S SO FINE (D Danis) - Began awkwardly then contacted shortly after becoming briefly unbalanced. Raced keenly through the middle stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

LADY GREY (B Rogerson) – Contacted shortly after the start becoming briefly unbalanced.

FALCON FALCON (A Lawson-Carroll) - Contacted shortly after the start becoming briefly unbalanced then steadied when placed in restricted room to the inside of LADY GREY and outside of TOKO ONO.

TOKO ONO (N Parmar) - Made the junction onto the course proper awkwardly near the 850 metres.

HIGHLY ANTICIPATED (A Goindasamy) - Held up entering the final straight.

APHADON (T Moodley) - Raced greenly when placed in restricted room approaching the 300 metres between LADY GREY which shifted out, and TOBLERONE which shifted inwards. Both B Rogerson and C Grylls were advised to exercise care in similar circumstances. Improved onto heels over the concluding stages having to be steadied.
