RACE COMMENTS		
Race 1	FEILDING HOTEL MAIDEN 1600m	

TOUCH OF PARADISE (T Newman) - Underwent a pre-race veterinary inspection behind the barriers following an incident in the mounting yard and was passed fit to run.

MIYAZAWA (J Parkes) - Slow away. J Parkes reported that the mare had failed to handle today's heavy track conditions.

BLACK ORLOV (L Sutherland) - Slow away. Raced three-wide without cover.

THIRSTY (C Grylls) - Raced in restricted room passing the 400 metres.

COUNTRYMAN (M Hudson) - Rider reported the gelding had hung badly from the 800 metres.

BOOMTOWN BOY (J Riddell) - When questioned regarding performance rider advised that the gelding had been very disappointing and was unable to offer any excuse other than possibly failing to handle today's track conditions. A post-race veterinary examination did not reveal any abnormality.

Race 2 JAPAC HOMES 1100m

DUNEAGLE (L Kauri) - Ran wide crossing the junction onto the course proper from the 500 metres.

IVY DAZZLER (M Hudson) - Held up approaching the 400 metres and when shifting outwards to obtain clear running made contact with DAISY DAISY. Contacted near the 125 metres.

DAISY DAISY (L Sutherland) - Contacted near the 400 metres. Shifted inwards under pressure making contact with IVY DAZZLER near the 125 metres.

COOPER (T Newman) - Rider reported she felt there may be something amiss with the gelding. A post-race veterinary examination did not reveal any abnormality other than a small laceration in the left nostril.

DELPHINE (J Parkes) - Rider reported the mare had failed to handle today's track conditions.

SWAZI (J Riddell) - Rider reported the gelding had failed to handle today's track conditions.

Race 3 MANAWATU ITM 1200m

TANZANITE ROSE (C Butler) - Hampered leaving the barriers when IDYLLIC jumped outwards.

CANDLE (L Sutherland) - Inconvenienced near the 300 metres when PRIORESS shifted outwards under pressure. Shifted inwards when struck with the whip near the 200 metres, having to be corrected.

Race 4 INTOWIN.CO.NZ JOIN A SYNDICATE 1400m

DONNYBROOK (J Chung) - Jumped away awkwardly from the outside barrier, losing ground.

PEPPERY (M Hudson) - Jumped away awkwardly.

STIPULATOR (S O'Malley) - Slow away. Steadied for a distance when improving onto heels passing the 1200 metres. When questioned regarding performance rider advised the filly had failed to handle today's track conditions.

POPSAGOOSEY (N Parmar) - Hampered leaving the barriers, losing ground, when PLATINUM SIXTY SIX jumped outwards. Held up for a short distance near the 200 metres.

M Singh (MISS DIXIE) - Issued with a warning for his whip use on a runner out of contention.

Race 5 COURTESY FORD REDCRAZE BOWL 1400m

SANIBEL (K Hercock) - Slow to begin then further hampered when crowded, losing ground.

OLD TOWN ROAD (L Sutherland) - Raced three-wide without cover. When questioned regarding performance rider was unable to offer any excuse other than possibly feeling the effects of recent racing.

PUNTURA (L Douglas) - Held up rounding the final turn, having to be checked off heels near the 450 metres. Again, held up for a distance approaching the 300 metres and then failed to respond to its rider's urgings when obtaining clear running, giving ground and finishing last. When shown footage of his ride in the presence of the Apprentice Mentor, L Douglas confirmed that although held up rounding the final turn the gelding had not felt comfortable in today's track conditions and once obtaining clear running had been unable to quicken. A post-race veterinary examination did not reveal any abnormality.

COLORADO STAR (J Chung) - When questioned regarding performance rider advised that the gelding is better suited over more ground and would derive benefit from today's fresh up run.

FARAGLIONI (L Allpress) - Inclined to lay inwards over the final 200 metres.

Race 6 STOCK LINES TRANSPORT 1600m

BATTLE SECRET (L Allpress) - Jumped away awkwardly making contact with PIGNAN. Rider advised the gelding is now looking for more ground.

PIGNAN (J Doyle) - Contacted leaving the barriers. Steadied when having to avoid the heels of the weakening WHEELITIN near the 500 metres. When questioned regarding performance rider advised the filly had not felt entirely comfortable in today's track conditions but had been disappointing. Trainer L Latta advised the filly was likely now to be freshened. A post-race veterinary examination did not reveal any abnormality.

WINKLE BAY (C Butler) - Hung inwards in the final straight proving difficult to ride.

KING OF HEARTS (L Hemi) - Held up for a distance near the 400 metres before shifting outwards across the heels of DUNCAN CREEK to obtain clear running near the 200 metres.

Race 7

MODE TECHNOLOGY FEILDING GOLD CUP 2100m

QUEEN OF SPADES (J Doyle) - Jumped away awkwardly, then raced ungenerously in the early stages, getting its head up and making the first bend awkwardly.

BULLY BOY (M Hudson) - Raced wide throughout and was a beaten runner prior to entering the final straight, with the rider advising the gelding had failed to see out the distance in today's testing conditions.

N Parmar (CROSS ROADS) - Admitted a charge in that he struck his mount CROSS ROADS 8 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 11 November, until the conclusion of racing on Friday, 24 November, 9 national riding days. N Parmar is to continue to work with the Rider Skills Review Panel.

Race 8 RATANUI DEVELOPMENT COMPANY 2100m

THE BELVOIR (C Grylls) - Hampered leaving the barriers losing ground when PACE ATTACK jumped outwards.

BARZETTI (J Parkes) - Restrained to the rear after jumping from a wide barrier.

NUN SO BAD (J Chung) - Checked and blundered when crowded for room between MAGGIESCLAN and SUPER FLASH near the 1800 metres when both of those runners appeared to shift ground marginally with video footage of the incident being inconclusive.

MASSO (L Kauri) - When questioned regarding performance rider was unable to offer any excuse.
