<b>Race 1</b>	<b>HASTINGS – HEART OF HAWKE'S BAY PREMIER 1600m</b>
<p><b>MANOLO</b> (T Taiaroa) - Slow to begin.</p> <p><b>BADGERINGDAWITNESS</b> (J Chung) - Over-raced in the middle stages. Held up rounding the final turn.</p> <p><b>SLIPPER ISLAND</b> (M McNab) - When questioned rider was unable to offer any excuse, advising that the entire had travelled well until placed under pressure, when it had failed to respond. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p><b>ONE DREAM ONE SOUL</b> (L Allpress) - When questioned rider advised that the mare had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p><b>K Asano</b> (HOOTER) - Issued with a warning for his whip use, raising his arm above shoulder height, over the concluding stages.</p> <p><b>T Taiaroa</b> (MANOLO) - Admitted a charge in that she failed to ride her mount out fully to the finish when there was a reasonable chance of finishing in fifth placing, with the Adjudicative Committee imposing a fine of \$450.</p> <p>Track downgraded to Heavy 8 following Race 1.</p>	

<b>Race 2</b>	<b>BBQ GOURMET PREMIER MAAT 1300m</b>
<p><b>LATRELLE</b> (R Elliot) - Slow to begin.</p> <p><b>POPSAGOOSEY</b> (J Riddell) - Slow to begin.</p> <p><b>RED GRANDE</b> (L Sutherland) - Over-raced in the early and middle stages.</p> <p><b>FANCY LIKE LASS</b> (M McNab) - When questioned regarding performance M McNab advised that the mare had been quickly beaten when placed under pressure in the straight. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p>Track further downgraded to Heavy 9 following Race 2.</p>	

<b>Race 3</b>	<b>OAKLANE STABLES CHAFF PREMIER 1300m</b>
<p><b>EL VENCEDOR</b> (M McNab) - Jumped away awkwardly hampering OLD TOWN ROAD.</p>	

**OLD TOWN ROAD** (L Sutherland) - Hampered leaving the barriers.

**Race 4** | **NZB READY TO RUN SALE TRAINERS SERIES PREMIER 1200m**

**GEE STRING** (R Elliot) - Reared at the start, losing ground. Briefly steadied near the 500 metres. Eased down in the straight, finishing a distant last. When questioned rider was of the opinion the gelding may have held its breath and choked down in the running. Underwent a post-race veterinary examination and found to have suffered cardiac arrhythmia. Trainer S Brown was advised that GEE STRING will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of 1000 metres.

**PRIORESS** (J Riddell) - Restrained from a wide barrier draw to obtain cover. Came together with HOT SHOCKOLATE passing the 200 metres with those two runners again making contact passing the 100 metres.

**HOT SHOCKOLATE** (J Doyle) - Came together with PRIORESS passing the 200 metres and again passing the 100 metres.

**REIGN IT IN** (J Chung) - Restrained from a wide barrier draw to obtain cover.

**DUNEAGLE** (M Hashizume) - Hung outwards in the final straight.

**Race 5** | **AHD ANIMAL HEALTH DIRECT HAWKES BAY GUINEA S (G2) 1400m**

**OVERDRAWN** (V Colgan) - Jumped away awkwardly losing ground. Raced greenly throughout.

**CHANTILLY LACE** (L Sutherland) - Restrained from a wide barrier draw to obtain cover.

**LANTERN WAY** (J Riddell) - Restrained from a wide barrier draw to obtain cover.

**REZEKI** (K Asano) - Made contact with the running rail and was steadied when placed in restricted inside the heels of BURN TO SHINE (W Kennedy), which lay inwards near the 600 metres before being corrected by its rider. Hampered as a result was SOLIDIFY. W Kennedy was advised to exercise care.

**SOLIDIFY** (R Elliot) Hampered 600 metres.

**TOKYO TYCOON** (O Bosson) - When questioned regarding performance, rider was of the opinion that the gelding had been unable to quicken in today's testing track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**R Elliot** (SOLIDIFY) - Weighed in 0.8kg in excess of the weight at which he weighed out and was fined \$200 under the Minor Infringement Schedule.

**Race 6** | **COLLIERS COMMERCIAL HB PREMIER 1400m**

The start of this race was delayed approximately 2 minutes when ARCADIAN IYNX refused to load.

**ARCADIAN IYNX** (J Parkes) – Declared a late scratching at 3.26pm after refusing to load. Connections were advised ARCADIAN IYNX must barrier trial to the satisfaction of Stewards prior to racing next.

**PACE ATTACK** (J Chung) - Crowded shortly after the start, losing ground.

**SO SURREAL** (J Doyle) - Raced keenly when wide without cover until near the 700 metres. After returning to the enclosure with blood present in the nasal area underwent an endoscopic examination which was clear.

**GOHUGO** (C Grylls) - Held up in the straight until near the 300 metres.

**L Allpress** (DON PAULY) - Spoken to regarding her whip action inside the final 100 metres raising her arm above shoulder height.

**Race 7** | **ARROWFIELD STUD PLATE (G1) 1600m**

**CHASE** (S Spratt) - Reared at the start, losing ground.

**HE'S A DOOZY** (K Asano) - Crowded at the start.

**TIMES TICKING** (L Allpress) - Crowded leaving the barriers.

**MALT TIME** (V Colgan) - Steadied going into the first bend near the 1400 metres, then being inclined to over-race for a distance when being restrained. Inconvenienced near the 350 metres.

**MALI STON** (R Elliot) - Steadied off the heels of MALT TIME near the 1300 metres.

**SHARP 'N' SMART** (M McNab) - When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Co-trainer G Rogerson advised that the gelding would undergo further veterinary tests on return to his stable.

**PIER** (S Weatherley) - Crowded and dictated outwards near the 350 metres. Blundered passing the 300 metres.

**AROMATIC** (W Kennedy) - Crowded and checked near the 350 metres.

**JUSTASKME** (J Parkes) - Inconvenienced near the 350 metres.

**CAMPIONESSA** (O Bosson) - When questioned regarding performance rider could offer no excuse.

**J Riddell** (CALLSIGN MAV) - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of PIER which was dictated outwards onto AROMATIC which was checked near the 350 metres. Inconvenienced as a result were MALT TIME and JUSTASKME. After hearing submissions, the Adjudicative committee imposed a suspension of his licence to ride in races from the conclusion of racing today, Saturday, 30 September, until the conclusion of racing on Friday, 13 October, 8 national riding days and in addition imposed a fine of \$900.

**Trainer K Fawcett** (POLLY GREY) - Admitted a charge in that she failed to declare a rider for POLLY GREY by the required time. After hearing submissions, the Adjudicative Committee imposed a fine of \$400. POLLY GREY was ridden by M Hashizume.

**Race 8** | **BETTA INSPECT IT PREMIER 2000m**

**HIT THE ROAD JACK** (E Nicholas) - Slow to begin.

**KICK ON** (M McNab) - Raced wide without cover. When questioned rider had no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**Race 9** | **VILLA MARIA PREMIER 2100m**

**BELCAMINA** (S Weatherley) - Slow to begin then further hampered shortly after. Over-raced for a distance when being restrained shortly after the start.

**WANNABE 'N' VEGAS** (L Sutherland) - Had to be steadied to avoid the heels of RHODESIAN, which was taken in by LATE TO THE PARTY (V Colgan) near the 2000 metres. V Colgan was advised to exercise greater care.

**ROC UP RALPH** (M Hashizume) - Steadied to avoid the heels of WANNABE 'N' VEGAS, which was dictated inwards by SWINGIT OUR WAY (S Spratt), which shifted inwards to avoid the heels of LATE TO THE PARTY near the 1900 metres. S Spratt was advised to exercise greater care.

**FLAMENCO** (M McNab) - When questioned regarding performance rider had no excuse.

**O Bosson** (CANHEROC) - Admitted a charge in that he struck his mount CANHEROC seven times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.
