Race 5 BARFOOT & THOMPSON 1100

SCREAMIN EAGLE (R Elliot) – Trainer D Guy reported to Stewards the stables veterinarian has been monitoring the progress of the puncture wound to the left hind leg and advised that it is healing well. D Guy further advised that it is her intention to resume track work with SCREAMIN EAGLE next week.

RACE COMMENTS

Race 1 | **RUAKAKARACING.CO.NZ 2200**

BRIAN LAMONT (W Kennedy) - Jumped away awkwardly contacting WITHALLMYHEART. Raced keenly shortly after the start having to be steadied off the heels of CIAMBELLA.

WITHALLMYHEART (A Lawson-Carroll) - Contacted at the start.

CON ARTIST (S Spratt) – Steadied off the heels of STUNNING MAIRE near the 2100 metres. Raced keenly in the early stages.

CIAMBELLA (B Rogerson) - Held up entering the final straight.

J Doyle (STUNNING MAIRE) - Issued with a warning after permitting his mount to shift inwards when not fully clear of CON ARTIST which had to steady near the 2100 metres.

Race 2 | **THANKS TO OUR 2023 VOLUNTEERS MAIDEN 2200**

MATAI BAY (A Lawson-Carroll) – Contacted leaving the barriers. Hung inwards near the 1500 metres. Raced three wide without cover from near the 900 metres. Lay in when placed under pressure in the final straight. Faltered when racing free of interference just after the winning post dislodging its rider, hampering CANULOVEMEAGAIN which also dislodged its rider. MATAI BAY was immediately attended to by the oncourse veterinarian with the horse ambulance being deployed. The gelding was found to have suffered a compound fracture of the near foreleg with MATAI BAY being humanely euthanised. A Lawson-Carroll was attended to by the St John Ambulance personnel and cleared to ride. Stewards excused apprentice A Lawson-Carroll from weighing in under the provision of [Rule 647(1)].

TOSCA (J Doyle) - Slow to begin. Placed in restricted room when racing to the inside of MATAI BAY which hung inwards passing the 1700 metres making contact with the running rail.

BIG RAJ (J Whiteside) - Raced keenly in the early stages. Made the crossing awkwardly near the 1700 metres hampering CANULOVEMEAGAIN which was forced wider on the track.

CANULOVEMEAGAIN (M Cameron) - Hampered and forced wider near the 1700 metres. Raced wide in the early stages before being allowed to stride forward to lead passing the 1200 metres. Hampered by the riderless horse just after the winning post dislodging its rider. M Cameron was attended to by the St John Ambulance personnel and cleared to ride.

TERRYSAWUS (T Abel) - Steadied approaching the 1200 metres.

Race 3 | **LION RED MAIDEN 1100**

DE NADA (T Newman) - Became fractious in its barrier prior to the start being affected. Connections were advised a warning would be placed against the mare's barrier manners. Raced wide without cover throughout.

FIRST FIVE EIGHT (J Fawcett) - Slow to begin (3L). Rider reported that the gelding raced greenly throughout.

INCANTO GOLD (S Spratt) – Raced three wide without cover throughout. Lay out when placed under pressure in the final straight.

SHANELLA (J Doyle) – Hung outwards throughout. When questioned regarding the performance the rider advised that the mare failed to handle today's track conditions.

NEVER FORGOTTEN (W Kennedy) - Improved onto heels having to be steadied near the 700 metres. When questioned regarding the performance the rider could offer no explanation.

OVERSTATE (M Hashizume) - Hung outwards making the bend awkwardly near the 700 metres. Briefly steadied near the 75 metres to avoid the heels of **INCANTO GOLD** which was laying in.

D Wiles (JUSTICE) - Issued with a minor infringement and fined \$50 for presenting JUSTICE to race without the notified visor blinkers.

COMPLIMENTERRY (V Jalalkuncha) - Slow to begin.

ELECTRIC DREAM (T Newman) - Knuckled leaving the barriers then contacted. Raced three wide without cover throughout.

LIVING IN HOPE (A Goindasamy) - Jumped outwards at the start contacting **ELECTRIC DREAM**. Raced keenly in the early stages.

ROYAL TSARINA (A Lawson-Carroll) - Began awkwardly losing ground.

VALLARTA (W Kennedy) - Began awkwardly losing ground.

ATLANTIC CHARM (M Hashizume) – Improved onto heels having to be steadied near the 900 metres.

GLAMOUR TYCOON (S Spratt) – Ducked away from the running rail near the 200 metres.

ERASE (J Whiteside) – Lost the right front plate during the running.

V Jalalkuncha (**COMPLIMENTERRY**) - Issued with a warning for using his whip on a runner that was out of contention with Stewards taking into account his clear recent record with regards to a breach of this rule.

Following this race M Cameron was stood down from his remaining rides with a recurring injury. M Cameron was advised a medical clearance would be required prior to riding next.

DANGEROUS COMPANY (C Barnes) - Reared as the start was affected losing ground.

SHIRAZELLE (M Hashizume) - Lay in making contact with **BRUCEY LEE** for a stride approaching the 800 metres.

BRUCEY LEE (L Satherley) – Contacted for a stride approaching the 800 metres.

GIBRALTAR RISING (B Rogerson) – Over-raced through the middle stages having to be steadied off heels approaching the 800 metres.

GLITZAL (W Kennedy) - Held up for clear running inside the final 100 metres.

Race 6 FIRECO – FIRE SAFETY & BUILDING COMPLIANCE MAIDEN 1400

POSITIVE POWER (H McNeill) - Slow to begin.

IVANA TRUMPALOT (A Lawson-Carroll) - Began awkwardly losing ground. Improved onto heels having to be steadied near the 800 metres. When questioned regarding the performance the rider advised that the gelding had hung outwards throughout.

HASSTOBEAWINNER (J Doyle) - Lay out early in the final straight having to be corrected by its rider.

FIRST FIVE (L Satherley) - Shifted outwards when struck with the whip near the 250 metres hampering ENDEAN ACE and MARGALIT.

THEE AULD MINX (T Newman) - Hampered near the 250 metres.

MARGALIT (S Spratt) - Hampered near the 250 metres. When questioned regarding the performance the rider advised that the mare was unsuited by today's track conditions.

Race 7 NORTHLAND BUSINESS SYSTEMS 1400

SUPER TIME (W Kennedy) - Removed from the barriers to undergo a pre-race veterinary examination after becoming fractious and was cleared to start. Connections were advised a warning would be placed against the gelding's barrier manners. Began awkwardly losing ground. Over-raced through the middle stages having to be steadied off heels. Shifted outwards passing the 50 metres unbalancing its rider who briefly lost the use of his left iron.

MYLA (A Lawson-Carroll) - Began awkwardly losing ground. Held up for clear running early in the final straight.

POZZI VIBE (H McNeill) - Raced three wide without cover throughout. Came together with NO AGENDA NIGEL near the 200 metres.

PIPPY (A Goindasamy) - Held up for clear running early in the final straight and again had difficulty obtaining clear running until approaching the 100 metres.

NO AGENDA NIGEL (J Doyle) – Came together with POZZI VIBE near the 200 metres.

TOUGH TEST HARRY (T Newman) - When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 8 5 JAN TRIGG FAMILY FUN RACEDAY 1600

THE SPRINKLER (A Goindasamy) - Began awkwardly.

PAHI LASS (M Hashizume) - Slow to begin. When questioned regarding the improved performance trainer advised that the mare appreciated the addition of blinkers.

KHAFRE (S Spratt) - Raced greenly over the junction prior to joining the course proper.

CHAMPAGNES ON ME (B Rogerson) - Shifted out and away when awkwardly placed close to the running rail approaching the 1200 metres.

CIMARRON (H McNeill) – Raced wide without cover throughout.

MUSE (A Lawson-Carroll) – Improved onto heels having to be steadied passing the 700 metres.

FAY KHAN IT (O Bosson) – Lay outwards rounding the final bend. When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

STRINGLINE (L Satherley) - Raced in restricted room near the 200 metres.

H McNeill (CIMARRON) – Issued with a warning after being unable to claim his full allowance.
