#### **RACE COMMENTS**

#### Race 1 ARAWA PARK HOTEL MAIDEN 1950

**AN SO IT BE** (H McNeill) - Bucked during its preliminary dislodging the rider who was injured. H McNeill was attended to by St John Ambulance personnel and stood down from his remaining rides with AN SO IT BE being declared a late scratching at 12.36 pm. H McNeill was advised a medical clearance would be required prior to riding next.

ROC ANTHEM (L Satherley) - Began awkwardly.

**SALVIN** (B Jacobson) - Slow to begin.

**FIFTY SHADES** (T Newman) – Restrained in the early stages to obtain cover after jumping from the outside barrier.

**LITTLE MISS WONDER** (S Spratt) - Crowded at the start having to be steadied. Had to be steadied off heels over the concluding stages when TIZ LOUIE and GEETEE FORTY both shifted ground.

SHIRAZELLE (J Chung) - Raced keenly through the early and middle stages when leading.

**OHTANIE ROSE** (L Sutherland) – Raced wide throughout.

**GEETEE FORTY** (D Danis) – Raced keenly through the middle stages. Lay outwards when placed under pressure over the concluding stages.

**TIZ LOUIE** (R Elliot) – Raced three wide without cover through the early stages. Lay in when placed under pressure over the concluding stages.

**SQUIRE** (M Hashizume) - Gave ground from the 700 metres and finished a distant last. When questioned, rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities.

**POLAMALU** (M McNab) – When questioned regarding the performance rider advised that the gelding was one paced and failed to quicken when placed under pressure.

**B Jacobson** (SALVIN) - Issued with a warning for using his whip on SALVIN with an action which raised the rider's arm above shoulder height with Stewards taking into account his clear recent record with regards to a breach of this rule.

# Race 2 SHERLOCK CONTRACTING MAIDEN 1230

ALL FIRED UP (L Sutherland) - Slow to begin. Over-raced through the early and middle stages.

PERMISSIVE (B Jacobson) - Slow to begin.

**DEFLATION** (C Barnes) - Began awkwardly.

**SALLY** (J Fawcett) - Raced wide through the early stages.

**LISE PAREE** (A Lawson-Carroll) - Over-raced through the early stages. Lay inwards when placed under pressure in the final straight. Improved onto the heels of a weakening runner passing the 100 metres. Apprentice rider A Lawson-Carroll was advised to exercise greater care in similar circumstances. Returned to the enclosure with blood in the mouth. Underwent a post-race veterinary examination which revealed a small laceration to the inside of its mouth.

**PHARAOH'S DREAM** (M Cameron) - Hung outwards throughout. Underwent a post-race veterinary examination which revealed a small laceration to the right hind leg and superficial swelling to the flexor tendon which were treated. Stewards will follow up on the post-race condition of the filly with trainer A Forsman in the coming days.

Following this race, the track was upgraded to Soft 7.

#### Race 3 HAVE YOUR FUNCTION AT ARAWA PARK MAIDEN 1230

**MOLDY** (L Sutherland) - Slow to begin then crowded shortly after losing ground.

MARKET PLACE (J Fawcett) - Jumped away awkwardly crowding MOLDY.

**OVERRATED** (L Satherley) - Slow to begin then hampered when SOUL QUEEN shifted inwards.

**SOUL QUEEN** (S Spratt) – Shifted inwards at the start hampering OVERRATED which blundered losing ground. Overraced through the early stages. Lay inwards when placed under pressure in the final straight.

**SHAWSHANK** (J Doyle) – Lay out early in the final straight when placed under pressure.

## Race 4 MACMILLAN ACCOUNTANTS 1230

**LADY MAK** (J Fawcett) - Jumped inwards abruptly at the start hampering LUXURIANT. Held up for clear running until near the 100 metres.

**LUXURIANT** (M McNab) - Became fractious in the barrier prior to the start being effected. Hampered at the start by LADY MAK losing ground.

**MADIRAN** (S Spratt) - Held up early in the final straight.

# Race 5 CAMPBELL INFRASTRUCTURE MAIDEN 1400

**COMMANDING ASPECT** (K Asano) – Knuckled at the start.

**RUAHEI** (B Rogerson) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

**PART TIME LOVER** (M Cameron) - Slow to begin. Raced keenly through the early and middle stages. Stewards questioned rider M Cameron regarding the tactics adopted through the middle stages of the race. M Cameron advised that the mare which was having her second race day start had over-raced through the middle stages when amongst other runners. M Cameron believed his best option for the mare to relax, and settle was to restrain and follow FORTUNATE SON. After consideration of M Cameron's explanation, viewing the replays and taking into account the racing manners of the mare, Stewards accepted that the tactics adopted were reasonable given the circumstances.

**FORTUNATE SON** (O Bosson) – Raced wide without cover through the early and middle stages.

**AUGUSTA** (L Sutherland) – Over-raced through the early stages.

**SHORT** (W Kennedy) - Held up for clear running early in the final straight.

# Race 6 ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1400

CADA CAMINO (B Rogerson) - Slow to begin. Held up for clear running early in the final straight.

**SAVAGE LOVE** (S Spratt) - Slow to begin. Raced wide throughout.

SHE WROTE MORE (J Doyle) - Restrained in the early stages to obtain cover after jumping from an outside barrier.

**TOKO ONO** (O Bosson) - Over-raced through the early and middle stages.

**GOLD DIGGER** (G Lahoud) – Raced three wide without cover throughout.

**CHARLBURY** (L Satherley) - Checked passing the 150 metres.

**COMPOSURE** (S Weatherley) – Held up for clear running until passing the 150 metres.

**LADYLOU** (M Cameron) - When questioned regarding the performance rider advised that in his opinion the filly was reluctant to hit out when racing in tight quarters. Underwent a post-race veterinary and endoscopic examination which revealed no abnormalities.

**O Bosson** (TOKO ONO) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when insufficiently clear of CHARLBURY which was checked passing the 150 metres. After considering submissions the Adjudicator imposed a suspension of O Bosson's licence to ride in races from the conclusion of racing on Wednesday 29 November up to and including racing on Friday 8 December, 6 national riding days.

## Race 7 GREENLIGHT INSURANCE BROKERS 1400

MISTER PUCCI (K Asano) - Slow to begin.

**MARMAC BOY** (M Cameron) - Raced keenly through the early stages before improving forward to settle outside the leader near the 800 metres. Hampered and forced inwards near the 150 metres.

**KHUTULUN KHAN** (S Weatherley) – Held up early in the final straight before having to be checked out of a run near the 150 metres.

A Lawson-Carroll (DROP OF SOMETHING) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of MARMAC BOY which was hampered and forced into the line of KHUTULUN KHAN which was checked near the 150 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 25 November up to and including racing on Friday 8 December, 7 national riding days.

## Race 8 LANCE LAWSON 1400

FLIGHT PLAN (A Lawson-Carroll) - Slow to begin.

**SUPER WRAITH** (L Sutherland) - Raced three wide without cover throughout.

**HAYATE** (M McNab) – Raced keenly through the middle stages.

**IMARICHGIRL** (O Bosson) – When questioned regarding the performance rider could offer no explanation.

# Race 9 DUNSTAN HORSE FEEDS STAYERS CHAMPIONSHIP QUALIFIER 1950

IFFIE SHOWS (A Lawson-Carroll) - Slow to begin then crowded shortly after losing ground.

LIL RED'EYEDNHOOD (J Allen) – Jumped outwards at the start crowding IFFIE SHOWS.

**TASER** (L Satherley) - Began awkwardly then crowded shortly after losing ground. Raced keenly in the early stages.

**IRRIGATE** (J Doyle) - Slow to begin. Improved onto heels having to be steadied just prior to the finish line.

LOGAN'S LOGIC (R Elliot) - Slow to begin.

**SKAI JACKI** (K Asano) - Over-raced through the early and middle stages placing its rider at a disadvantage.

**THE LETTER** (S Spratt) - Raced wide in the early stages before improving forward to settle outside the leader near the 1100 metres.

AFTER PARTY (O Bosson) - Raced three wide without cover from near the 1100 metres.

**HOOTER** (J Chung) - Shifted across the heels of LOGAN'S LOGIC near the 200 metres.

**FORTUNE WINGS** (A Goindasamy) - Rider reported that the gelding had felt indifferent in its action. Underwent a post-race veterinary examination which revealed no abnormalities.
