Race 7 ARROWFIELD STUD PLATE (G1) 1600m

SHARP 'N' SMART (M McNab) – Stewards completed the follow up for SHARP AND SMART, with Mr. G Rogerson advising the gelding has been having a freshen up and further advised that SHARP 'N' SMART'S recent blood tests were clear, and the gelding will resume track work shortly.

Race 2 WATER BAR NAPIER PREMIER 2200m

BELCAMINA (S Weatherley) – Trainer Mr. G Lowry advised Stewards he was satisfied with the post-race condition of the mare, however, has been retired from racing and will be sent to stud.

RACE COMMENTS

Race 1 | **CRYSTAL SHINE GLASS MAIDEN 2200m**

THINK AHEAD (J Parkes) - Became fractious in its barrier, becoming cast and was declared a late scratching at 12.36pm after undergoing a veterinary examination. Connections were advised the gelding will now require a veterinary clearance and must barrier trial to the satisfaction of Stewards prior to racing next.

All loaded runners were removed from their barriers.

SUBTLE IMAGE (L Sutherland) - When being removed from its barrier became fractious and underwent a veterinary examination after being removed from its barrier and was declared a late scratching at 12.36pm after showing signs of lameness in the left hind leg. Connections were advised the gelding will require a veterinary clearance prior to racing next.

UNCLE BRUCE (L Hemi) - Underwent a veterinary examination after being removed from its barrier and was declared a late scratching at 12.36pm due to having blood present in the nostrils consistent with coming into contact with its barrier.

The race started approximately 10½ minutes late due to the above.

DANZINO (C Dell) - Began awkwardly, shifting out abruptly shortly after the start, dictating runners to its outside wider on the track. Raced wide through the early stages. Lay outwards rounding the final bend making brief contact with POLAMALU and forcing that runner wider in the track.

MUGSHOT (C Grylls) - Dictated wider shortly after the start and as a result lost ground.

SKY CRUZA (C Barnes) - Blundered at the start. Hung outwards into the first bend, running wider.

POLAMALU (L Allpress) - Began awkwardly, then becoming awkwardly placed on the heels of EL ATTITUDE, having to be steadied and as a result lost ground. Raced three-wide without cover from the 900 metres. Briefly contacted and forced wider near the 375 metres.

EL ATTITUDE (C Lindsay) - Restrained behind runners to obtain cover shortly after the start.

FOXALOT (K Hercock) - Over-raced through the early and middle stages.

CHECKPOINT CHARLIE (M Hudson) - Raced keenly through the early and middle stages.

Race 2	PAEWAI MULLINS SHEARING MAIDEN 1200m

The start time for Race 2 was amended to 1.12pm.

SWISS BELT (B Grylls) - Late scratching at 1.07pm after dislodging its rider in the preliminary and then undergoing a veterinary examination and was found to be lame in the left foreleg. Connections were advised SWISS BELT requires a veterinary clearance prior to racing next. Rider B Grylls was uninjured.

FRENCH DOLL (J Chung) - Began awkwardly, shifting outwards at the start, having to be corrected by its rider.

CHAMPAGNE LINDA (C Barnes) - Slow to begin. Lay outwards under pressure throughout the final straight.

PLATINUM DESIGNS (J Doyle) - Began awkwardly, making brief contact with BETTERBEYOU. Raced three-wide without cover throughout.

BETTERBEYOU (C Butler) - Contacted at the start, losing ground, and was then ridden with urgency to recover. Rider reported the filly had raced greenly throughout the final straight.

NAVY BRIDE (L Sutherland) - Restrained behind runners shortly after the start to obtain cover.

THE ENTERTAINER (M Hudson) - Began awkwardly, briefly unbalancing its rider. Raced keenly through the early and middle stages. Going into the first bend was placed in restricted room and when being steadied got its head up in the air.

CHERISHED LADY (C Lindsay) - Had to shift ground inwards approaching the 100 metres to obtain clear running.

Race 3	SHANE BROWN RACING – GO HAWKE’S BAY! MAIDEN 1200m

COMPLEX (M Hudson) - Declared a late scratching at 1.42pm by Stewards after becoming fractious in its barrier, rearing up and escaping over the side of the barrier, galloping some distance prior to being recaptured. Underwent a post-race veterinary examination which revealed the gelding to have superficial lacerations to both hind legs. Connections were advised COMPLEX must barrier trial to the satisfaction of Stewards prior to racing next.

JOHNNY BOY (B Grylls) - Late scratching at 1.46pm, after refusing to load. Connections were advised JOHNNY BOY must barrier trial to the satisfaction of Stewards prior to racing next.

CHEVEAUX (J Doyle) - Slow to begin. Held up rounding the final bend.

SHEZ OOHLAHLAH (C Grylls) - Began awkwardly, briefly unbalancing its rider, losing ground.

MAN EXPRESS (L Allpress) - Shifted ground outwards shortly after the start, crowding its outside runners.

PROISSTAR (K Hercock) - Contacted at the start and was then crowded, losing ground. Raced three-wide without cover throughout.

ARDROE (J Riddell) - Began awkwardly, crowding inside runners.

CRUNCHIE BOY (L Sutherland) - Began awkwardly, making contact with PROISSTAR, and was then crowded when MAN EXPRESS shifted ground. Lay outwards rounding the final bend.

LA ROJA (C Barnes) - Held up rounding the final bend and throughout the final straight and was unable to obtain clear running until the 150 metres. Rider reported the gelding had hung inwards throughout the final straight.

WAZA DREAM (C Dell) - Had to steady after improving onto the heels of PROISSTAR when angling outwards to find clear racing room approaching the 150 metres.

LITTLEREDCORVETTE (L Douglas) - Blundered at the start.

THATZ DAISY (M Singh) - Slow to begin. When racing keenly, improved on to heels, having to be steadied passing the 1000 metres.

KNICKERLESS (J Doyle) - Slow to begin. Held up rounding the final bend and the early stages of the run home.

GURTLYN (T Bau) - Began awkwardly, losing ground.

OFF TO THE NUNNERY (L Hemi) - Began awkwardly, getting its head up in the air and as a result lost ground.

ANDIT HURTS (M Hudson) - Restrained behind runners to obtain cover shortly after the start.

Race 5	THE MEAT COMPANY DANNEVIRKE MAIDEN 1400m

VERRY ROYAL (C Butler) - Slow to begin.

MOLASSES (C Barnes) - Began awkwardly, making contact with WROE AND SALEE. Over-raced through the early and middle stages.

WROE AND SALEE (L Allpress) - Contacted at the start. Raced keenly through the early and middle stages.

CHEVAL DE FOUDRE (C Carmine) - Slow to begin. Raced keenly through the early and middle stages. When questioned C Carmine advised the gelding raced greenly throughout and shifted inwards in the home straight, having to be straightened when struck with the whip inside the final 100 metres.

BEAVERTOWN (M Hudson) - Slow to begin.

HELLO CUPID (J Parkes) - Slow to begin.

DEADLY PONY (C Dell) - Restrained behind runners to obtain cover shortly after the start.

NASSAU (J Doyle) - Raced keenly through the early and middle stages.

RECOMMENDHER (K Hercock) - Over-raced through the early and middle stages.

GREY INVADOR (J Chung) - Raced in restricted room in the early part of the home straight and was denied a run when NICK (M Singh) shifted in abruptly near the 200 metres. M Singh was shown footage of his ride and advised to exercise greater care. Continued to race greenly over the final stages.

I DON'T (C Grylls) - When questioned regarding performance rider could offer no excuse.

Race 6 | **JOHN SHANNON MEMORIAL 1600m**

ORLOV (L Allpress) - Broke through its barrier and was quickly pulled up by its rider. Underwent a veterinary examination and was cleared to start. Slow to begin. Raced three-wide without cover throughout.

CHIKIRA LASS (J Doyle) - Slow to begin.

SIR BEETS (J Chung) - Slow to begin.

ILLUSION OF PARIS (K Hercock) - Began awkwardly losing ground.

QUEEN OF SPADES (J Parkes) - Lay outwards under pressure throughout the final straight, having to be corrected by its rider on a number of occasions.

JAY BEE GEE (M Hudson) - Raced keenly through the early and middle stages.

Race 7 | **CD MILKING SHORTHORN 100 YEARS 1600m**

RIP US OFF (J Parkes) - Slow to begin. Became detached from the field from near the 900 metres and was not persevered with over the final stages when J Parkes considered there may be something amiss with the gelding. Underwent a subsequent veterinary examination, which did not reveal any obvious abnormality. Connections were advised RIP US OFF is required to trial to the satisfaction of Stewards prior to racing next. Trainer A Fieldes advised Stewards the gelding would now be sent for a spell.

UNSCRIPTED (C Dell) - Slow to begin.

ALBUFEIRA (M Hudson) - Slow to begin.

BOURBON FALLS (J Riddell) - Slow to begin. Raced three-wide without cover throughout. Had a tendency to lay inwards under pressure in the final straight.

PACE ATTACK (J Chung) - Raced wide without cover through the early and middle stages.

Race 8 | **WPRC COMMITTEE MILE MAIDEN 1600m**

PEGAU (J Doyle) - Slow to begin. Held up rounding the final bend and the early stages of the final straight.

YELSERP (C Lindsay) - Slow to begin.

ALMALANE (J Parkes) - Slow to begin.

BOOMTOWN BOY (J Riddell) - Slow to begin. Held up rounding the final bend and through the early stages of the final straight.

ALL OVER NOW (L Hemi) - Restrained behind runners to obtain cover shortly after the start.

IFFIDAPUNT (C Grylls) - Restrained behind runners to obtain cover shortly after the start.

WALKINTHEPARK (J Chung) - Raced wide without cover through the early stages before being allowed to improve forward to sit outside the leader near the 900 metres.

ALL OVER NOW (L Hemi) - Raced keenly through the early and middle stages.

BILLY EASTON (L Allpress) - Denied a clear run and checked off the heels of KAWATIRI approaching the 300 metres when both BILLY EASTON and BOOMTOWN BOY (J Riddell) were attempting a narrow run. After questioning riders, Stewards were satisfied that neither rider was at fault and no further action was required. Hampered 300 metres.

KAWATIRI (C Barnes) - Shifted out abruptly passing the 300 metres hampering BILLY EASTON and EXTROVERT.

EXTROVERT (L Sutherland) - Hampered 300 metres.
