## SUPPLEMENTARY

Waikato Thoroughbred Racing @ Cambridge Synthetic, Wednesday 24 July 2024 Race 7 MARTIN COLLINS NEW ZEALAND MAAT 2000m

**THE CHOSEN TOSEN (J Doyle)** – Stable representative Mr. R Mildon advised Stewards, the stable was satisfied with the post-race condition of the filly, however, THE CHOSEN TOSEN has been sent for a spell.

RACE COMMENTS

Race 1 AZTECH SIGNS MAIDEN 1400

Trainer **S Ralph** (MONIQUE TONNERRE) – Fined \$50 under the Minor Infringement Schedule for the late declaration of a rider.

**MISTA STITCH** (L Sutherland) - Slow to begin.

MIDNIGHT MONARCH (C Grylls) - Shifted across heels to avoid a weakening runner near the 450 metres.

**MONIQUE TONNERRE** (R Goyaram) - Shifted out slightly crowding DIVINE ESSENCE on to STONE OF DESTINY which had to be firmly restrained near the 450 metres. R Goyaram was advised to exercise greater care in similar circumstances.

**STONE OF DESTINY** (T Newman) - Had to be firmly restrained when weakening near the 450 metres.

**DIVINE ESSENCE** (J Fawcett) - When questioned regarding the improved performance co-trainer M Murdoch advised that the mare had benefitted from the addition of ear covers.

J Fawcett (DIVINE ESSENCE) - Issued with a warning after permitting her mount DIVINE ESSENCE to shift into a marginal run to the outside of MONIQUE TONNERRE which then shifted out slightly crowding DIVINE ESSENCE on to STONE OF DESTINY which had to be firmly restrained near the 450 metres. Also contributing to this incident was some inward movement from LED A MERRY DANCE.

Race 2 GARTSHORE CONSTRUCTION (1400m)

KORO'S PRINCESS (D Cooper) - Slow to begin. Briefly held up rounding the final bend.

WHOSHE'S GIRL (L Sutherland) - Raced three wide without cover throughout.

**APACHE BOY** (M Hashizume) - When questioned regarding the performance rider advised that the gelding had failed to respond when placed under pressure in the final straight.

**KEY LARGO** (J Nishizuka) - When questioned regarding the performance rider advised that the gelding had made abnormal breathing noises during the running. A post-race Veterinary and endoscopic examination revealed some mucus in the trachea. Stewards will follow up on the post-race condition of the gelding in the coming days.

 Race 3
 CONTRIBUTER STANDING AT MAPPERLEY STUD 1400

WHISKEY N' RYE (M Sanson) - Began awkwardly making contact with EMBEZZLER.

MONKHANA (C Barnes) - Slow to begin.

**EMBEZZLER** (A Lawson-Carroll) - Slow to begin then hampered shortly after losing ground.

**SILVER JAVELIN** (S Mxothwa) - Slow to begin. When questioned regarding the performance rider advised that the mare had made abnormal breathing noises during the running. A post-race Veterinary and endoscopic examination revealed some mucus in the trachea. Stewards will follow up on the post-race condition of the mare in the coming days. Rider S Mxothwa was shown the replays in the presence of L Innes and N Harris for educational purposes.

**CARDINAL QUEEN** (J Allen) - Raced keenly through the early and middle stages.

**RUACH** (B Jacobson) - Lay outwards when placed under pressure near the 200 metres having to be corrected by its rider.

**THIS LITTLE LIGHT** (S Spratt) - Lay outwards when placed under pressure near the 200 metres having to be corrected by its rider.

## Race 4 ULTIMATE MAZDA 3YO MAIDEN 1200

**SAKURA ROSE** (M Hashizume) - Proved difficult to load into the barriers causing a delay to the start. Trainer S Crawford was advised a warning was placed on the filly's barrier record. Raced three wide without cover throughout.

**BONNIE GEM** (S Spratt) - Lay outwards when placed under pressure near the 100 metres briefly inconveniencing DANCIN IN THE DARK.

DANCIN IN THE DARK (C Barnes) - Briefly inconvenienced near the 100 metres.

**IMPRESSIVE BELLE** (T Newman) - Rider advised that in her opinion the filly would benefit from the addition of a tongue tie.

**FRANCHETTI** (A Lawson-Carroll) - When questioned regarding the performance rider advised that he was disappointed with the filly's effort and could offer no explanation.

**T Newman** (IMPRESSIVE BELLE) - Admitted a charge in that she struck her mount IMPRESSIVE BELLE 6 times prior to the 100 metres with a further 5 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of Miss Newman's licence to ride in races from the conclusion of racing on Wednesday 7 August until the conclusion of racing on Friday 9 August 2024, 2 national riding days, and in addition imposed a fine of \$500.

### Race 5 FOOD 101 1200

There was a delay to the start of this race due a member of the public walking their dog near the 1600 metres.

**PARISIAN** (B Rogerson) - Ducked its head just prior to the start being effected and as a result began awkwardly losing ground.

SUMMIT HEIGHTS (M Sanson) - Slow to begin.

**MADIRAN** (S Spratt) - When questioned regarding the performance rider advised that the mare had failed to respond when placed under pressure in the final straight. A post-race Veterinary examination revealed no abnormalities.

Race 6 ARMORY STAN

### ARMORY STANDING AT MAPPERLEY STUD 2100

**SASSY LASS** (W Kennedy) - Crowded shortly after the start losing ground.

AMAZING GRACE (S Spratt) - Crowded shortly after the start losing ground.

ATA RANGI (T Moodley) - Improved on to heels having to be steadied near the 1200 metres.

JACK IN THE BOX (J Allen) - Raced three wide without cover throughout.

KAHMA SUITSYA (J Fawcett) - Rider reported that the mare had hung outwards throughout.

**T Moodley** (ATA RANGI) - Issued with a warning in that he used his whip on one occasion near the 100 metres with an action which raised the rider's arm above shoulder height.

### Race 7 HAPPY HIRE 2100

**WHAT A CHARMA** (N Hailey) - Dislodged its rider during the preliminary and was captured a short distance later, being found to have broken gear and was declared a late scratching at 2.53pm.

**PRINCESS ADDA** (B Jacobson) - Slow to begin. Became detached from the body of the field through the early stages despite the efforts of its rider.

**PATSYS LAD** (J Fawcett) - Lay inwards making contact with the running rail near the 950 metres losing ground and became awkward in its action for a distance.

POLAMALU (M Sanson) - Raced keenly through the middle stages.

KHUTULUN KHAN (T Newman) - Lay outwards when placed under pressure in the final straight.

**MR FANTASTIC** (M Hashizume) - When questioned regarding the performance rider reported the gelding had hung outwards throughout.

### Race 8 BACK TO BLACK MAIDEN 2100

VIRAGO TEASE (S Brown) - Began awkwardly losing ground.

**TELLEMALIE** (A Lawson-Carroll) - Slow to begin.

**TIMBA** (J Doyle) - Knuckled on two occasions near the 1500 metres. Rider J Doyle expressed concerns regarding the footing rounding the bend near the 1500 metres.

**THE REPUBLICAN** (R Goyaram) - When questioned regarding the performance rider advised that the gelding failed to handle today's heavy track conditions. Connections advised it was their intention for the horse to be sent for a spell.

Following the running of this race rider J Doyle (TIMBA) expressed concerns regarding the safety of the track rounding the bend near the 1500 metres. A Track Safety Review consisting of Stewards, Club Officials and Riders was convened. Following a track inspection and a subsequent meeting of all riders it was agreed by all present that it was safe to continue racing.

Race 9 TEAM WEALLEANS MAIDEN 2100

ENDEAN ACE (B Jacobson) - Raced keenly through the early stages.

**TE AROHA BOY** (L Sutherland) - Raced keenly through the early stages. Rider dropped her whip passing the 150 metres.

**CANULOVEMEAGAIN** (M Hashizume) - When questioned regarding the performance rider advised that the gelding failed to handle today's heavy track conditions.

WHOSHE'S BOY (T Newman) - Over-raced through the middle stages causing its rider some difficulty for a distance.

**B Jacobson** (ENDEAN ACE) - Admitted a charge in that he used his whip on two occasions in the final straight with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicative Committee imposed a fine of \$350.

THE KEHUA (J Nishizuka) - Began awkwardly losing ground.				

LA GRANGE (B Jacobson) - Slow to begin.

**DEMBE** (J Doyle) - Slow to begin. Lay outwards when placed under pressure in the final straight.
