GENERAL

J Fawcett (BLUEGRASS DIXIE) - Advised Stewards on the morning of the races she would be unable to take her ride in Race 9 due to flight changes. J Fawcett was replaced on her mount by Y Atchamah due to no suitable senior rider being available. Due to a communication error between the Racing Bureau and the TAB the rider change was for a short time incorrectly displayed as N Parmar.

RACE COMMENTS

Race 1 WET & FORGET MAIDEN 2200m

PINX (T Jonker) - Slow to begin.

SPEEDRUN (K Mudhoo) - Restrained from a wide draw to obtain cover shortly after the start.

MOUSSAIEFF (D Cooper) - Held up rounding the final bend only obtaining clear racing room passing the 250 metres.

RACCOURCI (Y Atchamah) - Held up early in the run home only obtaining clear racing room passing the 300 metres.

UHTRED (A Goindasamy) - When questioned regarding performance, rider advised that the gelding had had a good run in front but when asked to improve had failed to respond.

Race 2 CAVELL LEITCH MAIDEN 1600m

BRUSSET (Y Atchamah) - Slow to begin. Held up rounding the final bend only obtaining clear racing room passing the 300 metres.

LET'S GO (A Goindasamy) - Slow to begin. Over raced throughout the back straight.

PING (K Mudhoo) - Over raced through the middle stages.

CAPTAIN UPHAM (K Kwo) - Lay out badly rounding the final bend shifting wider having to be corrected throughout the run home. Connections were advised that CAPTAIN UPHAM is required to trial to the satisfaction of a Stipendiary Steward prior to racing next.

INGENIOUS (A Balloo) - Not persevered with in the run home, with the rider advising that the mare had hung inwards throughout proving a difficult ride. A post-race veterinary examination did not reveal any obvious abnormality. Trainer D Frye advised that INGENIOUS will now be sent for a spell.

Race 3 KENDAL DAWSON MAIDEN 1400m

JADE (D Tait) - Slow to begin.

HERE I AM (W Kennedy) - Over raced through the middle stages. Raced three wide without cover from the 900 metres.

PERSONA (K Bakker) - Lay out rounding the final bend becoming awkwardly placed on the heels of HERE I AM having to be steadied for some distance.

LOOSE KNICKERS (B Murray) - Steadied passing the 300 metres when LUV ROSAY (J Fawcett) shifted outwards to find clear racing room. J Fawcett was advised to exercise greater care when shifting ground.

LUV ROSAY (J Fawcett) - Briefly held up passing the 300 metres having to shift ground outwards.

OUR BRAVEHEART (T Moseley) - Rider could offer no tangible excuse for the disappointing performance.

Race 4 ADROY CAPITAL MAIDEN 1200m

RAGHALLAIGH (B May) - Slow to begin. Lay inwards under pressure over the concluding stages having to be straightened.

EL FUEGO (L Hemi) - Slow to begin. Lay outwards rounding the final bend.

WEST VIRGINIA (B Murray) - Raced three wide without cover throughout.

LA CERVEZA (A Goindasamy) - Lay outwards throughout the run home.

MIRAQUA (A Balloo) - Had trouble obtaining clear running for the majority of the run home only gaining clear racing room inside the final 100 metres.

LEAR JET (N Parmar) - Crowded when tiring near the 250 metres, with the rider reporting the mare had been under pressure and had been disappointing.

LIVE AND LEARN (J Fawcett) - Not persevered with in the run home finishing a distant last. Underwent a post-race veterinary examination which revealed the mare to have suffered cardiac arrhythmia. Trainer B Sarginson was advised that LIVE AND LEARN will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

Race 5 SMITHS TRADE & COMMERCIAL 1200m

ANALYST (A Goindasamy) - Taken back from a wide draw to obtain cover shortly after the start.

BELLA RAGAZZA (W Kennedy) - Raced three wide without cover throughout.

JUSTANACE (L Callaway) - Over raced through the middle stages.

PONZI PONY (T Jonker) - Rider dropped the whip passing the 250 metres.

AINGIE (A Balloo) - Rider dropped the whip passing the 25 metres.

HEY NOW (T Moseley) - Steadied in the shadows of the post when crowded for room by JUSTANACE (L Callaway) which shifted in. L Callaway was advised to exercise greater care when shifting ground.

Race 6 PREZZY CARD 1200m

DELPHILLIUS (K Bakker) - Slow to begin.

LINCOLN'S KRUZ (Y Atchamah) - Slow to begin.

KANA (W Kennedy) - Lay in rounding the first bend placing an inside runner in restricted room for a distance.

GUNNAR (A Najib) - Raced three wide without cover throughout.

MORE THAN WORDS (K Mudhoo) - Lay out rounding the final bend and when being angled across heels became awkwardly placed on the heels of the tiring GUNNAR having to be restrained for a distance, and was then held up until near the 300 metres.

Race 7 CAVELL LEITCH 2200m

DAME COUNTY (S Wynne) - Slow to begin.

MUZZLE CAT (T Moseley) - Slow to begin.

JETHRO (L Callaway) - Over raced through the early stages.

FLOAT (L Hemi) - Over raced through the early stages.

BAD FLAMINGO (Y Atchamah) - Over raced through the middle stages.

N Parmar (TREATY OF PARIS) - Spoken to advisedly regarding his whip use over the final stages.

Race 8 GIFT STATION 1600m

TAKE THAT (N Parmar) - Taken back from a wide draw to obtain cover shortly after the start.

ARCHERFIELD (K Bakker) - When asked to comment on performance, rider reported she had got back on a fast tempo and been unable to make up ground.

S Wynne (SEVEN TWENTY) - Admitted a charge in that she struck her mount SEVEN TWENTY 6 times prior to the 100 metre mark and 5 more strikes inside the final 100 metres. After considering submissions the Adjudicator imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Friday 26 July until the conclusion of racing on Sunday 4 August, 5 national riding days.

Race 9 SEDGWICK 1400m

VAUDEVIRE (A Goindasamy) - Slow to begin.

BLUEGRASS DIXIE (Y Atchamah) - Began awkwardly losing ground.

NOTSOMODEST (T Jonker) - Held up rounding the final bend until obtaining clear running passing the 300 metres.

D Tait (JUNE BUG) - Spoken to advisedly regarding her whip use over the final stages.

JUNE BUG (D Tait) - When asked about the improved performance, trainer M Stokes reported with the addition of blinkers, a change in training regime, a positive front running ride and a 3kg claim had aided the mare's performance today.
