### SUPPLEMENTARY

#### Wanganui Jockey Club - Saturday 25 November 2023

#### Race 8 - WAIPINE LOGGING/JOHN TURKINGTON FORESTRY 2040

**TRAMORE** (L Kauri) – Concluding an enquiry that was opened into the reasons TRAMORE clipped a heel and blundered, dislodging rider L Kauri near the 1500 metres. Rider L Kauri was advised that as he had suffered a concussion, he may not ride in barrier trials/races for at least 12 days and thereafter until he has been cleared to ride by the NZTR Medical Officer.

Stewards took initial evidence from riders J Parkes (WALKINTHEPARK), C Dell (UNSCRIPTED), J Allen (JACKAROO) and L Douglas (VENENO) who were assisted by Ms K Clapperton - Apprentice Riding Mentor. Subsequent to the race meeting evidence was also taken from Apprentice Riders L Kauri, L Sutherland and Ms K Clapperton. After viewing the replays and hearing from all riders it was established that VENENO raced ungenerously in the early stages and made the crossing rounding the first bend awkwardly before getting its head up when being firmly restrained off the heels

of WALKINTHEPARK. As a result VENENO shifted outwards into the running line of TRAMORE which clipped a heel and blundered, dislodging its rider when placed in restricted room to the inside of UNSCRIPTED and JACKAROO. Further it was established that when PERFECT TEST (L Sutherland) improved forward to lead near the 1500 metres the mare briefly raced erratically after going over the crossing and as a result there was an easing of the pace which contributed to the incident. Rider L Sutherland was advised to exercise greater care in similar circumstances. After considering the matter, Stewards found the primary reason for L Kauri being dislodged from his mount was due to the racing manners of VENENO and culpability could not be attributed to its rider. Accordingly, no further action was taken other than to note the circumstances.

#### RACE COMMENTS

##### Race 1 | MONSTAVISION LTD MAIDEN 1800m

**CATHERINENZ** (J Doyle) - Fractious in the barriers prior to the start.

**TINY** (J Allen) - Slow away.

**THIRSTY** (L Allpress) - Slow away.

**IMPOSTER** (J Chung) - Crowded leaving the barriers losing ground.

**MARIINSKY** (L Sutherland) - Commenced to over race near the 1400 metres and shifted outwards to avoid heels, being three wide without cover from that point and continuing to over race through the middle stages.

**BLUE RATA BOLDNESS** (J Parkes) - When questioned regarding performance, the rider could offer no excuse. A post-race veterinary inspection did not reveal any obvious abnormality.

Retrospective to Race 1 the track was upgraded to Soft 6.

##### Race 2 | TARANAKI ASSOCIATED CLEANERS 3YO MAIDEN 1100m

**S Logan** (ISLAY) - Issued with a warning for late declaration of rider.

**RAYET** (C Barnes) - Slow away.

**STOUT** (C Grylls) - Crowded leaving the barriers when LET IT BEGIN lay in.

**MEGATRENDZ** (M Hashizume) - Raced three wide without cover. Underwent a post-race endoscopic examination which found 2/4 exercise induced internal pulmonary haemorrhage. The stable representative indicated they would be giving consideration to the racing future of MEGATRENDZ. A veterinary clearance will be required if MEGATRENDZ is to race again.

**ARCACHON** (L Allpress) - Raced keenly in the trail through the early stages.

**LET IT BEGIN** (L Sutherland) - Lost the right front plate during the running.

##### Race 3 | BUNNINGS NEW PLYMOUTH LTD 1200m

**FELLINI** (N Parmar) - When questioned regarding performance, the rider could offer no excuse.

##### Race 4 | CENTRAL ELECTRICAL & SMITH & SONS MAIDEN 1200m

**SALUTO** (N Parmar) - Slow away.

**AM I BLUE** (M Hudson) - Slow away.

**KOHEROA** (M Hashizume) - Made the final bend awkwardly when racing greenly and shifted out off the heels of FLUTTERBELLE and in doing so dictated EL JAYCEE over extra ground. M Hashizume was shown footage of his ride and advised to exercise care when shifting ground. Stewards took into account the inexperience of both runners when assessing the interference.

**EL JAYCEE** (L Sutherland) - Dictated over extra ground rounding the final bend.

**Race 5** | **NULOOK ALUMINIUM MAIDEN 1400m**

**PERSIAN IDOL** (K Hercock) - Reared at the start losing ground.

**TAKES TIME** (C Butler) - Slow away.

**OVERDRAWN** (L Allpress) - Shifted in passing the 200 metres and bumped with IT'S DORIS.

**IT'S DORIS** (C Grylls) - Bumped passing the 200 metres.

**HALOUMI** (J Doyle) - Finished some distance last. When questioned regarding performance, the rider advised the tongue tie had become displaced during the running.

**Race 6** | **RETURN TO EARTH MAIDEN 1400m**

**MATETSI** (T Newman) - Crowded shortly after leaving the barriers losing ground.

**LOCH IN ORA** (J Parkes) - Restrained to obtain cover shortly after the start.

**LADY PAPPYGATE** (M Hashizume) - Raced three wide without cover from the 1000 metres.

**LADDIE BOY** (L Allpress) - When questioned regarding performance, the rider advised that the gelding had over raced and been unable to finish the race off as a result.

**I HOPE SO** (L Satherley) - Was not persevered with in the final straight, with the rider advising that the mare had raced very greenly throughout at its raceday debut.

**Race 7** | **REVITAL FERTILISERS 1400m**

**BELLA NOCHE** (M Hashizume) - Slow away.

**KORO'S PRINCESS** (N Parmar) - Jumped away awkwardly. When questioned regarding performance after finishing last, the rider had no excuse but advised in his opinion the mare is better suited to more rain affected footing.

**TRUSTWORTHY** (L Hemi) - Steadied to obtain cover shortly after the start.

**SHOW D'OR** (M Hudson) - Raced three wide without cover.

**MASTER PARK** (J Chung) - Lay out when placed under pressure early in the straight.

**Race 8** | **IDEAL RACING THANKS ASCOT BLOODSTOCK 1800m**

**BEAUDZ WELL** (C Butler) - Jumped away awkwardly losing ground.

**MY ZOI** (L Allpress) - Restrained to obtain cover after jumping from a wide barrier.

**MR FABULOUS** (T Bau) - Raced wide without cover until near the 1000 metres.

**DIMAGGIO** (M Hashizume) - When questioned regarding the disappointing performance, the rider had no tangible excuse.

**THE UNDERBELLY** (C Grylls) - Held up and unable to improve for some distance rounding the home turn, gaining clear running when angled out near the 200 metres and racing in restricted room over the final stages.

**MAUNA LOA** (J Allen) - Raced in restricted room until the 100 metres.

**T Bau** (MR FABULOUS) - Issued with a warning after he used his whip on MR FABULOUS when the horse was out of contention.

**C Butler** (BEAUDZ WELL) - Admitted a charge in that she struck her mount BEAUDZ WELL 8 times (3 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of C Butler's licence to ride in races from the conclusion of racing on Saturday 16 December until the conclusion of racing on Sunday 24 December, 5 national riding days.

**Race 9**

**CBRE PROPERTY VALUERS 2000m**

**BLISSFULL LADY** (M Hashizume) - Jumped away awkwardly before being further hampered by TICKLE ME ALMO which jumped outwards.

**HUNGRY** (L Allpress) - Crowded leaving the barriers losing ground. HUNGRY then continued to lose ground in the early stages, with the rider advising that the gelding had felt indifferent in its action throughout. A post-race veterinary inspection did not reveal any obvious abnormality.

**JACK IN THE BOX** (L Satherley) - Over raced in the early stages.

**BLUE RATA QUEEN** (C Butler) - Commenced to give ground rapidly rounding the home turn. C Butler was of the opinion the mare may have been feeling the effects of recent racing.

**HARDTIMES** (M Hudson) - Came together with RUFFHOUSE ROSIE and bumped passing the 200 metres when both runners shifted ground under pressure.

**RUFFHOUSE ROSIE** (J Doyle) - Came together with HARDTIMES and bumped passing the 200 metres when both runners shifted ground under pressure.
