GENERAL

J Fawcett advised Stewards on Thursday that she would not be riding at the meeting today, instead opting to ride at the transferred Pukekohe meeting. Miss Fawcett was replaced on her riding engagements as per the Summary above. **JETSTREAM** and **OUR SALLYANN** were both late scratchings in Race 1 due to a mechanical failure with the float transporting the horses to the course.

RACE COMMENTS

Race 1 **BEVAN CROMBIE MEMORIAL (1200m)**

The start of this event was delayed due to **MATAKANA PERKYNANA** proving very difficult to load. Connections were advised the filly would be placed on a barrier manners warning.

MATAKANA PERKYNANA (T Moseley) - Proved difficult to load. Steadied shortly after the start when **DIABLO BLANCO** shifted in abruptly, then raced keenly through the early stages.

MR PACQUIAO (K Bakker) - Raced keenly through the early stages.

MAMAEA (L Sutherland) - Rider could offer no excuse for the disappointing performance adding that the filly may have come to the end of its current preparation.

Race 2 **THANK YOU PETER KENNEDY MAIDEN (1200m)**

VANDERDONK (D Subramaniam) - Slow to begin.

HIGH STEP (C Butler) - Slow to begin.

THE PEONY EXPRESS (K Bakker) - Slow to begin. Raced wide throughout.

STOLEN MAGIC (W Kennedy) - Slow to begin. Rider advised that after being slow to begin the filly had found it hard to make up ground in today's testing track conditions and had been disappointing.

DECLARE (S Toolooa) - Raced wide without cover through the early to middle stages.

CALLMEGINGER (D Tait) - Blundered passing the 700 metres after contacting the heel of **LA FURRIOSSA**. After interviewing riders and viewing replays which proved inconclusive, Stewards were of the opinion that there was movement from inside and outside runners at this point in the race and as such could not be satisfied one horse or rider was at fault. Accordingly, no further action was taken other than to remind all riders to ensure they are clear of other runners when shifting ground.

DE RUSSIAN ROCKET (L Sutherland) - Raced three wide without cover throughout.

Race 3 **GLENMOA FARMS LTD RIVER PLATE TROPHY (1200m)**

MAKABAR (K Williams) - Slow to begin.

BENAUD (W Kennedy) - Slow to begin.

IN DISGUISE (L Sutherland) - Made the bend near the 900 metres awkwardly having to be steadied away from the heels of LOUIE LOUIE.

Race 4 | **DAVE ALLAN MEMORIAL (2200m)**

There was a delay to the start of this event when **PLEASURENPAIN** proved very difficult to load. Connections were advised the mare was on a final barrier manners warning.

SASSY CHOUXS (C Butler) - Late scratching on Veterinary advice at 12.13pm after being injured in the float enroute to the course.

PLEASURENPAIN (K Chowdhoo) - Proved difficult to load. Improved wide from the 1200 metres to sit outside the leader near the 900 metres. On return to the home stable was found to have a suspected injury to a front leg with trainer A Hoffman advising Stewards she would have mare undergo a Veterinary examination as soon as possible and undertook to advise Stewards of the results.

LOQUITA (K Williams) - Began awkwardly shifting outwards hampering an outside runner.

SADLER'S LASS (D Subramaniam) - Began awkwardly losing some ground before being ridden forward with urgency to recover.

DIAMOND RIVIERE (G Jogoo) - Slow to begin and was then further hampered when LOQUITA shifted outwards at the start.

KING OF THE DANCE (N Parmar) - Raced in restricted room shortly after the start when ASTRADEEL lay outwards. Raced three wide without cover until obtaining cover near the 1400 metres.

ANTICIPATE (R Muniandy) - Over-raced in the early stages.

Race 5 | **PLUNKET ELECTRICAL (2200m)**

HALLELUJAH BROTHER (D Subramaniam) - Began awkwardly losing ground.

OHIWA SUNSET (C Butler) - Began awkwardly shifting outwards and was then ridden forward with urgency to sit outside the leader passing the 1700 metres. When questioned regarding the performance rider advised that the mare had hung throughout and had been disappointing. A post-race Veterinary examination did not reveal any abnormality.

ON THE RIVET (L Callaway) - Slow to begin. Clipped a heel and blundered near the 1700 metres.

MILFORD SOUND (A Goindasamy) - Taken back from a wide draw to obtain cover shortly after the start. When questioned regarding the performance rider advised the gelding had been off the bridle throughout and had been disappointing. A post-race Veterinary examination did not reveal any abnormality. Connections advised they would have blood tests conducted on the gelding in the coming days, which Stewards will follow up.

ELLENAWROE (K Bakker) - Raced wide without cover through the early stages.

GABBY DIAZ (T Moseley) - Made the bend near the 1700 metres awkwardly having to be steadied away from heels and in doing so came back onto ON THE RIVET which clipped a heel and blundered. After viewing replays and

interviewing riders Stewards were satisfied that this incident was down to the racing manners of GABBY DIAZ and not the actions of the rider. Held up rounding the bend near the 450 metres.

BILLY LID (R Muniandy) - Lay out early in the run home and became awkwardly placed on heels near the 350 metres having to be steadied.

KOYAMA (L Hemi) - When questioned regarding the seemingly improved performance trainer L Stewart advised the gelding had found track conditions today which suited.

Race 6 | **ROBBIE LORY MEMORIAL MAIDEN (1400m)**

CLYDE BARROW (W Kennedy) - Began awkwardly losing ground.

KASHIPURA (A Najib) - Bounded at the start losing some ground. Crowded having to steady near the 650 metres.

PHENOMENAL ROSE (B Murray) - Shifted out abruptly at the start crowding outside runners.

FRIENDOFTHEDEVIL (S Toolooa) - Crowded shortly after the start and was forced outwards making firm contact with MAURIKEE, losing ground as a result. Held up by a tiring runner passing the 650 metres and when shifting ground to avoid heels placed KASHIPURA in restricted room, which had to be steadied. S Toolooa was shown a replay of this incident and advised to exercise greater care. Crowded and checked near the 300 metres and was then held up and unable to obtain clear running until inside the final 200 metres.

MAURIKEE (L Callaway) - Crowded and buffeted at the start losing ground.

CASTLEBRAE (K Chowdhoo) - Raced wide without cover throughout.

CLAIRE'S PAL (D Subramaniam) - Rider reported the gelding had failed to handle today's testing track conditions.

K Mudhoo (JING JING) - Admitted a charge of careless riding in that he permitted his mount JING JING to shift out near the 300 metres crowding and checking FRIENDOFTHEDEVIL. After considering submissions the Adjudicative Committee imposed a suspension of Mr Mudhoo's licence to ride in races from the conclusion of racing on Friday 26 July until the conclusion of racing on Saturday 3 August, 4 national riding days.

Race 7 | **THANK YOU OAMARU JOCKEY CLUB SUPPORTERS (1400m)**

TADITA (A Balloo) - Began awkwardly shifting out and crowding REDFORD.

CLASSIC DIVA (L Sutherland) - Slow to begin.

VICTORIAN CHARM (D Tait) - After initially being slow to begin was then further hampered losing ground when inside runners shifted out. Had to shift ground inwards early in the run home to find clear racing room.

REDFORD (K Bakker) - Crowded at the start losing ground.

GOODANYA (K Chowdhoo) - Taken back from a wide draw to obtain cover shortly after the start.

BALZANO (T Moseley) - Race three wide without cover for the majority of the event.

KABUGEE (W Kennedy) - Lay inwards in the run home.

MARGHERITA VELOCE (C Butler) - When asked to comment on the performance rider advised she could not offer any tangible excuse.

A Balloo (TADITA) - Admitted a charge that he struck his mount TADITA 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of Mr Balloo's licence to ride in races from the conclusion of racing on Friday 26 July until the conclusion of racing on Sunday 4 August, 5 national riding days.

Race 8 | **CROMBIE & PRICE LTD OAMARU CUP (1600m)**

CAPTAIN OUMUAMUA (K Bakker) - Underwent a pre-race Veterinary examination around at the start area after blood was observed in its mouth and was cleared to start. Over-raced through the early stages. The saddle shifted forward during the running and again on pulling up with assistance required to return the horse to the birdcage. Due to the length of time involved rider K Bakker was excused from weighing in under Rule 647(1).

CHARBANO (W Kennedy) - Began awkwardly. When asked to comment on the performance rider advised the gelding had failed to handle today's testing track conditions.

ZADANE (G Jogoo) - Slow to begin.

LORD DARCI (D Tait) - Over-raced in the early stages.

BAUBLE (D Subramaniam) - The saddle shifted forward nearing the 1200 metres placing the rider at a disadvantage for the remainder of the event.

MASTER MARKO (C Butler) - Raced wide without cover throughout.

CORK (L Sutherland) - Raced in restricted room near the 350 metres and had to shift outwards away from heels when SMOOTH OPERATOR shifted out for clear racing room.

CONOR O'CEIRIN (A Goindasamy) - When asked to comment on the performance rider advised he was disappointed and could offer no tangible excuse.

T Moseley (SMOOTH OPERATOR) - Issued with a warning after angling his mount SMOOTH OPERATOR out passing the 350 metres crowding CORK which raced in restricted room for a short distance having to be shifted away from that runner's heels.

Race 9 | **EASY MADE MARMALADE LTD (1200m)**

ZAC THE LAD (B Murray) - Began awkwardly losing ground.

AVITUS (A Balloo) - Slow to begin.

GAME DUKE (G Jogoo) - Slow to begin.

GLOBAL STAR (C Butler) - Slow to begin.

BELLA ROSE (W Kennedy) - Slow to begin. Raced wide without cover throughout.

VICTOR ROUGE (D Tait) - Crowded and checked passing the 1100 metres then got its head up when over-racing.

THEE AULD MINX (K Williams) - When asked to comment on the performance rider advised the mare had been under pressure rounding the final bend and had been quickly beaten. A post-race Veterinary examination did not reveal any abnormality other than an elevated heart rate. Stewards will follow up with connections in the coming days.

K Williams (THEE AULD MINX) - Admitted a charge of careless riding in that she permitted her mount THEE AULD MINX to shift inwards passing the 1100 metres crowding and checking VICTOR ROUGE. After considering submissions the Adjudicative Committee imposed a suspension of Miss William's licence to ride in races from the conclusion of racing today until the conclusion of racing on Friday 26 July, 4 national riding days.

T Ladouceur (OUR CLARRY) - Admitted a charge that he struck his mount OUR CLARRY 17 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of Mr Ladouceur's licence to ride in races from the conclusion of racing today until the conclusion of racing on Saturday 3 August, 8 national riding days.

T Ladouceur (OUR CLARRY) - Admitted a charge of using the whip in 7 consecutive strides on his mount OUR CLARRY in the home straight. After considering submissions the Adjudicative Committee imposed a suspension of Mr Ladouceur's licence to ride in races from the conclusion of racing on Sunday 4 August until the conclusion of racing on Saturday 10 August, 5 national riding days. Apprentice Ladouceur was also referred to the apprentice mentor for further education around the whip use.
