Race 1	ELLERSLIE EVENTS 1600
MIGHTY CASTLE (M Hashizume) – Began awkwardly losing ground.	
POLAMALU (M Sanson) - Crowded shortly after the start having to be steadied.	
RAKAU (A Lawson-Carroll) - Steadied when placed in restricted room to the inside of SULABELLA which was shifting inwards passing the 1400 metres.	
K Myers (SULABELLA) - Issued with a warning after permitting her mount to shift inwards when not fully clear of RAKAU which had to steady passing the 1400 metres.	
Race 2	AUCKLAND CO-OP TAXIS MAIDEN 1600
LADY GREY (J Doyle) - Slow to begin.	
TELLEMALIE (A Lawson-Carroll) - Began awkwardly then crowded shortly after losing ground.	
HOLY MOLY (R Goyaram) - Crowded shortly after the start having to be steadied when runners either side shifted ground. Raced keenly through the early stages with the saddle shifting forward passing the 1300 metres with apprentice R Goyaram easing the gelding out of the remainder of the race.	
FALCON WARRIOR (K Myers) - Crowded shortly after the start having to be steadied when runners either side shifted ground. Steadied when placed in restricted room to the inside of MITONIC which had shifted in slightly near the 1100 metres.	
MITONIC (M Hashizume) - Crowded shortly after the start having to be steadied when runners either side shifted ground.	

K McQuade (HE'Z DRAMATIC) – Issued with a warning after presenting HE'Z DRAMATIC to race with pre-race ear covers which weren't declared.

Race 3 | **TAB NZ MAIDEN 1600**

JANKA (J Allen) - Slow to begin. Lay inwards when placed under pressure in the final straight coming together with MUSCOVADO near the 400 metres and again near the 25 metres when MUSCOVADO lay outwards under pressure.

WORKING CLASS MAN (R Goyaram) – Crowded shortly after the start losing ground.

KHANDO (B Jacobson) - Knuckled at the start.

JON WARRIOR (K Myers) – Raced ungenerously through the early and middle stages.

ROYAL SECRETARIAT (M Sanson) – Improved onto heels having to be steadied near the 800 metres.

MUSCOVADO (L Kauri) – Lay outwards when placed under pressure in the final straight coming together with JANKA near the 400 metres and again near the 25 metres.

THREE TIMES A LADY (M Hashizume) - Rider reported that the mare had made abnormal breathing noises. Underwent a post-race veterinary examination which did not reveal any abnormalities.

J Bell (MUSCOVADO) – Issued with a warning after presenting MUSCOVADO to race without the notified tongue tie.

Following the running of this race connections of the fourth placed horse JANKA lodged a protest with the Adjudicator alleging interference in the final straight by the second placed horse MUSCOVADO. After considering submissions the Adjudicator dismissed the protest with placings standing 1st DOCTOR IRIS, 2nd MUSCOVADO, 3rd SALLY, 4th JANKA.

Race 4 | **DUNSTAN HORSEFEEDS MAIDEN 2100**

MIDDLE KHAN (N Smith) - Reared as the start was effected losing ground as a result.

TIMBA (L Kennedy) - Slow to begin.

SHEEZE A BREEZE (C McKee) - Slow to begin. Raced keenly through the early stages when being restrained.

I'LL HAVA SEMILLON (V Peebles) - Raced in restricted room passing the winning post on the first occasion, having to be steadied.

TE AROHA BOY (C Rennie) – Raced keenly through the early stages. Lay inwards when placed under pressure in the final straight

BEAU ONDAGO (J McIlroy) – Lay outwards rounding the final bend and continued to do so when placed under pressure in the final straight. Lost the near hind plate during the running.

Race 5 | **ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1200**

PENNY BLUE (S Brown) - Raced keenly through the early stages when being restrained.

ARABELLA (A Lawson-Carroll) – Lay outwards when placed under pressure in the final straight.

FLUTTERBELLE (R Goyaram) - Lay outwards when placed under pressure in the final straight.

Race 6	SKYCITY HORIZON MAIDEN 1200
<p>FOREVER YOUNG (B Jacobson) - Crowded at the start losing ground. Improved onto heels having to be steadied near the 1000 metres.</p> <p>STAR HEART (K Myers) - Crowded at the start. Raced ungenerously through the early stages getting its head up on a number of occasions.</p> <p>KERBLINE (J Doyle) - Crowded at the start. Lay inwards when placed under pressure in the final straight. Came together with TAKEACHANCE near the winning post when both horses were shifting ground.</p> <p>FINNT (L Kauri) - Crowded at the start. Briefly steadied near the 700 metres when improving into restricted room.</p> <p>OVERSTATE (A Lawson-Carroll) - Began awkwardly losing ground. Steadied passing the 1000 metres to avoid the heels of FINNT rounding the bend.</p> <p>FAMILY STRENGTH (R Goyaram) - Began awkwardly.</p> <p>BENEE (J Nishizuka) - Raced keenly through the early and middle stages.</p> <p>GIBRALTAR RISING (B Rogerson) – Raced keenly through the early and middle stages.</p> <p>TAKEACHANCE (J Allen) – Came together with KERBLINE near the winning post when both horses were shifting ground.</p> <p>J & R Vance (FAMILY STRENGTH) – Issued with a minor infringement and fined \$100 after presenting FAMILY STRENGTH to race without the notified blinkers.</p> <p>Connections of the second placed horse KERBLINE viewed video footage before electing not to proceed with a protest.</p>	
Race 7	STELLA ARTOIS 1400
<p>IN THE LOOP (J Nishizuka) - Contacted shortly after the start becoming unbalanced.</p> <p>HANAIEI STAR (B Rogerson) – Raced keenly through the early stages.</p> <p>WANDA LU (R Goyaram) – Lay inwards when placed under pressure in the final straight.</p> <p>MOELLE (A Lawson-Carroll) - Lay outwards when placed under pressure in the final straight.</p> <p>MISCHIEF MANAGED (M McNab) - When questioned regarding the performance rider advised that the mare had not handled today's track conditions.</p>	
Race 8	BARFOOT & THOMPSON MAIDEN 1400
<p>SWEET AND SASSY (J Allen) – Declared a late scratching at 3.54 pm after refusing to load into its barrier stall. Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p>FLEETWOOD (L Kauri) - Slow to begin.</p> <p>SUITED AND BOOTED (J Nishizuka) - Slow to begin.</p>	

SUMMERSTON (M Hashizume) – Crowded shortly after the start. Lay inwards when placed under pressure in the final straight.

CALL ME (M McNab) - Slow to begin.

I'M PEDRO (A Lawson-Carroll) – Raced keenly through the early and middle stages. Lay outwards when placed under pressure in the final straight.

COMPLIMENTERRY (M Sanson) - Steadied when placed in restricted room to the inside of SUMMERSTON and outside of REVUELTO near the 500 metres.

TEAK (J Doyle) – Lay inwards when placed under pressure in the final straight.

R Elliot (REVUELTO) - Issued with a warning after permitting his mount to shift outwards when not fully clear of COMPLIMENTERRY which had to be steadied near the 500 metres.
