Race 9 JOHN YOUNG FAMILY 2200m

SOLIDIFY (B Rogerson) – Trainer G Rogerson reported to Stewards upon returning to the stable SOLIDIFY underwent a veterinarian examination which included x-rays, with no abnormalities being detected. G Rogerson further advised the SOLIDIFY and has now been sent for a spell.

CHARLBURY (K Myers) – Trainer C Cameron advised Stewards CHARLBURY was examined by the Veterinarian on Monday 8 July which revealed no abnormalities, however C Cameron further advised CHARLBURY has been lightly freshened with swimming and will continue with the mare’s current preparation.

RACE COMMENTS

Race 1 NORTHLAND BUSINESS SYSTEMS 1200

MARKET PLACE (T Moodley) - Began awkwardly. Raced three wide without cover throughout. Eased down over the final 200 metres when out of contention. Rider reported that the gelding had felt lame in the off-hind leg. Underwent a post-race veterinary examination which revealed no abnormalities.

NEW YORK JAZZ (J Nishizuka) – Raced keenly through the early stages. Briefly steadied near the 900 metres to avoid the heels of LOVE AFFIRMATIONS. Raced in restricted room over the concluding stages having to be steadied.

ILLICIT DREAMS (J Fawcett) – Lay inwards when placed under pressure in the final straight.

S Spratt (PATRICIA) - Admitted a charge in that she struck her mount eight times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.

Race 2 ITM/GIB 2YO RACE 1200

I’M ALL IN (W Kennedy) - Underwent a pre-race veterinary examination after becoming fractious in the barriers being late scratched at 12.46 pm on veterinary advice.

CASUAL KHAN (K Myers) - Slow to begin. Raced ungenerously through the early stages hampering MISS FLOWER near the 950 metres.

MISS FLOWER (W Pinn) – Restrained at the start to obtain cover from the outside barrier. Hampered near the 950 metres.

VEGAS QUEEN (J Fawcett) – Contacted when HARD ATTACK shifted outwards when not fully clear passing the 950 metres. Lay outwards rounding the final bend.

S Spratt (HARD ATTACK) - Issued with a warning after allowing her mount to shift outwards when not fully clear of VEGAS QUEEN which was contacted passing the 950 metres.

Race 3 ENTAIN/NZB INSURANCE PEARL SERIES 1200

FOREIGN AFFAIR (W Pinn) – Restrained at the start to obtain cover from a wide barrier. Lost contact with the body of the field through the middle stages despite the efforts of its rider. When questioned regarding the performance rider advised that the filly never travelled throughout the running and in his opinion resented the kickback.

BEE ON TIME (S Spratt) – Raced three wide without cover throughout.

ROC ON HOME (N Parmar) - Made the bend near the 800 metres awkwardly shifting outwards then raced wide for the remainder of the race. Not persevered with over the final 300 metres when out of contention. When

questioned, rider advised that the mare hung outwards throughout. Underwent a post-race veterinary examination which revealed no abnormalities.

DANCING DREAM (J Fawcett) – When questioned regarding the performance rider advised that the filly failed to respond when placed under pressure in the final straight.

W Pinn (FOREIGN AFFAIR) - Was shown the replay and reminded of his obligations in that he must ensure that he rides his mounts out fully to the end of the race when circumstances permit.

Race 4 | **ITM/GIB SPRINTERS' WINTER CHAMPIONSHIP FINAL 1400**

PIPPY (W Pinn) - Proved difficult to load which resulted in a 2 minute delay to the start of this race. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next. Steadied when placed in restricted room to the inside of SHAMUS making contact with the running rail near the 850 metres. Had some difficulty obtaining clear running until near the 200 metres.

MALT TIME (A Lawson-Carroll) - Slow to begin.

NO AGENDA NIGEL (J Nishizuka) - Slow to begin. Raced three wide without cover throughout. Lay inwards when placed under pressure in the final straight.

TURN THE ACE (S Mxothwa) - Began awkwardly. Lay outwards rounding the final bend. When questioned regarding the performance rider advised that the gelding would appreciate a track with more give.

MASTER BRUTUS (W Kennedy) – Raced keenly through the early and middle stages when being restrained.

SHAMUS (T Moodley) – Lay inwards rounding the bend near the 850 metres placing PIPPY in restricted room.

Race 5 | **ITM/GIB PROGRESSIVE WINTER CHAMPIONSHIP FINAL 1600**

HEART OF ALLADIN (K Myers) - Slow to begin. Raced keenly through the early and middle stages.

AWHINA (T Moodley) - Slow to begin. Held up for clear running until shifting across heels passing the 200 metres.

ALMACETA (T Newman) - Restrained at the start to obtain cover from the outside barrier.

TALENTOSO (B Jacobson) – Raced three wide without cover throughout. Lay inwards when placed under pressure in the final straight. Came together with MARGALIT approaching the 300 metres.

OVERRATED (S Spratt) – Over-raced through the early stages improving onto heels near the 1200 metres having to be steadied. When questioned regarding the seemingly improved performance connections advised that the gelding appreciated a step up in distance today.

LOOSE CHANGE (J Fawcett) – Improved onto heels having to be steadied passing the 1200 metres.

MARGALIT (A Lawson-Carroll) - Came together with TALENTOSO approaching the 300 metres.

THE EXPONENT (M Hashizume) – When questioned regarding the performance rider advised that he was disappointed with the gelding's effort and could offer no explanation.

T Mitchell (DELOREAN) - Admitted a charge in that she struck her mount six times prior to the 100 metres with a further five strikes inside the final 100 metres. After considering submissions the Adjudicator imposed a suspension

of T Mitchell's licence to ride in races from the conclusion of racing on Friday 26 July up to and including racing on Wednesday 31 July, 3 national riding days.

Race 6 | **ITM/GIB WHANGAREI GOLD CUP STAYERS' FINAL 2100**

BRUCEY LEE (C Barnes) - Began awkwardly.

PENURIOUS (T Newman) - Slow to begin.

MINESHAFT (K Myers) – Restrained at the start to obtain cover from the outside barrier. When questioned regarding the performance rider advised that the gelding found it difficult to make up ground from its rearward position.

LET FLY (N Parmar) - Restrained at the start to obtain cover from a wide barrier.

I'M LULU (M Hashizume) – Steadied when placed in restricted room near the 2000 metres. Raced keenly through the early and middle stages.

BOSCH (S Spratt) - Had to be steadied off heels rounding the first bend when racing keenly. Held up behind a weakening runner for a distance from the 600 metres.

BLUE SKY AT NIGHT (T Mitchell) - Raced wide without cover from the 1000 metres.

CIMARRON (W Kennedy) - Steadied when placed in restricted room to the inside of MALFY ROSA and outside of ESTELLA KHAN which had shifted ground slightly near the 600 metres.

ESTELLA KHAN (B Rogerson) – Placed in restricted room to the outside of BOSCH having to be steadied near the 500 metres.

NO PLAN BE (A Lawson-Carroll) - Had to shift across heels to obtain clear running near the 250 metres.

MALFY ROSA (W Pinn) - Briefly placed in restricted room having to be steadied when runners either side shifted ground approaching the 200 metres.

Race 7 | **ITM/GIB 3YO WINTER CHAMPIONSHIP FINAL 1600**

BOUND TO BE (W Pinn) - Crowded at the start losing ground. Became detached from the body of the field through the early stages.

ZLATNA (J Fawcett) - Crowded at the start. Hampered near the 850 metres.

ERASE (J Nishizuka) - Crowded at the start. Over-raced through the early and middle stages getting its head up and raced ungenerously for a distance proving difficult for its rider. Raced three wide without cover throughout. Connections were advised that a warning would be placed against the gelding's racing manners.

CINTIVEE (M McNab) - Began awkwardly making contact with FULL NOISE. Raced keenly through the early stages getting its head up on several occasions. Made the bend near the 850 metres awkwardly shifting outwards hampering ZLATNA. When questioned regarding the performance rider advised that the racing manners of the filly proved detrimental to its chances.

FULL NOISE (A Lawson-Carroll) - Contacted at the start. Held up for clear running rounding the final bend and early in the straight.

LOVACI (C Barnes) - Began awkwardly.

GASGAL (T Mitchell) - Became detached from the body of the field through the early stages. Made the bend near the 900 metres awkwardly having to be steadied for a distance.

NAVY CHIEF (T Moodley) - Held up for clear running rounding the final bend and early in the straight.
