Race 4 MARTIN COLLINS 1200m

QUINTAIN (K Hercock) – Trainer Mr. C Isdale advised Stewards, the filly was examined by the stable veterinary on Wednesday 26 June, with no abnormalities being detected. C Isdale further advised that in his opinion QUINTAIN may have not been suited to the synthetic track conditions and it will be his intention to nominate Quintain on grass surfaces, however, he will look to trial QUINTAIN before her next race day start.

Race 5 I SEE RED SYNDICATE MAIDEN STEEPLECHASE 4000m

DEVOTED (H McNeill) – Co-trainer Mr. M Walker reported to Stewards, the stable was satisfied with the post-race condition of DEVOTED. M Walker further advised the stable will continue with the gelding's current preparation and may look to nominate DEVOTED at the Racing Rotorua meeting on 20 July.

Race 1	CHRIS GOMMANS & SONS CONTRACTING MAIDEN 2140m
<p>BATTLE HYMN (K Hercock) – Late scratching at 11.56am on veterinary advice after becoming fractious in the barrier.</p> <p>FINAL CHAPTER (C Dell) - Bounded at the start, losing ground.</p> <p>WHOSAID (L Sutherland) - Raced three-wide without cover through the early stages.</p> <p>VERARDINO (W Kennedy) - Inclined to lay inwards throughout the run home.</p> <p>TOWROPE (S O'Malley) - Finished well back after disputing the pace from near the 900 metres when three-wide without cover. S O'Malley was questioned regarding her tactics and she advised stewards that in her opinion her best option was to let the gelding roll forward some distance out but agreed that she had erred by not obtaining cover when the opportunity existed earlier in the race. S O'Malley was advised that she is expected to exercise better judgement in future and her explanation was noted. S O'Malley added the gelding may not have been suited to the synthetic. A subsequent veterinary examination did not reveal any obvious abnormality.</p>	
Race 2	ROWDEN ELECTRICAL & DL TREE SPECIALISTS LTD MAIDEN 1000m
<p>KERETI (K Chowdhoo) - Began awkwardly. Contacted and unbalanced racing into the first bend. Raced three-wide for the majority of the event.</p> <p>NADEEM'S PEACH (K Hercock) - Bumped with SIZZLE at the start. Crowded racing into the first bend losing some ground when laying outwards and bumping with KERETI (K Chowdhoo) which lay inwards simultaneously. Both riders were shown footage and advised to exercise care.</p> <p>SIZZLE (J Chung) - Bumped with NADEEM'S PEACH at the start. Lay outwards when making the first bend near the 750 metres placing outside runners in restricted room. Was dismounted in the back straight on pulling up after showing signs of distress and was immediately attended to by the on-course veterinarian and horse ambulance, with the result being the filly had suffered a cardiac arrest and was humanely euthanised.</p> <p>PREMINENCE (L Sutherland) - Raced wide into the first bend.</p> <p>KODA (S O'Malley) - Tailed the field for the majority of the event despite the efforts of the rider.</p>	
Race 3	MURRAY FREE CONTRACTING LTD 1200m
<p>BIKINDY (L Allpress) - Slow into stride.</p>	
Race 4	ASHHURST DEER AND DUCK INN 1200m
<p>DARHAD (L Sutherland) - Blundered leaving the barriers, unbalancing the rider. Raced keenly in the early stages. Connections advised the gelding will be retired.</p> <p>LINCOLN'S KRUZ (L Allpress) - Raced keenly in the early stages before being allowed to stride forward to lead passing the 800 metres.</p>	
Race 5	THE PAVEMASTERS MAIDEN 1400m
<p>RIDE THE TIDE (K Chowdhoo) - Slow to begin.</p> <p>JAZZ WITH DRAGON (C Dell) - Slow to begin.</p>	

BUTTON YA LIP (L Hemi) - Raced three-wide without cover throughout.

MRS WEBB (K Hercock) – Disappointed. K Hercock advised the mare had no excuse

COBBA (J Allen) - Began awkwardly losing some ground. Under pressure passing the 600 metres, finishing a distant last. Rider J Allen advised that the gelding had displayed an unusual breathing pattern and she had recommended to connections that a tongue-tie be applied. A post-race veterinary inspection did not reveal any obvious abnormality.

Race 6 | **MANAWATU SHEARING & MANAWATU SPREADERS 1400m**

SCHUSKI (A Bohorun) - Was fractious in its barrier prior to the start.

ROYAL DESTROYER (W Kennedy) - Slow to begin.

DOUBTFUL SOUND (L Kauri) - Crowded leaving the barrier, losing some ground.

SONNET (L Douglas) - Taken back from its wide draw shortly after the start to obtain cover.

IRONWOOD (Ayush Mudhoo) - Raced three-wide without cover for the majority of the event.

VEE VEE (J Chung) - Raced in restricted room over the concluding stages and could not be ridden to full advantage.

Race 7 | **CARTERS ASHHURST-POHANGINA CUP 2140m**

L Kauri (NARINCE) - Failed to make the required weight and was fined \$100 under the Minor Infringement Schedule. L Kauri was replaced by J Chung.

OXYGEN (J Allen) - Very slow to begin (5L) and failed to muster early speed, becoming well-detached from the field in the early stages. Connections were advised a warning has been placed against the barrier manners of OXYGEN.

LEGALLY BLONDE (K Kalychurun) - Crowded shortly after the start losing ground.

NARINCE (J Chung) - Crowded shortly after the start losing ground.

MONKEY TOWN (C Lindsay) - Began awkwardly, shifting inwards abruptly crowding inside runners. Raced three-wide without cover from the 1200 metres.

PLATINUM SIXTY SIX (W Kennedy) - Held up rounding the bend and early in the run home.

BOURBON FALLS (M Hashizume) - Checked near the 1700 metres when TRAMORE shifted inwards when insufficiently clear.

L Sutherland (TRAMORE) - Admitted a charge of careless riding in that she permitted TRAMORE to shift inwards when not sufficiently clear of BOURBON FALLS near the 1700 metres, resulting in M Hashizume having to check his mount. After considering submissions the Adjudicative Committee suspended her licence to ride in races from the conclusion of racing on Thursday, 11 July, until the conclusion of racing on Thursday, 18 July, 4 national riding days.

Race 8 | **ANDREA O'DONNELL PROPERTY BROKERS MAIDEN 1700m**

ALMALANE (M Hashizume) - Slow to begin.

COMMISSION (L Sutherland) - Got its head up when being steadied racing into the first bend.

CHAMPAGNE LINDA (L Allpress) - Taken back from a wide draw to obtain cover shortly after the start.

WHISKEY SOUR (J Allen) - Lay outwards rounding the final bend, placing MIDASWELLBJACK in restricted room.

MIDASWELLBJACK (L Hemi) - Placed in restricted room rounding the final bend.
