Rider **M McNab** did not attend today's meeting as he was still feeling the effects of a recent injury.
 Rider **D Tait** advised Stewards the night before the races she was feeling unwell and would not be attending today's meeting.
 Both riders were advised that a medical clearance is required prior to racing next. Rider replacements were made as per the above Summary.

SUPPLEMENTARY

Riccarton Park–Amberley at Riccarton Park – Saturday 22 June 2024

Race 8 - GRAND NATIONAL TICKETS ON SALE 1400m

ROYAL WINGS (C Barnes) - Connections advised Stewards that following the disappointing performance in this race, a veterinary examination revealed no obvious abnormalities however the mare has now been retired from racing.

RACE COMMENTS

Race 1 | **THE TEA HOUSE RICCARTON PARK MAIDEN 2200m**

RACCOURCI (Y Atchamah) - Slow away.

LET'S GO (C Barnes) - Came under pressure passing the 800 metres and commenced to give ground shortly after, finishing a distant last. When questioned the rider could offer no excuses. A post-race veterinary examination revealed an initial high heart rate but normal recovery.

HIGH PINS (K Kwo) - Raced greenly in the run home and shifted in abruptly passing the 350 metres having to be straightened by the rider.

Race 2 | **THE SHOW GATE RICCARTON PARK MAIDEN 1600m**

J & K Parsons (SPEEDRUN) – Fined \$50 under the Minor Infringement Schedule after presenting SPEEDRUN without notified gear (visor blinkers).

MONTEZUMA (A Najib) - Slow away. Raced keenly in the early stages. Held up early in the straight.

MONTERO (L Callaway) - Raced three wide without cover.

OUR MAN STAN (L Hemi) - Held up rounding the final turn and early in the straight having to shift outwards across heels to obtain clear running passing the 200 metres.

YAMAZAKI (D Cooper) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection YAMAZAKI was confirmed to have bled. YAMAZAKI shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. Trainer D Medcalfe advised Stewards that YAMAZAKI will now be retired from racing.

Race 3 | **GRAND NATIONAL TICKETS ON SALE 1600m**

M Jones (CORRECTION) - Issued with a warning after presenting CORRECTION with unnotified gear (tongue tie).

HAYATE (Y Atchamah) - Slow away. Rider advised that after being slow away the mare had made good ground over the concluding stages finishing less than three lengths from the winner, and he was not disappointed with today's effort.

CATALINA BAY (A Najib) - Slow away.

DEVIL IN DISGUISE (A Goindasamy) - Slow away.

CORRECTION (T Moseley) - Denied a run passing the 350 metres when GIVEALITTLE lay outwards, with CORRECTION then being held up until near the 150 metres.

Race 4 | **CHRISTCHURCH – NZ'S HAPPIEST CITY 1600m**

DA VINCI GIRL (A Najib) - Slow away. Over raced in the middle stages. Held up rounding the final turn until near the 300 metres.

HIGHLAND FLING (K Bakker) - Raced wide without cover until near the 1100 metres.

TOUGH TIME (Y Atchamah) - When racing keenly had to be steadied in the early stages and continued to race keenly through the middle stages.

FATHER LENIHAN (D Cooper) - Raced three wide without cover from the 1000 metres.

A Najib (DA VINCI GIRL) - Severely reprimanded after making contact with a member of the public prior to weighing in.

Race 5 | **ENTAIN – NZB INSURANCE PEARL SERIES RACE MAIDEN 1400m**

PHENOMENAL ROSE (B Murray) - Jumped away awkwardly making contact with PING which was forced onto MUZZLE CAT.

PING (K Mudhoo) - Contacted leaving the barriers.

MUZZLE CAT (L Callaway) - Hampered when crowded leaving the barriers losing ground.

IFF I GET PAAID (A Balloo) - Slow away.

FRIENDOFTHEDEVIL (Y Atchamah) - Unbalanced when contacted by MUZZLE CAT leaving the barriers. Raced three wide without cover.

WISEMEN'S DIVA (A Goindasamy) - Held up rounding the final turn and continued to have difficulty finding clear running until the 200 metres. Rider advised that after being held up the mare had failed to respond to his riding when in clear racing room and had been disappointing.

UGET WHAT YOU GIVE (D Cooper) - Briefly held up in the run home.

WRITTEN OFF (C Barnes) - Rider advised she had had a perfect trip throughout but when placed under pressure in the final straight had been disappointing.

Race 6 | **SPEIGHT'S SUMMIT ULTRA ON TAP MAIDEN 1200m**

DUJOUR (D Cooper) - Jumped away awkwardly making contact with HERE I AM. Raced three wide without cover and was inclined to lay out. Went off stride when jumping a shadow on the track approaching the 400 metres.

HERE I AM (K Williams) - Contacted leaving the barriers.

LEAR JET (Y Atchamah) - When asked to comment on performance, rider expressed disappointment with the mare after having a nice run in the trail for the majority of the race and when placed under pressure failed to respond to his riding.

Race 7 | **CUP WEEK HOSPITALITY ON SALE 1200m**

MISS SAILOR (T Moseley) - Slow away. Crowded onto JOEY'S GIFT passing the 100 metres when VOICE OVER shifted outwards to obtain clear running.

THATS CHARMING (Y Atchamah) - Slow away.

JOEY'S GIFT (K Williams) - Restrained to obtain cover after jumping from the outside barrier. Crowded passing the 100 metres then checked near the 50 metres.

VOICE OVER (D Cooper) - Shifted out passing the 100 metres when looking for clear racing room dictating MISS SAILOR outwards onto JOEY'S GIFT which was contacted. D Cooper was advised to exercise greater care.

Y Atchamah (THATS CHARMING) - Admitted a charge of careless riding in the presence of the Riding Mentor in that he permitted his mount THATS CHARMING to shift inwards when not sufficiently clear of JOEY'S GIFT which was checked near the 50 metres. After considering submissions the Adjudicator imposed a suspension of Y Atchamah's licence to ride in races from the conclusion of racing on Thursday 4 July until the conclusion of racing on Friday 12 July, 6 national riding days.

Race 8 | **NATIONAL BREEDING SALE GAVELHOUSE PLUS ENDS 10/7 1200m**

KABUGEE (A Goindasamy) - Jumped away awkwardly before being further hampered when crowded. Rider reported the gelding which had lost ground at the start had been chasing throughout and was unable to make ground on a fast tempo.

MORE THAN WORDS (R Jaun) - Jumped away awkwardly.

SEVEN TWENTY (Y Atchamah) - Slow away then getting its head up losing ground.

MORMAIRE (T Moseley) - Contacted shortly after the start.

WAR COURT (L Hemi) - Rider reported she was slightly disappointed with the effort, adding that the gelding may not have handled the step up in class today.

Race 9 | **RACECOURSE HOTEL & MOTOR LODGE RATING 65 2200m**

STAR IN THE SKY (A Goindasamy) - Restrained to obtain cover after jumping from the outside barrier.

LINCOLN COUNTY (K Bakker) - Slow away.

DAME COUNTY (B May) - Slow away.

EXTREME POWER (D Cooper) - Raced wide without cover before being ridden forward to sit outside the leader near the 1500 metres.

FLICK THE SWITCH (B Murray) - Gave ground from the 800 metres finishing a distant last, with the rider reporting the mare was less than genuine in its efforts today. A post-race veterinary examination revealed a high heart rate and a slow recovery with a minor eye ailment consistent with getting track kick back in the eye area. Trainer K Shearing advised she would be reassessing the racing future of mare.

MAYBE I'M DREAMING (A Najib) - Raced greenly in the run home being inclined to shift ground throughout the straight and near the 150 metres shifted out abruptly resulting in JAZAN having to steady. Rider was shown a replay of his ride in the home straight in the presence of the Riding Mentor and advised he must keep greater control of his mounts and not let them shift ground as much as he had on this occasion.

JAZAN (K Williams) - Steadied passing the 150 metres. Rider could offer no tangible excuse for the disappointing performance other than she had been left flat footed when the pace increased.
