Race 1 CAMBRIDGE EQUINE HOSPITAL MAIDEN 1550

OUR BO JAKK (B Rogerson) - Slow to begin.

SPECTRIER (V Colgan) - Slow to begin

**ONEFORTHEGIRLS** (K Asano) - Slow to begin.

**VILETTE** (M Hashizume) – Restrained at the start to obtain cover from the outside barrier.

**ELECTRON** (B Grylls) - Raced keenly through the early stages.

**CLUTHA** (B Jacobson) - Over-raced through the early stages.

GEE FORCE (S Spratt) - Raced wide without cover throughout.

EL AMOR (M McNab) - Held up for clear running throughout the final straight.

**ESFERA CELESTE** (T Newman) - Had some difficulty obtaining clear running in the final straight.

## Race 2 GROUP ONE TURF BAR 1550

**STONYBRECK** (M McNab) - Slow to begin. Steadied when placed in restricted room to the outside of WITH YOU and inside of ORANGE PEARL which was shifting inwards near the 150 metres.

HASSTOBEPERFECT (W Kennedy) - Began awkwardly.

**ROCKET LAD** (C Barnes) – Slow to begin. Raced wide without cover from near the 1000 metres.

SIDE EYE (T Mitchell) - Raced keenly through the early stages.

WITH YOU (K Asano) - Checked when placed in restricted room near the 150 metres.

**URBAN MYTH** (M Hashizume) - When questioned regarding the performance rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

A Lawson-Carroll (ORANGE PEARL) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when insufficiently clear of STONYBRECK which was dictated inwards having to be steadied, and WITH YOU which had to be checked near the 150 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 29 June up to and including racing on Sunday 7 July, 6 national riding days.

## Race 3 ASCOT FARM MAIDEN 1300

**EVANA TRUMPALOT** (S Weatherley) - Began awkwardly losing ground. Lay in rounding the final bend and in the straight.

BILLY PEACH (J Fawcett) - Slow to begin.

**DIVINE ESSENCE** (M Hashizume) – Raced wide without cover throughout.

**MOHI PLACE** (V Colgan) - Raced wide without cover through the early stages. Checked near the 200 metres to avoid the heels of DECRETO DE GUERRA which shifted outwards when insufficiently clear. Had difficulty obtaining clear running for the remainder of the straight.

RICHIE'S DREAM (K Myers) - Held up for a majority of the straight going to the line untested.

**C Barnes** (DECRETO DE GUERRA) - Admitted a charge of careless riding in that she permitted her mount to shift outwards when insufficiently clear of MOHI PLACE which had to be checked near the 200 metres. After considering submissions the Adjudicator imposed a suspension of C Barnes' licence to ride in races from the conclusion of racing on Saturday 29 June up to and including racing on Thursday 4 July, 3 national riding days.

#### Race 4 ENTAIN/NZB INSURANCE PEARL SERIES 1300

PAX MUNDI (S Weatherley) – Restrained to obtain cover in the early stages from the outside barrier. Held up for clear running rounding the final bend and throughout the straight. Underwent a post-race veterinary examination which did not reveal any abnormality. Stewards questioned S Weatherley regarding his riding tactics adopted through the middle stages and in the final straight. S Weatherley explained that his instructions were to ride the filly in a conservative manner through the early and middle stages from the outside barrier. He said his mount has a tendency to over-race so did not want to push her forward and be three wide in a six horse field. He further explained that he was placed inside the heels of MY CHABLIS throughout and would have had to pull back and lose three lengths to get to the outside of that runner, which he believed would not have benefitted the filly as she was travelling well. Once in the final straight S Weatherley added he was out of options both to his inside and outside, and riding for luck had not panned out. Trainer T Pike confirmed the riding instructions. Stewards noted S Weatherley's explanation.

**CARRINGTON** (J Fawcett) - Raced ungenerously through the early and middle stages getting its head up.

MY CHABLIS (C Barnes) - Raced three wide without cover throughout.

## Race 5 SHAW'S WIRE ROPES 1300

**ULTIMATE FOCUS** (C Barnes) – Began awkwardly losing ground.

**ALFRISTON** (T Mitchell) – Began awkwardly. Raced keenly through the early and middle stages.

FELIX FAURE (A Lawson-Carroll) - Began awkwardly. Raced wide without cover through the middle stages.

**DRIFTIN** (W Pinn) - Held up rounding the final bend and early in the straight.

**BRYNDERWYN** (S Weatherley) – Lay inwards when placed under pressure in the final straight.

## Race 6 THE OAKS STUD MAIDEN 1300

**SAKURAJIMA** (J Fawcett) - Began awkwardly losing ground.

MARCOS (K Asano) - Slow to begin.

**EIGHT LUCKY PRAWNS** (S Weatherley) - Restrained to obtain cover in the early stages from the outside barrier. Raced wide without cover from the 800 metres.

**TOA TUAHINE** (V Colgan) – Raced keenly in the early stages.

BEE ON TIME (M Hashizume) - Held up until near the 100 metres.

**PARADISE THUNDER** (S Spratt) - When questioned regarding the performance rider advised that the gelding may not have been suited by the synthetic track conditions.

#### Race 7 MANNING INVESTMENTS LTD MAIDEN 970

**ROC ON HOME** (S Brown) - Over-raced through the early and middle stages. Lay outwards rounding the final turn and continued to do so when placed under pressure in the final straight.

**BRILLIANT COLOUR** (T Mitchell) - Restrained near the 800 metres to obtain cover, commencing to race ungenerously for a distance.

**BOXMOSS** (W Kennedy) – Briefly steadied when placed in restricted room to the inside of BRILLIANT COLOUR near the 750 metres.

## Race 8 GARRARD'S HORSE & HOUND 2000

**GIN GIN** (J Fawcett) - Began awkwardly losing ground. Became detached from the body of the field through the middle stages, despite the efforts of its rider.

KAAPTIVATING (R Goyaram) - Raced keenly when being steadied in the early stages.

BIEDERMEIER (C Barnes) - Slow to begin.

**THE GREEN KEEPER** (M Hashizume) – Raced wide without cover through the early stages.

**POW TONG** (S Weatherley) - Steadied passing the 1650 metres when CON ARTIST shifted inwards. Held up rounding the final bend.

**HUTSON** (B Rogerson) - Held up until passing the 100 metres.

IRRIGATE (T Newman) - Held up until near the 100 metres.
