T Mitchell did not attend today's race meeting after advising Stewards on race morning that she was unwell. T Mitchell is to provide a medical clearance prior to riding next.

There was a miscommunication prior to scratching time this morning between the Club and NZTR regarding the rainfall in the last 24 hours with the correct figure being 9 mls which was updated on the NZTR website prior to the running of Race 1.

RACE COMMENTS

Race 1 SHANE BATTEN ELECTRICAL 1100

PIPPY (S Spratt) - Removed from the barriers after becoming fractious to undergo a veterinary examination being late scratched at 11.26 am.

MASTER BRUTUS (O Bosson) - Crowded at the start.

LOVE AFFIRMATIONS (W Kennedy) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

QUARTZ QUEEN (J Allen) – Raced keenly through the early and middle stages. Lay in when placed under pressure early in the final straight.

PATRICIA (A Goindasamy) – Raced three wide without cover throughout.

Race 2 TRIGG CONSTRUCTION MAIDEN 1600

MITONIC (A Lawson-Carroll) – Raced three wide without cover throughout.

SHOW ME LOVE (V Colgan) – Began awkwardly losing ground. Held up for clear running early in the final straight.

WYE VALLEY (C Barnes) - Began awkwardly losing ground.

KING WILLIAM (S Spratt) – Began awkwardly losing ground. Attempted to improve into a marginal run making contact with FLAMBOYANCE rounding the final bend. Rider S Spratt was advised to exercise greater care in similar circumstances.

CANULOVEMEAGAIN (A Goindasamy) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

FLAMBOYANCE (O Bosson) – Contacted rounding the final bend.

MAPALICIOUS (M McNab) - Held up for clear running until approaching the 200 metres.

KISZKAH (W Kennedy) - Rider advised that the mare never travelled throughout the running.

Race 3 MARSDEN COVE DENTAL 1600

THE MASTER (N Hailey) - Slow to begin. Jostled for a position with SAYAN through the middle stages. Riders N Hailey and T Moodley were shown the replays in the presence of the riding mentor. N Hailey was spoken to advisedly for the manner in which he rode through the middle stages.

SUPA GET (T Newman) - Began awkwardly then crowded shortly after losing ground.

AQUA MAN (S Brown) - Slow to begin. Raced in restricted room passing the 100 metres.

SAYAN (T Moodley) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Jostled for a position with THE MASTER through the middle stages.

MISCHIEF MANAGED (M McNab) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

HEART OF ALLADIN (J Fawcett) - Restrained to obtain cover in the early stages after jumping from a wide barrier. When questioned regarding the seemingly improved performance trainer advised that the gelding had been racing better than its form line suggested and expected a forward showing.

SHOCKATILLATAP (N Parmar) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

ANNA TAIT (K Myers) - Raced keenly through the early stages.

PILLAR OF SOCIETY (B Jacobson) – Raced three wide without cover throughout.

MIGHTY CASTLE (S Spratt) - Had to be steadled off the heels of AQUA MAN which shifted ground outwards when not fully clear entering the final straight. Apprentice rider S Brown was advised to exercise greater care in similar circumstances. Had difficulty obtaining clear running for the majority of the final straight.

CIAMBELLA (W Kennedy) - Raced in restricted room approaching the 100 metres having to be steadied by its rider.

MEGA MOGUL (O Bosson) - Lost the left front plate during the running.

Race 4 PORTHOUSE BAR EATERY BREAM BAY SPRINT 1400

SIDE EYE (T Moodley) - Began awkwardly.

NEW YORK JAZZ (T Newman) - Slow to begin. Raced three wide without cover throughout.

NO AGENDA NIGEL (J Nishizuka) - Slow to begin.

MALT TIME (A Lawson-Carroll) - Began awkwardly.

SHAMUS (J Fawcett) - Raced keenly through the early and middle stages.

URBAN MYTH (N Parmar) - Raced wide without cover throughout. When questioned regarding the performance rider advised that the gelding over-raced during the running which proved detrimental to its chances.

CHEVRON (M McNab) - Lost the near front plate during the running.

Race 5 DALTONS BREAM BAY CUP 2100

CIMARRON (W Kennedy) - Slow to begin.

BOSCH (C Barnes) - Raced wide without cover before improving to race outside the leader near the 1400 metres.

MALFY ROSA (A Lawson-Carroll) – Lay inwards when placed under pressure in the final straight.

TAWI (J Fawcett) – Inconvenienced near the 400 metres when MALFY ROSA shifted outwards.

ENRIGHT (K Myers) – Trainer S Manning advised that the gelding would now be sent for a spell.

W Kennedy (CIMARRON) - Was reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit after narrowly holding onto 4th place on this occasion.

Race 6 MARSDEN METALS GROUP 1400

CINTIVEE (M McNab) - Slow to begin. Made the bend near the 600 metres awkwardly. Lay outwards when placed under pressure passing the 100 metres having to be corrected by its rider.

BOUND TO BE (W Kennedy) - Slow to begin. Improved onto heels having to be steadied approaching the 1200 metres. Had difficulty obtaining clear running early in the final straight.

DANCING DREAM (T Moseley) - Crowded at the start. Raced keenly through the early and middle stages. Held up rounding the final bend and early in the straight.

TIDE AND TIME (K Myers) - Hampered at the start.

LA PARISIENNE (A Lawson-Carroll) - Saddle slipped forward in the early stages placing the rider at a disadvantage.

FULL NOISE (T Moodley) – Raced keenly through the early and middle stages having to be steadied off heels passing the 1000 metres.

DIOR SAUVAGE (S Spratt) - Raced three wide without cover throughout. Had to be briefly steadied near the 50 metres when placed in restricted room when CINTIVEE lay outwards. Rider M McNab was advised to exercise greater care in similar circumstances.

K Rae & K Williams (DANCING DREAM) - Issued with a warning for presenting DANCING DREAM late to the birdcage.

Race 7 STORAGE BREAM BAY 1200

VEGAS QUEEN (N Parmar) - Began awkwardly losing ground. Raced wide without cover throughout.

JUST LIKE THIS (A Goindasamy) - Slow to begin. Raced greenly throughout.

CHICAGO DREAM (N Hailey) - Began awkwardly. Over-raced through the early and middle stages. Raced three wide without cover throughout.

PATSY'S DREAM (T Moseley) – Over-raced through the early and middle stages. Not persevered with in the final straight when out of contention.

ELEGANT JAZZ (B Grylls) - Raced keenly through the early stages making the bend near the 800 metres awkwardly.

I'M ALL IN (W Kennedy) - Raced keenly through the early and middle stages.

SUPER ROSA (K Myers) - Had to be steadied off heels when racing keenly near the 900 metres. Hung outwards from the 600 metres.

MAGICE (J Fawcett) - Held up rounding the final bend and early in the straight before shifting outwards to obtain clear running passing the 300 metres.

Race 8 ROOFING SPECIALISTS NORTHLAND 1200

STERLING EXPRESS (W Kennedy) - Slow to begin. Held up until near the 200 metres.

BALLS OF FIRE (J Allen) – Raced keenly through the early and middle stages.

HADID (S Brown) - Lay outwards when placed under pressure in the final straight. Rider advised that the bit became displaced placing her at a disadvantage over the final 100 metres.

TU MEKE POTAE (A Lawson-Carroll) - When questioned regarding the performance rider advised that the gelding peaked on its fresh up run and would derive benefit from today's race.

Race 9 MARSDEN MARINE SUPPLIES 1600

MODERNISE (N Hailey) - Slow to begin. When questioned regarding the performance rider advised that the mare got further back in the run than intended and he was satisfied with the manner in which it closed off the race.

CONFIANCE (W Kennedy) - Crowded shortly after the start losing ground.

GRACE 'N' GLORY (J Fawcett) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

NAVY CHIEF (T Moodley) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

CON ARTIST (B Jacobson) - Raced keenly through the early and middle stages.

HE'S PLATINUM (S Spratt) - Raced keenly through the early and middle stages. Steadied off heels near the 1000 metres. Lay out and away from I'M LULU near the 300 metres which resulted in HASSTOBEAWINNER being forced wider on the track.

I'M LULU (N Parmar) – Lay outwards rounding the final bend and continued to do so when placed under pressure in the final straight. Rider advised that the mare hung outwards in the final straight placing him at a disadvantage.

ALADDIN SANE (V Colgan) – When questioned regarding performance the rider advised that the gelding never travelled throughout the running. Underwent a post-race veterinary examination which revealed no abnormalities. Stewards will follow up with connections in the coming days.

N Bishara (NAVY CHIEF) - Issued with a Minor Infringement and fined \$150 after presenting NAVY CHIEF to race with worn plates, having to be re-plated.

N Parmar (I'M LULU) - Issued with a warning after allowing his mount to shift inwards when not fully clear of HE'S PLATINUM which had to be steadied off heels near the 1000 metres.

J Nishizuka (SPICEY LAD) - Admitted a charge in that he struck his mount eight times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.
