H McNeill – Issued with a minor infringement and fined \$100 pursuant to Rule 352 in that he used a mobile phone whilst mounted on a horse at Te Aroha Racecourse on Wednesday 29 May.

RACE COMMENTS

Race 1

THE GRAND TAVERN MAIDEN HURDLE 3100

GO BUTCH (J Parker) - Raced wide through the early and middle stages.

UNCLE CHARLIE (K Wiles) - Misjudged the fence near the 1300 metres.

CIVIL UNREST (C Wiles) – Retired from the race near the 400 metres when out of contention.

JOLLY MOLLY (P Matthews) - Retired from the race near the 400 metres when out of contention.

CHANCELLOR (M Roustoby) – Misjudged the fence near the 400 metres and fell on landing dislodging its rider. M Roustoby was attended to by St John Ambulance personnel and found to be uninjured. Underwent a post-race veterinary examination which revealed no abnormality. Lost the right fore plate during the running.

TE KAHU (S Karnicnik) - Hampered by a fallen runner near the 400 metres.

SALVIN (A Roustoby) – Put in a poor jump at the second to last fence.

MONT VENTOUX (N Downs) – Stumbled on landing after jumping the last fence.

Race 2

TAJC HOSPITALITY MAIDEN HURDLE 3100

MANUKA (S Karnicnik) - Slow to begin. Landed awkwardly after jumping the fence near the 400 metres.

HELENA BABY (N Downs) – Raced keenly through the early and middle stages when leading. Misjudged the fence near the 1000 metres. Landed awkwardly after jumping the fence near the 400 metres.

QUAFF (A Roustoby) – Retired from the race near the 800 metres. Trainer S Cameron advised that the gelding would now be retired from racing. Underwent a post-race veterinary examination which revealed no abnormality.

MUSE (K Wiles) - Hit the second to last fence and fell, dislodging its rider. K Wiles was attended to by St John Ambulance personnel and stood down from his remaining engagements. Underwent a post-race veterinary examination including an endoscopic examination which revealed a wound on the inside of the left nostril.

BROTHER MAX (M Roustoby) – Hampered by a fallen runner near the 200 metres.

ROCEM (P Matthews) - Hit the last fence and blundered badly on landing losing ground.

H McNeill (IMPERIAL PARTY) - Issued with a minor infringement and fined \$300 after failing to weigh in on IMPERIAL PARTY. A request for ruling was filed with the Adjudicative Committee with IMPERIAL PARTY being disqualified from the race after H McNeill failed to weigh in.

Race 3

P & J BROSNAN TRAINING 0-1 WIN HURDLE 3100

BANKS ROAD (A Roustoby) – Slow to begin. Retired from the race near the 400 metres when out of contention. Underwent a post-race veterinary examination which revealed no abnormality.

GALILEO INVADER (H McNeill) – Raced keenly through the early stages.

SMUG (S Karnicnik) - Hit the fence near the 2200 metres and dipped on landing, unbalancing its rider.

METALLO (P Matthews) - Misjudged the fence near the 1300 metres. Ran down the fence near the 1000 metres.

THE BAMBINO (M Roustoby) - Misjudged the fence near the 1000 metres.

GINGER TOO (C Wiles) - Retired from the race near the 400 metres when out of contention. Underwent a post-race veterinary examination which revealed no abnormality.

Race 4

NZB NATIONAL WEANLING SALE 2024 MAIDEN 1400

SALUTO (M NcNab) - Stood flat footed when the start was effected losing ground (3L).

NAVY BLUE (C Barnes) - Began awkwardly losing ground.

LED A MERRY DANCE (V Colgan) - Came together with TROUVAILLE near the 300 metres.

TROUVAILLE (O Bosson) - Came together with LED A MERRY DANCE near the 300 metres.

I'M PEDRO (S Weatherley) - Lay outwards having to steady across the heels of LED A MERRY DANCE near the 300 metres and continued to lay outwards throughout the final straight.

Race 5

SILVER FERN FARMS MAIDEN STEEPLECHASE 3500

PONTARDAWE (A Roustoby) - Landed awkwardly after jumping the first fence unbalancing its rider who was dislodged. A Roustoby was attended to by St John Ambulance personnel and found to be uninjured. Underwent a post-race veterinary examination which revealed no abnormality.

SWEET TABOO (J Parker) - Run off by the riderless horse after jumping the first fence and was retired from the race.

IMA WONDER (P Matthews) - Hampered by the riderless horse after jumping the first fence.

AL'S RED ZED (H McNeill) - Misjudged the fence near the 600 metres. Retired from the race near the 600 metres when out of contention. Underwent a post-race veterinary examination which found the gelding to have suffered cardiac arrhythmia. Connections were advised that AL'S RED ZED will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres. Connections advised that the gelding would now be retired from racing.

Following the race connections of the second placed runner viewed video footage of the concluding stages before electing not to proceed with a protest.

Race 6

EPIC JOURNEYS USA/CANADA 2025 MAIDEN 1400

QUILL (A Lawson-Carroll) – Co-trainer S Clotworthy was given permission to race QUILL without the notified blinkers today due to the track conditions.

BORGHINI (B Jacobson) - Slow to begin.

HE'S SO FINE (W Pinn) – Over-raced through the early and middle stages causing its rider difficulty.

POKURU SHOW (K Asano) - Over-raced through the early and middle stages. Went off stride near the 600 metres.

RESERVED (S Spratt) - Steadied near the 700 metres after improving into restricted room to the inside of LINKIN PARK and outside of GENIEINABOTTLE. Shifted outwards near the 400 metres to obtain clear running.

POETIC JUSTICE (M McNab) - Lay inwards when placed under pressure in the final straight.

Race 7 TE AROHA VETERINARY SERVICES TE AROHA CUP 2200

The start of this race was delayed by 3 minutes at the request of TAB race day control.

RUA ROCKS (J Allen) - Began awkwardly.

RODOLFO (C Barnes) – Slow to begin.

PACHECO (N Hailey) – Raced keenly through the early and middle stages.

DEEBEE BELLFER (W Pinn) - Lost the near hind plate during the running. When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormality.

MARGARET JEAN (M McNab) - When questioned regarding the performance rider advised that the mare may benefit from the addition of a tongue tie.

Race 8 TE AROHA VETERINARY SERVICES BIG DAY OUT 1300

FONTEYN (T Mitchell) - Began awkwardly losing ground.

PIER (S Weatherley) – Crowded shortly after the start having to be steadied shifting outwards across the heels of TEVERE passing the 1200 metres. Raced keenly through the early and middle stages.

Race 9 WEBSITE ANGELS 1600

THREE NINETY (A Lawson-Carroll) - Slow to begin.

LEICALOT (M Sanson) - Slow to begin.

EL NYMPH (S Weatherley) - Improved onto heels having to be steadied near the 1300 metres.

DIOMEDES (N Hailey) - Raced keenly through the early stages. Lay outwards when placed under pressure contacting GIGI near the 200 metres.

GIGI (T Moodley) - Contacted near the 200 metres.

AFTER PARTY (S Spratt) - Underwent a post-race veterinary examination including an endoscopic examination at the request of the trainer which revealed no abnormality.

FAMILY TIES (J Allen) - When questioned regarding the performance the rider could offer no explanation.

Race 10 SADDLERY WAREHOUSE MAIDEN 1600

TIME TO WONDER (K Myers) - Slow to begin.

KAURI LANE (B Jacobson) – Began awkwardly losing ground. Raced keenly in the early stages. Became detached from the body of the field passing the 700 metres. When questioned regarding the performance the rider could offer no explanation.

EMBEZZLER (N Hailey) - Inconvenienced near the 200 metres when AU REVOIR lay out under pressure.

AU REVOIR (N Parmar) - Improved into restricted room having to be steadied near the 100 metres.

LADY GREY (S Spratt) – Lost the right fore plate during the running.

KIWI BOY (B Grylls) - When questioned regarding the performance the rider could offer no explanation.
