Race 1	WIN A HILUX WITH PROPERTY BROKERS 1600m
<p>LILY OF THE VALLEY (B May) - Slow away.</p> <p>BAUBLE (C Campbell) - Restrained to obtain cover in the early stages.</p> <p>CLASSIC DIVA (B Rogerson) - Restrained to obtain cover in the early stages.</p> <p>LEAVE IT TO ME (D Tait) - Raced three wide without cover. When questioned regarding performance, rider advised in her opinion the gelding may be feeling the effects of recent racing. Trainer J Dalton indicated that LEAVE IT TO ME would now be sent for a spell.</p> <p>ALBATROSS (K Williams) - Lay inwards under pressure in the straight with MISS PEARL shifting away from that runner passing the 200 metres.</p> <p>MISS PEARL (S Wynne) - Shifted inwards away from ALBATROSS passing the 200 metres.</p>	
Race 2	GRAND CASINO 1200m
<p>STREET FIGHTIN MAN (A Balloo) - Jumped inwards at the start making heavy contact with ON SONG which lost ground. Lay inwards under pressure in the straight.</p> <p>ON SONG (D Cooper) - Heavily contacted at the start losing ground. Raced three wide without cover.</p> <p>CHOUX MACHER (K Bakker) - Slow away. Hung outwards rounding the turn and in the straight and was unable to be ridden out by its rider.</p> <p>ATOMIC (R Muniandy) - Jumped away awkwardly making contact with the hindquarters of ZACAT then being further hampered when crowded losing ground.</p> <p>ZACAT (S Wynne) - Contacted at the start.</p> <p>SASSMAN (L Callaway) - Over raced when being restrained in the early stages. Lay inwards under pressure in the straight.</p>	
Race 3	SPEIGHTS 1200m
<p>GUNNAR (T Jonker) - Blundered badly leaving the barriers dislodging its rider. T Jonker was attended to by St John personnel and found to be uninjured.</p> <p>I HOPE I NEVER (R Muniandy) - Restrained to obtain cover after jumping from the outside barrier.</p> <p>VICTOR ROUGE (D Tait) - Raced three wide without cover.</p> <p>EFOREFFORT (K Williams) - Eased down by its rider early in the straight being retired from the race. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection EFOREFFORT was confirmed to have bled. EFOREFFORT shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. Co-trainer M Pitman advised that EFOREFFORT would now be retired from racing.</p> <p>AVITUS (A Balloo) - Contacted by the riderless horse near the 300 metres.</p>	

GAME DUKE (G Jogoo) - Rider dropped his whip passing the 100 metres.

R Muniandy (I HOPE I NEVER) - Issued with a warning after weighing in 0.7 kg in excess of the weight at which he had weighed out.

Race 4 | **KADE'S RESTAURANT 1100m**

CLOCHE (K Williams) - Jumped away awkwardly losing ground.

LITTLE BUT FIERCE (A Goindasamy) - Steadied when placed in restricted room to the inside of GLADIUS which lay in going into the bend near the 850 metres. Held up when improving onto the heels of GLADIUS rounding the turn passing the 400 metres.

FAH RONG (A Balloo) - Lay in making contact with the hindquarters of IMPTEE going into the bend near the 850 metres then after being corrected clipped a heel of MAMAEA which shifted inwards.

MAMAEA (Y Atchamah) - Raced wide without cover.

IMPTEE (L Hemi) - Contacted approaching the 850 metres. Raced very greenly under pressure in the straight.

Y Atchamah (MAMAEA) - Admitted a charge of careless riding in that he permitted his mount MAMAEA to shift inwards when not sufficiently clear of FAH RONG which clipped a heel near the 850 metres. After considering submissions the Adjudicator imposed a suspension of Y Atchamah's licence to ride in races from the conclusion of racing on Sunday 9 June until the conclusion of racing on Wednesday 19 June, 4 national riding days.

Race 5 | **THE MOSGIEL TAVERN 2200m**

LOFTYS GIFT (D Cooper) - Slow away. Was inclined to shift ground under pressure in the straight.

SADLER'S LASS (R Muniandy) - Slow away.

PROSERVE (K Williams) - Checked to avoid heels near the 1900 metres. Was inclined to lay inwards under pressure in the straight placing PAR TEE in restricted room passing the 150 metres with outward movement from LOFTYS GIFT contributing to this incident. K Williams was advised to exercise greater care.

LEITRIM LAD (B Rogerson) - Steadied to avoid heels near the 1900 metres. Checked near the 175 metres.

HEIDI HI (B May) - Steadied to avoid heels near the 1900 metres. Lay out under pressure making contact with LOFTYS GIFT which was also shifting ground near the 175 metres.

PAR TEE (S Wynne) - Steadied when placed in restricted room for a distance passing the 150 metres.

L Callaway (LOVELOCK) - Issued with a warning after permitting his mount LOVELOCK to shift inwards near the 1900 metres when not fully clear of LEITRIM LAD which had to steady and shift outwards to avoid heels. As a result LOFTYS GIFT also had to steady to avoid the heels of LEITRIM LAD and shifted inwards into the line of PROSERVE which was checked.

D Cooper (LOFTYS GIFT) - Admitted a charge of careless riding in that he permitted his mount LOFTYS GIFT to shift inwards when not sufficiently clear of LEITRIM LAD which was checked passing the 175 metres. After considering submissions the Adjudicator imposed a suspension of D Cooper's licence to ride in races from the conclusion of racing today Sunday 2 June until the conclusion of racing on Wednesday 12 June, 6 national riding days.

S Wynne (PAR TEE) - Defended a charge in that she failed to ride her mount out to the end of the race when there was a reasonable chance of finishing in fourth position. After viewing films and hearing submissions the Adjudicator found the charge to be proven and imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Sunday 9 June until the conclusion of racing on Friday 21 June, 6 national riding days.

Race 6 | **POSITIVE SIGNS + PRINT 2200m**

SILK 'N' DALE (B Rogerson) - Began awkwardly before being further hampered when crowded losing ground. Had to be steadied away from heels near the 1600 metres, then being inclined to race keenly through the middle stages.

HALLELUJAH BROTHER (R Muniandy) - Struck a heel and blundered near the 1900 metres.

TELLME YOU LOVEME (D Cooper) - Raced three wide without cover from the 900 metres.

THEODEN (C Campbell) - Was inclined to shift ground under pressure in the straight.

COSY NOOK (L Hemi) - A post-race veterinary inspection found the gelding to be suffering from the Thumps.

TWILIGHT GEM (A Goindasamy) - Lost the right hind plate during the running.

L Hemi (COSY NOOK) - Admitted a charge of careless riding in that she permitted her mount COSY NOOK to shift inwards when not sufficiently clear of TELLME YOU LOVEME which was dictated into the line of HALLELUJAH BROTHER which struck a heel and blundered near the 1900 metres. After considering submissions the Adjudicator imposed a suspension of L Hemi's licence to ride in races from the conclusion of racing on Sunday 9 June until the conclusion of racing on Wednesday 19 June, 4 national riding days.

Race 7 | **DUNEDIN CITY MOTORS 1400m**

BURNVUE (A Goindasamy) - Jumped away awkwardly. Lay inwards under pressure in the straight.

GO LOTTE (Y Atchamah) - Crowded shortly after the start.

GOODANYA (T Jonker) - Slow away.

THE HANGOVER (D Cooper) - Over raced when being restrained in the lead in the early to middle stages.

MIDNIGHT RUNNER (R Muniandy) - Checked near the 150 metres.

A Goindasamy (BURNVUE) - Admitted a charge of careless riding in that he permitted his mount BURNVUE to shift inwards when not sufficiently clear of MIDNIGHT RUNNER which was checked near the 150 metres. After considering submissions the Adjudicator imposed a suspension of A Goindasamy's licence to ride in races from the conclusion of racing on Sunday 9 June until the conclusion of racing on Thursday 20 June, 5 national riding days.

Race 8 | **NELLIES RESTAURANT & BAR 1400m**

VALYRIAN (D Cooper) - Slow away. Steadied after becoming awkwardly placed inside the heels of ABIT SASSY approaching the 1000 metres. Lay outwards under pressure in the straight.

SAVABOURBON (R Muniandy) - Slow away.

STOP YELLING (S Wynne) - Jumped away awkwardly hampering BLEAKHOUSE BURTIE.

BLEAKHOUSE BURTIE (A Goindasamy) - Hampered leaving the barriers. Raced wide throughout.

FREEDOM REINS (K Williams) - Raced wide without cover.

BOURBON CHIQUE (C Campbell) - Lay inwards under pressure in the straight.

Race 9

BE MY GUEST DESIGN 1400m

PURE ZAMBEZI (L Hemi) - Jumped away awkwardly then being steadied shortly after the start.

TOBLERONE (Y Atchamah) - Bounded at the start.

MAGIC ACE (S Wynne) - Jumped away awkwardly.

ROYAL WINGS (K Bakker) - Restrained to obtain cover after jumping from a wide barrier.

CHEYENNE DREAMS (D Subramaniam) - Steadied to avoid the heels of DELMONICO (T Moseley) which shifted inwards when not fully clear near the 1100 metres. T Moseley was advised to exercise greater care.

THE IMMIGRANT (K Williams) - Inconvenienced near the 300 metres when DELMONICO shifted outwards under pressure. Hampered near the 200 metres when LA OPCION (D Tait) shifted inwards under pressure before being corrected by its rider. D Tait was advised to exercise greater care. Also inconvenienced as a result was DELMONICO, MININJAGIRL and SHEJENGAR.

DELMONICO (T Moseley) - Inconvenienced near the 200 metres.

MININJAGIRL (A Balloo) - Inconvenienced near the 200 metres.

SHEJENGAR (K Mudhoo) - Inconvenienced near the 200 metres.

Race 10

RAY KEAN – PROPERTY BROKERS 1600m

CULLINAN (K Bakker) - Slow away.

AMALFI COAST (L Hemi) - Slow away.

GABBY DIAZ (C Campbell) - Jumped away awkwardly then being restrained to obtain cover.

ABRUZZI (S Toolooa) - Hung outwards throughout.

EXPLOSIVE LASS (A Balloo) - Raced wide without cover.

PLEASUREPAIN (B May) - Raced wide without cover. Raced in restricted room over the concluding stages having to be steadied away from heels.

SMOOTH OPERATOR (K Williams) - Lay inwards under pressure in the straight.

THE RED KRACKEN (K Kwo) - Was not persevered with in the final straight finishing a distant last. When questioned regarding performance, rider advised that the gelding had been quicken beaten once placed under pressure and felt there may have been something amiss. A post-race veterinary inspection found the gelding to have a slow rate of recovery requiring further investigation, with a veterinary clearance required prior to racing again.

ANGELISTIC (K Mudhoo) - When questioned regarding performance, rider advised that the mare had not felt comfortable in today's track conditions.
