## **SUPPLEMENTARY**

Race 2 BRAESIDE FARM MAIDEN HURDLE 3000m

**JESKO (S Fannin)** – Co-trainer Mr. S Fannin reported to Stewards, the stable was satisfied with the post-race condition of JESKO, and it is their intention to carry on with the gelding's current preparation.

#### **RACE COMMENTS**

Race 1 FEILDING JOINERY & SPRAY SPECIALIST LTD MAIDEN 1000m

**KAROSHI** (A Mudhoo) - Declared a late scratching at 12.44pm after refusing to load. Trainer J Bary was advised KAROSHI is required to barrier trial to the satisfaction of Stewards prior to racing next. Connections advised the mare's future will be reassessed.

IT'S AMELIA (J Doyle) - Slow away.

KOROLOVA (W Kennedy) - Restrained at the start to obtain cover. Over-raced in the early stages.

**GOOD CRAIC** (C Dell) - Raced three-wide throughout.

#### Race 2 TOWNSHENDS JOINERY 1000m

PACE ATTACK (L Hemi) - Slow to begin.

**ALFRISTON** (T Mitchell) - Restrained to the rear to obtain cover.

**THATZ DAISY** (A Lawson-Carroll) - Raced wide throughout. Commenced to weaken from the 350 metres, finishing a distant last. Rider reported the mare to failed to "put-in" today and was also of the opinion the mare was not entirely comfortable on the synthetic surface. A post-race veterinary examination did not reveal any obvious abnormality.

#### Race 3 TOMO'S ALUMINIUM SERVICES MAIDEN 2140m

TIKEMYSON (L Allpress) - Began awkwardly. Improved three-wide from the 1000 metres.

CAME SAW CONQUERED (A Mudhoo) - Slow to begin.

**VERARDINO** (J Riddell) - Slow to begin.

ON ALERT (S O'Malley) - Restrained to obtain cover. Made the bend into the back straight awkwardly.

**ZEBADAYA** (J Chung) - Three-wide in the early and middle stages.

## Race 4 GARY DYER PAINTERS AND DECORATORS 2140m

**GURTLYN** (A Mudhoo) - Began awkwardly, losing ground.

**JUSTASKPERCY** (L Kauri) - Slow away. Shifted outwards near the 250 metres when not clear of HAYATE, which was checked.

**PLATINUM SIXTY SIX** (J Riddell) - Restrained from a wide draw to obtain cover.

**BUBBAJOCK** (T Newman) - Raced three-wide in the early stages.

**HAYATE** (W Kennedy) - Held up rounding the final turn. Checked near the 250 metres when JUSTASPERCY shifted outwards when not clear.

**L Kauri** (JUSTASKPERCY) - Admitted a charge of careless riding in that he permitted his mount JUSTASPERCY to shift outwards when not sufficiently clear of HAYATE, which was checked near the 250 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 8 June, until the conclusion of racing on Wednesday, 19 June, 5 national riding days.

## Race 5 PRYDA MAIDEN 1400m

MISS ROSIE (L Allpress) - Began awkwardly, bumping I AM JAZZ.

I AM JAZZ (J Doyle) - Bumped at the start.

**LADY ANGLESEA** (T Mitchell) - Over-raced through the early stages. Came together and bumped with DARE 'N' DUCHESS entering the home straight.

**BRYAN'S LEGACY** (K Hercock) - Commenced to over-race near the 900 metres, having to be heavily restrained off the heels of VEE VEE.

DARE 'N' DUCHESS (T Newman) - Came together and bumped with LADY ANGLESEA entering the home straight.

#### Race 6 CARTERS 1400m

SHARE POWER (J Chung) - Over-raced when wide in the early stages.

**BEE ENCHANTED** (J Riddell) - Began awkwardly, contacting HEMI RIDAPEST, which in turn contacted MEDIA MISS, which lost ground.

HEMI RIDAPEST (A Lawson-Carroll) - Contacted at the start. Steadied near the finish.

MEDIA MISS (J Doyle) - Contacted at the start, losing ground.

NARINCE (A Mudhoo) - Slow away.

**BUENOS DIAS** (K Hercock) - Underwent a pre-race veterinary examination after loosening a tooth behind the barrier and was cleared to start. Disappointed, finishing well back. K Hercock advised that in her opinion the gelding may be unsuited to the synthetic surface but also displayed a respiratory issue and recommended to connections that a tongue-tie be applied prior to its next start. A post-race veterinary examination did not reveal any obvious abnormality.

**L Kauri** (DOUBTFUL SOUND) - Shown footage of his ride in the presence of the Apprentice Mentor and issued with a warning after allowing his mount to shift in near the finish when not sufficiently clear of HEMI RIDAPEST, which had to steady.

### Race 7 HENRY'S PLUMBING LTD & DESIGN BUILDERS 1200m

LINCOLN'S KRUZ (A Lawson-Carroll) - Began awkwardly, bumping STONYBRECK.

STONEYBRECK (J Riddell) - Bumped at the start. Raced wide in the early stages.

**OPAWA JACK** (C Dell) - Raced wide through the middle stages.

**CALEDONIE** (T Mitchell) - Finished last. When questioned rider could offer no excuse. A post-race veterinary examination did not reveal any obvious abnormality.
