Race 1 TAB ODDS SURGE EVERY RACE AT TRENTHAM MAIDEN 1400m

KNIGHTS REALM (W Pinn) – Trainer Mr. C Isdale reported to Stewards, he was satisfied with the post-race condition of KNIGHTS REALM, and it is his intention to carry on with the gelding's current preparation.

HAUGHTY (M Cameron) – Trainer Mr. C Cole advised Stewards, the filly underwent a veterinary examination on Monday 20 May, which revealed soreness to the near side shoulder area and underwent chiropractor treatment on Wednesday 22 May for overall general soreness. C Cole further advised HAUGHTY has now been sent for a spell.

Race 1 HOLDEM CONTRACTING LEGEND HAWERA RIDERS MAIDEN HURDLES 2800m

QUAFF (M Roustoby) - Trainer Mr. S Cameron reported to Stewards, the gelding will undergo chiropractor treatment on Tuesday 28 May and at this stage will continue on with QUAFF'S current preparation.

RACE COMMENTS**Race 1 TAB ODDS SURGE EVERY RACE AT TRENTHAM 2YO MAIDEN 1200m**

KARYON (J Chung) - Jumped outwards at the start crowding LEWIN. Raced three-wide without cover throughout. Lay inwards from the 600 metres.

LEWIN (L Hemi) - Crowded at the start losing ground.

RUSHIN HOME (K Chowdhury) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

SKYMAX (B Grylls) - Raced keenly in the early stages.

Race 2 BOWLS WELLINGTON RACEDAY 13/07 @ TRENTHAM MAIDEN 2100m

QUID (E Woller) - Slow to begin. Raced wide without cover throughout.

PARADIS (M Singh) - Slow to begin then shifted behind runners to take cover.

ZEDDIANI (C Barnes) - Raced wide without cover throughout.

SMOKIN MO (L Allpress) - Raced keenly in the early stages. Made the first bend awkwardly, shifting wide on the track.

YUNGBLUD (J Riddell) - Raced in restricted room having to be restrained off heels near the 1600 metres. When questioned regarding performance rider could offer no explanation.

Track Downgraded to Heavy 10 retrospective to Race 1.

Race 3 MAJESTIC HORSE FLOATS 1400m

CHASE (L Sutherland) - Slow to begin. Rider reported the gelding felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

CONOR O'CEIRIN (C Barnes) - Raced keenly in the early stages.

DUNCAN CREEK (K Hercock) - Held up for some distance rounding the turn. Had to be steadied when attempting a marginal run which had not fully developed near the straight entrance between CONOR O'CEIRIN and ROCABABY, and when being corrected shifted in across the heels of CONOR O'CEIRIN, clipping that runner's heels and blundering. When assessing this incident Stewards took into account simultaneous inward and outward movement.

ROCABABY (L Allpress) - L Allpress was reminded of her obligation to ensure she rides her mount out fully to the end of the race when circumstances permit after momentarily relaxing her ride near the 100 metres with Stewards being satisfied that her finishing position was not compromised.

Race 4 HAPPY 65TH PETER LISSINGTON MAIDEN 1300m

CHEVEUX (L Allpress) - Stood in the barriers when the gates opened losing ground (7L). Connections were advised a warning has been placed on the mare's barrier manners.

SAINT OLIVER (J Mudhoo) - Jumped awkwardly shifting outwards at the start.

BARBIE DOLL (L Hemi) - Slow away.

LINARA (Ayush Mudhoo) - When questioned regarding performance rider advised that in his opinion the colt had failed to handle today's Heavy track conditions. Ayush Mudhoo was shown the replay in the presence of the Apprentice Mentor and reminded of his obligations that he must ride his mount out fully to the end of the race when circumstances permit. Issued with a warning for using his whip in consecutive strides near the 350 metres.

Race 5 | **LISA LATTA RACING MAIDEN 1300m**

OPAWA SCARLETT (K Asano) - Knuckled leaving the barriers.

LINCOLN TOWERS (J Riddell) - Began awkwardly losing ground.

SOUL CATCHER (M Singh) - Placed in restricted room having to be steadied near the 700 metres.

IT'S BOMBPROOF (K HercocK) - Raced greenly and went off stride rounding the final bend, losing ground. When questioned, rider advised that she would be recommending to connections the addition of blinkers to the gear of IT'S BOMBPROOF prior to racing next.

ELLA KATE (A Mudhoo) - Held up for clear running for some distance passing the 300 metres.

SEE MY MACHINE (L Hemi) - Briefly lay outwards when placed under pressure near the 200 metres.

T Allan (PERFECT POSY) - Admitted a charge in that he struck his mount PERFECT POSY nine times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing today, 25 May, until the conclusion of racing on Saturday, 1 June, 5 national riding days.

K Asano (OPAWA SCARLETT) - Admitted a charge in that he struck his mount OPAWA SCARLETT seven times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$350.

Race 6 | **AUTOTECH DOORS 1600m**

MANOLO (C Lindsay) - Slow to begin. Finished a distant last. When questioned, rider advised the gelding failed to handle today's Heavy track conditions. Underwent a post-race veterinary examination did not reveal any obvious abnormality.

JESTIN CASE (C Dell) - Slow to begin.

MR TWINKLETOES (S O'Malley) - Improved on to heels when racing keenly near the 1300 metres.

Race 7 | **JOHN CRYAN 2200m**

PRINCE ALBY (L Douglas) - Restrained to the rear in the early stages after jumping from the outside barrier.

NEDWIN (S O'Malley) - Slow to begin.

MARRONI (J Chung) - Raced keenly through the early stages.

PRIDE OF ASPEN (L Allpress) - Raced keenly in the middle stages.

DIVINE SPIRIT (K Asano) - Finished a distant last. When questioned rider advised the mare over-raced and had failed to back-up from its previous start on 18 May.

SOLDIER BOY (K Hercock) - When questioned regarding performance ride advised the gelding was displaying a breathing abnormality consistent with having got its tongue back. Trainer G Sharrock confirmed a tongue tie will be added to SOLDIER BOY prior to its next start.

Race 8 | **THE METRO INTERIORS AUTUMN SPRINT FINAL 1200m**

KANA (K Asano) - Began awkwardly.

PRIORESS (C Dell) - Slow away.

AMEND (J Mudhoo) - Raced wide without cover throughout. J Mudhoo was observed to relax his ride over the final stages. When questioned J Mudhoo advised that AMEND commenced to hang outwards when in restricted room near the 100 metres. Stewards noted J Mudhoo's comment, and he was advised, in the presence of the Apprentice Mentor, that he must ride his mounts out fully to the finish when circumstances permit.

SHELBYROCK'N (B Grylls) - When questioned regarding performance rider advised the mare would appreciate a step up in distance and would derive benefit from today's fresh-up race.

Race 9 | **MANAWATU ITM STEEPLECHASE DAY TOMORROW AT WOODVILLE 1200m**

THUMPER (K Asano) -Kicked at the start. Underwent a pre-race veterinary examination and was cleared to start.

PACE ATTACK (L Hemi) - Slow to begin.

SHAMELESS BOY (L Douglas) - Had to be steadied off the heels of MOMOSA shortly after the start. Raced keenly in the early stages. Improved on to heels, having to be steadied passing the 200 metres.

MOMOSA (E Sole) - Raced keenly through the early and middle stages.

ANDIT HURTS (J Mudhoo) - -Improved on to heels, having to be steadied near the 500 metres.

SUPER TIME (T Mitchell) - Hung outwards when linking up to the course proper near the 400 metres.

SOTIRIO (J Chung) - Lay outwards over the concluding stages having to be corrected by its rider.

T Mitchell (SUPER TIME) - Admitted a charge in that she struck her mount SUPER TIME seven times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a \$500 fine.
