#### **RACE COMMENTS**

### Race 1 SUPER STAR SEA KING MAIDEN HURDLE 3000m

**CATCH AND RELEASE** (D Parker) - Jumped the fence near the 1000 metres awkwardly. Jumped the fence near the 600 metres and fell. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. D Parker was examined by St John ambulance personnel, stood down from his remaining rides and transported to Palmerston North Hospital for further observation. D Parker is required to provide a medical certificate prior to riding next.

**PEERLESS WARRIOR** (N Downs) - Jumped indifferently throughout. Retired from the event prior to the last fence.

### Race 2 BRAESIDE FARM MAIDEN HURDLE 3000m

**RUN JAKKO RUN** (L Douglas) - Began awkwardly. Hit the fence near the 1900 metres. Lay outwards under pressure over the concluding stages.

**FOXALOT** (H McNeill) - Raced keenly through the early stages when leading and in the middle stages when in a trailling position.

MR BEANS THE NAME (S Karnicnik) - Retired from the event prior to the final fence when out of contention.

**ROCEM** (P Matthews) - Jumped the last two fences awkwardly. Lay inwards under pressure over the concluding stages.

**NEW YORK JAZZ** (K Wiles) - Retired from the event prior to the fence near the 600 metres. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**JESKO** (S Fannin) - When questioned rider could offer no excuse other than the gelding may be better suited to more rain-affected going.

#### Race 3 MANAWATU ITM AWAPUNI HURDLE 3000m

TAHUROA HEIGHT (K Wiles) - Jumped indifferently throughout.

**OXYGEN** (S Fannin) - Jumped the fence near the 1900 metres awkwardly. Fell at the second to last fence. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. S Fannin was examined by St John ambulance personnel and cleared to ride.

**ENGLISH GAMBLER** (C Wiles) - Commenced to give ground from near the end of the back straight. Hampered by the fallen runner after negotiating the second to last fence. When questioned rider C Wiles advised the gelding lugged outwards throughout and had little left at the finish. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**COUNTRY BUMPKIN** (N Downs) - Hampered by the fallen runner after negotiating the second to last fence.

**LOCHWINNOCH** (M Roustoby) - Hampered by the fallen runner after negotiating the second to last fence.

#### Race 4 MURRAY CONTRACTORS & QUOTATION FOODTRAILER 1400m

**ISLAND HOP** (L Sutherland) - Slow to begin. Raced keenly through the early stages then made the bend awkwardly near the 800 metres, momentarily placing LORD DONOVAN in restricted room.

LOVE STORM (L Allpress) - Slow to begin.

ROYAL FLOWER (L Kauri) - Raced wide throughout.

LORD DONOVAN (K Hercock) - Momentarily placed in restricted room passing the 800 metres.

#### Race 5 SPELDHURST MATES MAIDEN STEEPLECHASE 4000m

**HOME RULE** (M Roustoby) - Made the first bend awkwardly. Raced keenly for the majority of the race. When questioned rider confirmed the gelding had raced keenly. However, HOME RULE would benefit from today's race, being the gelding's first steeplechase.

**NO TEARS** (C Wiles) - Jumped indifferently throughout. Retired from the event near the 1800 metres with a round to go. When questioned C Wiles was of the opinion the gelding may be sore. Underwent a post-race veterinary examination which revealed 3/5 lameness in the near hind and 1/5 in the near front. A Baker was advised NO TEARS would require a full veterinary clearance prior to its next start. Connections indicated NO TEARS would be retired.

**DUCK ROAD** (S Karnicnik) - Jumped indifferently throughout. Retired from the event near the 600 metres.

**SWEET TABOO** (H McNeill) - Jumped the fence near the 900 metres awkwardly, momentarily unbalancing the rider.

## Race 6 LJ HOOKER MANAWATU STEEPLECHASE 4000m

HEY HAPPY (M Roustoby) - Jumped the first fence awkwardly hampering DONARDO and IZYMYDAAD.

**DONARDO** (P Matthews) - Hampered first fence. Rider P Matthews reported the gelding was showing soreness on pulling up. A post-race veterinary examination which revealed 2/5 lameness in the left foreleg with a veterinary clearance required prior to racing next.

**IZYMYDAAD** (S Karnicnik) - Hampered first fence.

**DES DE JEU** (N Downs) - Raced keenly through the early and middle stages. Retired from the event after jumping the second-to-last fence.

RAUCOUS (H McNeill) - Raced keenly through the early and middle stages.

PASSWORD (K Wiles) - Jumped the last fence awkwardly.

**INTERLLECTUS** (L Douglas) - Underwent a post-race veterinary examination which revealed 2/5 lameness in the left foreleg with a veterinary clearance required prior to racing next.

**H McNeill** (RAUCOUS) - Spoken to regarding his whip use on a runner out of contention.

## Race 7 PROPERTY BROKERS WOODVILLE-PAHIATUA CUP 2100m

MASSO (L Hemi) - Restrained at the start to obtain cover. Lay inwards near the 350 metres.

PINKERTON (L Allpress) - Raced wide from the 1000 metres.

**FABIAN HAWK** (J Riddell) - Lay inwards near the 350 metres. Finished towards the rear. When questioned the rider could offer no excuse.

**DOROTHY'S DAUGHTER** (L Sutherland) - Finished towards the rear. When questioned the rider was of the opinion the mare was unsuited to today's track conditions.

#### Race 8 MACDOUGALLS & SCANPOWER MAIDEN 1600m

**LEPREKHAN** (A Lawson-Carroll) - Restrained to the rear from a wide draw. Improved on to the heels of the tiring CRY BABY near the 400 metres, having to be steadied.

**KEEN ON BUBBLES** (E Sole) - Restrained to the rear from a wide draw. Lay inwards rounding the final bend.

WHO KNOWS (L Sutherland) - Raced three-wide throughout.

**KEEPING TIME** (K Hercock) - Raced four-wide throughout.

## Race 9 BUCKLEY CONTRACTING & FARMLANDS PAHIATUA 1600m

MISS EMERALD (A Mudhoo) - Very slow away.

**SEFTON** (J Riddell) - Slow away.

**FAY KHAN IT** (C Butler) - Raced keenly in the early stages while leading.

MAGGIES CHOICE (J Chung) - Raced keenly in the early and middle stages.

SCRIPT (J Mudhoo) - Raced four-wide throughout and tired over the concluding stages.

KNICKERLESS (C Dell) - Lay inwards throughout the home straight.
