## RACE COMMENTS

<b>Race 1</b>	<b>ROHAN MUDHOO TRUST FUNDRAISING NOW MAIDEN 1200m</b>

**MOVIE GIRL** (T Comignaghi) - Blundered at the start. Raced keenly through the early stages when being restrained to obtain cover. Briefly held up early in the straight.

**FIRST LIEUTENANT** (J Fawcett) - Began awkwardly making contact with STAR FORMULA.

**STAR FORMULA** (S Wynne) - Hampered at the start losing ground.

**INSPIRATION** (A Najib) - Shifted outwards at the start making contact with WEST VIRGINIA. Lay inwards under pressure near the 300 metres having to be corrected.

**WEST VIRGINIA** (T Moseley) - Contacted at the start.

**YAK SHA** (J Doyle) - Began awkwardly losing ground.

**DOMPERION** (Y Atchamah) - Jumped away awkwardly losing ground.

**SEÑOR PEDRO** (K Asano) - Slow to begin. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection SENOR PEDRO was confirmed to have bled. SENOR PEDRO shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a veterinarian. Co-trainer Michael Pitman advised that SENOR PEDRO was likely to be retired.

**VANGELIS** (K Kwo) - Over raced through the early and middle stages. Raced wide throughout.

<b>Race 2</b>	<b>HAPPY RETIREMENT PAUL 'HINZ' HINSLEY 1200m</b>

**JUSTANACE** (K Williams) - Jumped away awkwardly.

**ON THE WALL** (L Hemi) - Blundered at the start losing ground.

**MUMBO JUMBO** (B May) - Slow to begin. Checked when disappointed for a run near the 250 metres when a marginal gap closed due to DELPHILLIUS (J Fawcett) laying inwards away from ON SONG. J Fawcett was advised to exercise greater care.

**FINGERPRINTED** (S Wynne) - Began awkwardly then shifting outwards contacting and crowding GOLDEN HARVEST. Over raced through the early and middle stages.

**GOLDEN HARVEST** (J Doyle) - Contacted and crowded at the start losing ground. Had difficulty obtaining clear running until inside the final 200 metres.

**VICTOR ROUGE** (K Kwo) - Jumped away awkwardly losing ground. Held up having to be firmly restrained off heels rounding the bend near the 500 metres, then having difficulty obtaining clear running when racing in restricted room for a distance.

**MOGUL** (K Asano) - Began awkwardly losing ground.

**MISS BRITTANY** (U Holmquist) - Jumped away awkwardly losing ground. When questioned regarding performance, the rider advised that the mare had failed to handle today's track conditions.

**DELPHILLIUS** (J Fawcett) - Raced keenly through the early and middle stages.

**IDEAL DREAMS** (W Kennedy) - Badly held up passing the 400 metres until near the 250 metres.

**PLEASURE** (K Mudhoo) - Was unable to obtain clear running for the majority of the straight.

**NO BOUQUET** (T Moseley) - Held up rounding the final turn and early in the straight.

**ONCEACONNER** (L Callaway) - Raced in restricted room rounding the final turn and early in the straight.

**Race 3** | **ANGUS MEATS OPEN HANDICAP 1200m**

**THE HOTTIE** (C Barnes) - Underwent a pre-race veterinary inspection after being fractious in the barriers and was passed fit to run.

**ZOULANDER** (B Rogerson) - Began awkwardly then shifting outwards hampering and crowding GOODANYA.

**GOODANYA** (K Chowdhoo) - Hampered and crowded at the start losing ground.

**EXPRESS COUP** (K Williams) - Began awkwardly then commenced to race keenly through the early stages.

**AMBERECHO** (M Cameron) - Raced keenly through the early stages. Steadied when placed in restricted room near the 300 metres.

**EMANON** (D Cooper) - Over raced through the early and middle stages. Contacted near the 350 metres. Rider dropped his whip near the 150 metres. Steadied just short of the finishing line to avoid the heels of SPARTAN (S Wynne) which rolled in under pressure over the concluding stages. S Wynne was advised to exercise greater care.

**SPARTAN** (S Wynne) - Over raced through the early and middle stages. Was inclined to lay inwards under pressure in the straight making contact with EMANON near the 350 metres.

**Race 4** | **RICCARTON PARK FUNCTION CENTRE WELCOME STAKES 1000m**

**REDEMPTION** (T Moseley) - Became fractious in the barriers getting its front legs into an adjacent stall making contact with both the horse LIL ZENA and its rider S Wynne. Both REDEMPTION and LIL ZENA were removed to undergo veterinary examinations being passed fit to run, with S Wynne being attended to by the paramedic at the start. After being reloaded REDEMPTION immediately again became fractious getting both front legs into the adjacent stall occupied by LIL ZENA and was declared a late scratching on veterinary advice at 2:04pm. Connections were advised that REDEMPTION is required to barrier trial on two occasions to the satisfaction of a Stipendiary Steward prior to racing next. On the second occasion on which REDEMPTION kicked out into the barrier stall occupied by LIL ZENA, S Wynne struck out with her whip towards the shoulder region of REDEMPTION before being able to dismount to remove herself from harm's way. In the circumstances S Wynne was on this occasion reprimanded for her actions.

**LIL ZENA** (S Wynne) - Removed from its barrier to undergo a veterinary examination and cleared to race. Began awkwardly.

**SUPER SINCERE** (K Williams) - Raced keenly through the early and middle stages.

**Race 5** | **DAVID EMERSON ACCOUNTANT & BUSINESS CONSULTANT 2000m**

**GENTLE BEN** (K Asano) - Slow to begin.

**BAUBLE** (C Campbell) - Jumped away awkwardly.

**TAKE THAT** (B May) - Slow to begin. Steadied when placed in restricted room near the 250 metres.

**STAR BALLOT** (T Comignaghi) - Restrained behind runners to obtain cover shortly after the start.

**TAIMATE DIVA** (K Chowdhooory) - Slow to begin then ridden with urgency to recover. Raced wide in the early stages before being ridden forward to lead approaching the 1200 metres.

**PEEECE PUSSYCAT** (S Wynne) - Raced in restricted room going into the first turn near the 1800 metres having to be steadied losing ground. Film footage of this incident proved inconclusive.

**AMAZON GODDESS** (U Holmquist) - Over raced passing the 1600 metres. When questioned regarding performance, the rider was of the opinion the mare was feeling the effects of recent racing.

**DEMAND RESPECT** (K Williams) - Over raced passing the 1600 metres.

**EXTREME POWER** (K Kwo) - Had to be restrained off heels near the 1500 metres.

**GENERATION JOY** (J Doyle) - Held up when improving onto the heels of TAIMATE DIVA approaching the 200 metres.

**B Rogerson** (STEVE AUSTIN) - Issued with a warning after weighing in 0.5kg in excess of her weigh out weight.

**K Chowdhooory** (TAIMATE DIVA) - Admitted a charge of careless riding in that he permitted his mount TAIMATE DIVA to shift inwards when not sufficiently clear of STEVE AUSTIN which was checked passing the 1100 metres. After considering submissions the Adjudicative Committee imposed a suspension of K Chowdhooory's licence to ride in races from the conclusion of racing on Saturday 20 April until the conclusion of racing on Saturday 27 April, 5 national riding days.

**Race 6**

**NZB INSURANCE STAKES 1600m**

**EPEE BEEL** (T Comignaghi) - Shifted outwards at the start contacting and hampering outside runners.

**CAFFEINATED** (K Mudhoo) - Hampered and contacted at the start.

**AMERICAN CHEVAL** (C Campbell) - Contacted and hampered at the start losing ground.

**MAZZUCATO** (M Cameron) - Jumped away awkwardly.

**CONTEMPLATION BAY** (U Holmquist) - Began awkwardly losing ground. Steadied for a distance when over racing approaching the 1000 metres with the saddle then shifting forward badly inconveniencing its rider, with the filly not being persevered with in the final straight.

**KINDLING SPARK** (L Callaway) - Slow to begin.

**NO RAIN EVER** (K Williams) - Slow to begin.

**BLANCHE** (A Najib) - Slow to begin. Steadied when becoming awkwardly placed near the heels of AMERICAN CHEVAL near the 500 metres.

**SENSE OF TIMING** (A Goindasamy) - Steadied when awkwardly placed near heels passing the 1100 metres and shifted inwards contacting NIKAIA.

**NIKAIA** (K Asano) - Steadied when contacted passing the 1100 metres then racing in restricted room for a distance.

**IT'S DORIS** (C Barnes) - Raced wide throughout. When questioned regarding performance, the rider was unable to offer any excuse advising that the filly had been disappointing.

**RAPTYLIGHT** (T Moseley) - Held up rounding the final turn and early in the straight.

**NEPHETI** (J Doyle) - Raced in restricted room rounding the final turn. Lost the right hind plate during the running.

**NO RAIN EVER** (K Williams) - When questioned regarding performance, the rider was unable to offer any excuse advising that the filly had been disappointing.

**S Kennedy and A Furlong** (QUINTABELLE) - Fined \$50 under the Minor Infringement Schedule after presenting QUINTABELLE with an incorrect saddle cloth number.

Retrospective to this race the track was downgraded to Heavy 8.

**A Goindasamy** (SENSE OF TIMING) - Admitted a charge in that he struck his mount SENSE OF TIMING 7 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

<b>Race 7</b>	<b>ANGUS "SCHAWSEY" SCHAW 30<sup>TH</sup> FIZZER 1600m</b>

**VAUDEVIRE** (S Wynne) - Slow to begin.

**CEDDY SMITH** (J Doyle) - Shifted outwards at the start crowding BLOOD DIAMOND.

**BLOOD DIAMOND** (Y Atchamah) - Crowded at the start losing ground. Shifted outwards across the heels of LUCIENNE to obtain clear running passing the 400 metres simultaneously to VAUDEVIRE attempting to improve to its outside, resulting in BELLO MIO and CEDDY SMITH being inconvenienced and LULO ROSE being hampered.

**ALMANAC** (K Williams) - Began awkwardly losing ground.

**MAOLLA MISS** (C Barnes) - Slow to begin.

**COSMETIC VIRTUE** (M Cameron) - Raced three wide without cover throughout.

**SHE'S AN ACE** (D Subramaniam) - Over raced through the early and middle stages.

**LULO ROSE** (K Asano) - Hampered passing the 400 metres.

**BELLO MIO** (W Kennedy) - Inconvenienced passing the 400 metres. Lost the right front plate during the running. When questioned regarding performance, the rider advised that the gelding had been disappointing and was unable to offer any excuse other than possibly feeling its top weight in today's track conditions.

**CEDDY SMITH** (J Doyle) - Inconvenienced passing the 400 metres.

**KOTIRO TERE** (A Goindasamy) - Shifted outwards across heels to obtain clear running early in the straight.

**TUMUCH** (L Hemi) - When questioned regarding performance, the rider advised that the gelding had travelled well but had been unable to quicken in today's track conditions once placed under pressure.

<b>Race 8</b>	<b>TAB SOUTHERN ALPS CHALLENGE 1600m</b>

**JON OL ROCCO** (K Williams) - Jumped away awkwardly losing ground and then ridden with urgency to recover. Got its head up and raced ungenerously after being steadied near the 1200 metres. When questioned regarding

performance rider advised that the gelding had been unable to finish the race off over the concluding stages in today's track conditions.

**THE GREY GOOSE** (T Moseley) - Slow to begin. Had to shift ground outwards across the heels of EARS BACK to obtain clear running near the 200 metres.

**MISS PEARL** (S Wynne) - Restrained behind runners to obtain cover shortly after the start.

**GREEN LUCK** (B May) - Restrained behind runners to obtain cover shortly after the start.

**THE BUFFER** (M Cameron) - From its wide barrier draw restrained behind runners to obtain cover shortly after the start. Steadied away from the heels of MATSCOT near the 1200 metres. Held up early in the straight. Steadied near the 200 metres to avoid the heels of JON OL ROCCO which shifted inwards slightly under pressure with some outward movement from THE GREY GOOSE contributing.

**EARS BACK** (J Fawcett) - Raced three wide without cover.

**MYSTIC PARK** (T Comignaghi) - Over raced in the lead through the early and middle stages. When questioned regarding performance, the rider confirmed that after over racing badly the gelding had been unable to finish the race off over the concluding stages. A post-race veterinary examination found MYSTIC PARK to have a slow rate of recovery.

**CHARBANO** (K Chowdhoo) - Held up early in the straight.

**LADY TELENA** (W Kennedy) - When questioned regarding performance, the rider advised the mare had failed to handle today's track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

**L Hemi** (DAZZLING MISS) - Admitted a charge in that she struck her mount DAZZLING MISS 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

**S Wynne** (MISS PEARL) - Admitted a charge in that she struck her mount MISS PEARL 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Saturday 20 April until the conclusion of racing on Wednesday 1 May, 7 national riding days.

<b>Race 9</b>	<b>RACECOURSE HOTEL &amp; MOTOR LODGE 1400m</b>

**TADITA** (D Cooper) - Became fractious in the barriers being removed to undergo a pre-race veterinary examination being cleared to start.

**SEVEN TWENTY** (K Asano) - Jumped away awkwardly crowding PHELAN THE POWER. Held up rounding the final turn until near the 250 metres.

**PHELAN THE POWER** (R Muniandy) - Crowded leaving the barriers losing ground. Held up early in the straight.

**ROYAL VALOUR** (J Fawcett) - Slow away.

**FIREGLOW** (K Williams) - Slow away. Was not persevered with over the final 200 metres, with the rider reporting the gelding had been making abnormal breathing noises. A post-race veterinary examination did not reveal any obvious abnormality.

**STREET FIGHTIN MAN** (A Balloo) - Raced wide without cover.

**FELLINI** (W Kennedy) – Returned to the enclosure with blood visible on the right foreleg undergoing a post-race veterinary examination which revealed a small abrasion to the right front coronet band which did not require treatment.

**TURF WAR** (T Comignaghi) - When questioned regarding performance, the rider advised that the gelding had not felt comfortable in today's track conditions.
