GENERAL

Equine hair testing was conducted at today's race meeting.

SUPPLEMENTARY

Auckland Thoroughbred Racing at Ellerslie - Saturday, 30 March 2024
Race 6 NZEA NEW ZEALAND THOROUGHBRED BREEDERS' STAKES 1600 (G1)
MUSTANG VALLEY (J Doyle) – Trainer A Forsman advised Stewards he was satisfied with the post-race condition of the mare, and at this stage, **MUSTANG VALLERY** will head to Sydney next week to race at Randwick on Saturday 13 April, however, if the mare does not race then his intention will be to send the mare for a spell.

PEARL OF ALSACE (M McNab) – Trainer S Ritchie advised Stewards the stable was satisfied with the post-race condition of the mare, however, in his opinion PEARL OF ALSACE may have been feeling the effects of the firmer track. S Ritchie further advised the mare has now been sent for a spell.

Race 7 ELSDON PARK 2200

SUPER SID (D Danis) – Trainer D Hollinshead advised Stewards SUPER SID pulled up lame in the fetlocks and has now been retired from racing.

Race 8 SKYCITY HORIZON 1600

SUN AND HEIR (C Grylls) – Trainer M Van Lierde advised Stewards upon return to the stable the entire underwent a veterinary examination which included x-rays, with results showing a fracture to the lower lateral aspect cannon bone of the off foreleg with the entire undergoing surgery with pins being put in place. M Van Lierde further advised SUN AND HEIR has now been sent for spell and connections will also be reassessing its racing future.

RACE COMMENTS

Race 1 | **STELLA ARTOIS 1600**

CINTIVEE (N Parmar) - Began awkwardly. Over-raced through the early stages. Lay outwards when placed under pressure near the 100 metres.

SOLIDIFY (B Rogerson) - Began awkwardly. Over-raced through the early and middle stages.

KING OF THE NORTH (K Asano) - Raced keenly in the early and middle stages.

KEALOHA (C Barnes) – Raced keenly in the early to middle stages.

N Hailey (BILLY LINCOLN) - Admitted a charge in that he struck his mount BILLY LINCOLN twelve times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of N Hailey's licence to ride in races from the conclusion of racing on Sunday 14 April up to and including racing on Thursday 25 April, 7 national riding days.

Race 2 | **TAB 1200**

MAGICE (J Fawcett) - Removed from its barrier stall after becoming fractious to undergo a pre-race veterinary examination being late scratched at 1.06 pm on veterinary advice. Connections were advised that the colt would be required to barrier trial to the satisfaction of Stewards prior to racing next.

CHICAGO JACK (C Barnes) - Began awkwardly. Held up early in the final straight.

OSTERIA (T Moodley) - Began awkwardly with the rider becoming unbalanced, losing ground as a result.

MAYA BAY (U Holmquist) - Slow to begin then inconvenienced shortly after. Held up early in the final straight.

TORUK MAKTO (A Lawson-Carroll) - Began awkwardly.

WIND RUSH (L Sutherland) - Raced three wide without cover throughout.

MAGNA MEMORY (N Hailey) – Held up early in the final straight.

RAZIAH (B Grylls) – Raced greenly when placed in restricted room passing the 200 metres.

THE VICTRESS (A Goindasamy) - When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 3 | **SHAW'S WIRE ROPES MAIDEN 1600**

PERSPECTIVE (T Mitchell) - Slow to begin. Improved onto heels approaching the 500 metres having to be steadied.

LAGISQUET (N Parmar) - Knuckled at the start.

WAR EMPRESS (D Prastiyou) - Began awkwardly losing ground. Raced three wide without cover throughout.

POINTER (N Hailey) - Slow to begin. Contacted approaching the 300 metres by JOYOLA which shifted inwards. T Moodley was advised to exercise greater care.

LANIKAI (L Sutherland) – Raced keenly in the early and middle stages.

NORTHEASTERLY (K Asano) - Raced keenly in the early and middle stages. Had difficulty obtaining clear running early in the final straight.

ROCMONT (L Satherley) – Raced keenly for a distance passing the 1000 metres.

SOUL QUEEN (T Abel) - Had to shift outwards entering the final straight to obtain clear running.

D Prastiyou (WAR EMPRESS) - Issued with a warning for his whip use on a runner out of contention.

D Hollinshead (POINTER) - Issued with a warning for presenting POINTER to race without the notified pre-race ear covers.

Race 4 | **ELLERSLIE EVENTS 1600**

HASSTOBEAWINNER (B Jacobson) - Began awkwardly losing ground.

BRECKON POWER (A Goindasamy) – Over-raced through the early stages. Had to be steadied approaching the 800 metres.

MALDINI (L Sutherland) - Raced ungenerously when placed in restricted room passing the 1400 metres to the inside of BRECKON POWER which was racing keenly. Improved onto heels near the 1000 metres having to be firmly restrained. Held up for the majority of the final straight.

MANAWA (J Fawcett) – Over-raced in the early and middle stages. Was inclined to lay in when placed under pressure in the final straight.

ROCHMIE RAY (L Satherley) - Raced wide without cover throughout.

BELLA LUCE (A Lawson-Carroll) - Rider dropped his whip approaching the 300 metres.

GLOBAL CURRENCY (N Hailey) - Lost the left hind plate during the running.

Race 5 | **HALLMARK STUD 1600**

TAHUROA HEIGHT (L Sutherland) - Slow to begin.

XRATED (K Asano) - Slow to begin. Steadied when placed in restricted room to the inside of BASSOROC which shifted in and away from FINAL PURCHASE which was shifting inwards passing the 1200 metres. B Jacobson was advised to exercise greater care.

CHANTARI BAY (T Mitchell) - Knuckled at the start.

SPICEY LAD (A Lawson-Carroll) – Made contact with the running rail approaching the 1200 metres when racing ungenerously. Contacted passing the 250 metres.

ROSETOWN PRINCESS (N Hailey) - Had to be steadied off heels approaching the 1200 metres.

BILLY BUNTER (K Myers) – When questioned regarding performance the rider advised that in her opinion the gelding had struggled with the impost of 60 kgs and may benefit from a step up in distance. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 6 | **DUNSTAN HORSEFEEDS 1300**

TELLALL (J Fawcett) - Slow to begin.

IS THAT SO (K Myers) – Slow to begin.

DEVASTATE (A Goindasamy) - Raced three wide without cover throughout. Dictated inwards from near the 150 metres making contact with RUDYARD near the 25 metres.

RUDYARD (L Sutherland) - Dictated inwards from near the 150 metres being contacted by DEVASTATE near the 25 metres becoming unbalanced.

UDERZO (N Parmar) - Lay in when placed under pressure over the final 150 metres with the rider attempting to straighten the gelding near the 25 metres.

N Parmar (UDERZO) - Admitted a charge of careless riding in that he permitted his mount UDERZO to shift inwards when insufficiently clear of DEVASTATE which was dictated inwards contacting RUDYARD near the 25 metres becoming unbalanced. After considering submissions the Adjudicative Committee imposed a suspension of N Parmar's licence to ride in races from the conclusion of racing on Wednesday 10 April up to and including racing on Friday 19 April, 6 national riding days.

Following the running of this race connections of the third placed runner DEVASTATE viewed video footage before electing not to proceed with a protest.

Following the running of this race connections of the first equal placed horse RUDYARD lodged a protest alleging interference over the concluding stages against the first equal placed horse UDERZO. After considering submissions the Adjudicative Committee upheld the protest with amended placings being 1st RUDYARD, 2nd UDERZO, 3rd DEVASTATE, 4th SAINT BATHANS.

Race 7 | **SISTEMA 1500**

THATSALLSHEWROTE (K Myers) – Slow to begin.

HEART OF GOLD (T Moodley) - Began awkwardly losing ground. Over-raced through the early stages.

CHATTAHOOCHEE (N Hailey) – Raced three wide without cover.

FAMILY TIES (J Allen) – Raced three wide without cover throughout.

HAT TRICK (L Sutherland) – Lay out in the final straight forcing CHATTAHOOCHEE wider passing the 150 metres.

NEIGHBOURHOOD (N Parmar) – Lost the right front plate during the running

ARMINO (K Asano) - Lost the left hind plate during the running.

Race 8

SKYCITY HORIZON 2200

BLISSFULL LADY (B Jacobson) - Slow to begin.

WITHALLMYHEART (T Mitchell) - Slow to begin. Held up early in the final straight.

EVE'S SONG (C Barnes) – Began awkwardly.

CIMARRON (L Satherley) – Over-raced through the early stages. Went off stride near the 300 metres.

NORTHERN RAIDER (U Holmquist) – Over-raced throughout.

ESPRESSO TO GO (K Asano) – Raced three wide without cover.

DEVOTED (N Parmar) – Steadied when placed in restricted room near the 150 metres.

ROC DANCER (L Sutherland) – Shifted outwards passing the 100 metres becoming awkwardly placed on the heels of ALL SHOOK UP which shifted inwards slightly.
