Following Race 1 T Mitchell advised Stewards she felt unwell and was stood down by paramedics. Replacements as above.

RACE COMMENTS

Race 1 HAPPY 65TH JOHN BAXTER MAIDEN HIGHWEIGHT 2040m

NO TEARS (M Roustoby) - Slow away. Tailed the field throughout finishing a long last. Underwent a post-race veterinary examination which did not reveal any abnormality.

AFTERALLTHISTIME (S Fannin) - Slow away.

NIGHTFALL (K Macnab) - Began awkwardly.

PEE WEE (P Matthews) - Hampered having to be steadied shortly after the start when RAKANUI (D Parker) dictated REBAL AGENT inwards passing the 1800 metres when not fully clear. PEE WEE then commenced to race fiercely for a distance through the early stages and made the first bend awkwardly. Raced in restricted room over the concluding stages.

NO BIZZ (D Mcdonagh) - Raced wide through the early stages before being taken forward to sit outside the leader passing the 1600 metres. Lay outwards over the concluding stages momentarily placing REBAL AGENT in restricted room. D Mcdonagh was advised to exercise care.

REBAL AGENT (S O'Malley) - Raced in restricted room over the concluding stages.

D Parker (RAKANUI) - Issued with a warning after dictating REBAL AGENT inwards into the line of PEE WEE, which had to steady passing the 1800 metres.

Race 2 PALAMOUNTAINS ANIMAL NUTRITION 2040m

FIELD OF GOLD (T Davies) - Slow away. Improved on to heels near the 700 metres, having to be steadied.

KUNGFUMASTER PANDA (T Mitchell) - Began awkwardly.

Race 3 KEVIN MYERS STABLES JUMPERS HIGHWEIGHT 1600m

CHARRED (N Downs) - N Downs was issued with a warning for failing to make the carded weight for CHARRED, being 1kg overweight. Dictated inwards shortly after the start, hampering PASSWORD, which was checked.

PASSWORD (K Wiles) - Checked shortly after the start when CALL ME JACK (M Roustoby) shifted inwards dictating CHARRED into the line of PASSWORD. Stewards took into account the simultaneous outward movement from INVISIBLE SPIRIT (S Fannin) when assessing the interference. M Roustoby and S Fannin were both advised to exercise greater care when shifting ground.

AONGATETE EXPRESS (S O'Malley) - Slow away.

SUPER FLASH (P Matthews) - Began awkwardly.

DES DE JEU (K Joyce) - Raced wide through the early stages before being restrained to take cover.

LOCHWINNOCH (K Macnab) - Raced three-wide from near the 1100 metres. Lay inwards over the concluding stages.

Race 4 WANGANUI FUNCTION CENTRE MAIDEN 3YO 1600m

ROSEMARY FIZZ (T Moodley replaced T Mitchell (unwell). T Mitchell is required to provide a medical clearance prior to riding next. Slow away. Made the first bend awkwardly.

OMEGA BOY (M Hashizume) - Slow away. Awkwardly placed on heels entering the back straight, having to be steadied. Finished towards the rear. When questioned rider advised that after being slow away and settling further back than anticipated, the gelding had not responded when placed under pressure and was disappointing.

PROMETHEUS (K Hercock) - Shifted outwards near the 1000 metres when the pace ahead eased to avoid the heels of SIDE PIECE, checking SATSUKI.

PHATS (M Cameron) - Raced wide throughout.

SIDE PIECE (C Dell) - Lay outwards over the concluding stages, bumping SATSUKI near the winning post.

SATSUKI (L Hemi) - Checked approaching the 1000 metres when PROMETHEUS shifted outwards when not sufficiently clear. Bumped concluding stages.

BEAVERTOWN LASS (L Sutherland) - Made the first bend awkwardly.

K Hercock (PROMETHEUS) - Admitted a charge of careless riding in that she permitted her mount PROMETHEUS to shift outwards when insufficiently clear of SATSUKI which was checked near the 1000 metres. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 13 April, until the conclusion of racing on Friday, 19 April, 4 national riding days.

Race 5 LISA LATTA RACING STABLES 1600m

Trainer C Ivil (PRINCESS ELLY) - Issued with a warning for presenting his runner PRINCESS ELLY without notified gear (pre-race ear covers).

ZEEFA ZED (C Grylls) - Slow away. Had to angle outwards in order to improve near the 150 metres.

MUSE (T Moodley) - Restrained to the rear from its wide draw.

TORQUE TIME (S O'Malley) - Tightened going into the first bend. After questioning riders no further action was taken due to inadequate video coverage.

BEAN A PLEASURE (L Allpress) - Raced four-wide through the early and middle stages.

SIR MIKKI (C Dell) - Raced three-wide throughout.

PRINCESS ELLY (L Sutherland) - Checked passing the 200 metres when BOURBON FALLS (K Asano) shifted inwards when not sufficiently clear.

FREYJA'S GODDESS (C Butler) - Shifted ground near the 200 metres.

K Asano (BOURBON FALLS) - Admitted a charge of careless riding in that he permitted BOURBON FALLS to shift inwards when not sufficiently clear of PRINCESS ELLY, which was checked passing the 200 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Sunday, 14 April, until the conclusion of racing on Thursday, 25 April, 7 national riding days.

Race 6 FRASER AURET RACING 1600m

TAVI ANN (T Moodley) - Slow away. Held up rounding the final bend.

MEDIA MISS (L Allpress) - Restrained to the rear from its wide draw. Commenced to over-race. Weakened over the concluding stages and was not persevered with. When questioned rider advised that over-racing the mare had little left at the finish, and as a result may not have seen out the 1600 metres. A post-race veterinary examination did not reveal any abnormality.

ERNA (T Taiaroa) - Slow away.

ASAHI (C Grylls) - Made the first bend awkwardly.

O'CEIRINS DREAM (C Butler) - Raced wide throughout.

KNICKERLESS (L Hemi) - Raced keenly through the early stages.

Race 7 CHASE A FOX RACING SYNDICATE MAIDEN 1200m

HELL OF A ROCA (A Mudhoo) - Rider lost the use of his stirrup iron for a short distance becoming unbalanced. Finished some distance back. Trainer advised the gelding's future will be reassessed.

HASBULLA (T Davies) - Began awkwardly bumping DEEP FREEDOM.

DEEP FREEDOM (C Grylls) - Bumped at start. Raced greenly and hung outwards near the 700 metres placing the rider at a disadvantage. Connections were advised a warning has been placed on the gelding's racing manners.

GOOD CRAIC (C Dell) - Hampered when improving to the inside of RETURN MESSAGE (C Butler), which shifted in under pressure near the 150 metres. C Butler was advised to exercise greater care.

Race 8 TINA EGAN PRE-TRAINING 1200m

BIKINDY (L Sutherland) - Slow away.

HEMI RIDAPEST (L Hemi) - Restrained to the rear from its wide draw.

BELLA TIMING (T Moodley) - Raced keenly when being restrained in the early stages.

THUMPER (M Cameron) - Finished a distant last. Rider could offer no excuse. Underwent a post-race veterinary examination did not reveal any obvious abnormality.

Race 9 RAYNER RACING MAIDEN 1340m

TIKEMYSON (S O'Malley) - Began awkwardly. Over-raced in the early and middle stages.

ASTARTE (M Cameron) - Unable to gain clear racing room throughout the home straight, going to the line untested.

THATZ BONNIE (J Chung) - Hung throughout placing the rider at a disadvantage and shifted out abruptly near the 400 metres heavily contacting STOUT near the 300 metres, resulting in both runners becoming unbalanced. Connections were advised a warning has been placed on the mare's racing manners.

STOUT (C Grylls) - Heavily contacted and unbalanced near the 300 metres.

NEVER NEVER (M Hashizume) - Lay inwards under pressure over the concluding stages.

UP WITH CHARM (J Riddell) - Raced greenly over the concluding stages and shied at the winning post
