Race 3 TOP TIPS DCOPPINS@EXTRA.CO.NZ 1100m

An adjourned inquiry was reconvened into the ride of C Butler (SINBIN) who was charged under Rule 636(1)(b), in that she failed to take all reasonable and permissible measures to finish in the best possible placing. After hearing all evidence, the Adjudicator dismissed the charge.

RACE COMMENTS

Race 1 DAVES PATCH MAIDEN 2000m

The start of this race was approximately 4 minutes late due to SUNSET BOULEVARD dislodging the rider in the preliminary and taking some to be recaptured.

SUNSET BOULEVARD (R Elliot) - Dislodged rider enroute to the start, taking some time to be recaptured, being declared a late scratching at 12.23pm on veterinary advice. Connections were advised SUNSET BOULEVARD must trial to the satisfaction of Stewards prior to racing next.

REBAL AGENT (C Grylls) - Slow to begin.

PLEASE SIR (C Butler) - Raced three-wide without cover.

WRY SMILE (J Doyle) - Made the bend into the back straight awkwardly and skied its head.

INVESTIGATE (W Pinn) - Shifted out under pressure in the home straight.

Race 2 SINCLAIR ELECTRICAL & REFRIGERATION MAIDEN 1200m

RISQUE RULER (J Fawcett) - Jumped away awkwardly.

HELL OF A ROCA (L Douglas) - Slow away. Had to steady near the 1000 metres when BERNIE'S EGO (N Hailey) was angled inwards when not fully clear. N Hailey was issued with a warning. Finished well back. When questioned L Douglas could offer no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

BRIGIT (M Hashizume) - Over-raced and had to be steadied going into the first bend.

STOUT (C Grylls) - Raced greenly and shied when making the first bend near the 800 metres, shifting out, making contact with KEEN ON BUBBLES which became unbalanced as a result. Trainer R Patterson advised Stewards that consideration would be given to removing the blinkers prior to STOUT'S next start.

KEEN ON BUBBLES (E Sole) - Hampered and unbalanced when contacted near the 800 metres. Held up rounding the final turn near the 350 metres.

LED RED RITA (T Davies) - Finished some distance from the body of the field. When questioned T Davies could offer no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

N Hailey (BERNIE'S EGO) -Issued with a warning after angling BERNIE'S EGO inwards near the 1000 metres when not fully clear of HELL OF A ROCA, which had to steady.

Race 3 PENINSULAR BEACHFRONT RESORT MOOLOOLABA MAIDEN 1400m

NEVER NEVER (J Doyle) - Slow away.

KAIMAI WARRIOR (J Fawcett) - Restrained to obtain cover after jumping from the outside barrier, then commencing to over-race for a distance shortly after the start.

ANDERSONS BAY (J Riddell) - Restrained in the early stages after jumping from a wide barrier. Raced three-wide without cover.

SALLY (J Chung) - Made the bend near the 800 metres awkwardly.

NORTHEASTERLY (M Hashizume) - Contacted by RITA BONITA near the 250 metres.

Race 4 GRANGEWILLIAM STUD 1400m

ZIVJELI (E Sole) - Slow away. Commenced to over-race passing the 1200 metres, continuing to do so through the middle stages.

BELLADONNA LILY (C Butler) - Over-raced in the middle stages. Held up near the 200 metres, having to shift ground inwards across heels to obtain clear running.

IT'S DORIS (C Grylls) - Raced three-wide without cover.

Race 5 HASSALL HOMES HAPPY 50TH BIRTHDAY HASS 1800m

CHARLBURY (D Danis) - Slow away then being further hampered shortly after the start. Raced three-wide without cover from the 1000 metres. Hampered near the 400 metres when BELLA WATERS (M Hashizume) shifted outwards to obtain clear running.

MATETSI (J Doyle) - Jumped away awkwardly making contact with MIYAZAWA, which was forced on to TIZ LOUIE.

MIYAZAWA (C Dell) - Hampered when contacted leaving the barrier. Raced keenly in the early stages, getting its head up. Held up early in the home straight and bumped with THE CHOPPER on several occasions when attempting a run.

THE CHOPPER (C Grylls) - Bumped on several occasions in the home straight.

TIZ LOUIE (N Hailey) - Received firm contact leaving the barriers, badly unbalancing its rider, who was almost dislodged.

FREYJA'S GODDESS (C Butler) - Made the crossing near the 1500 metres awkwardly.

KHAFEEF (L Sutherland) - Over-raced in the middle stages.

CHOOSE 'EM BIG (J Fawcett) - Rider reported the gelding was not entirely comfortable in the going.

M Hashizume (BELLA WATERS) - Issued with a warning after allowing his mount to shift outwards near the 600 metres when not clear of CHARLBURY, which had to steady.

Race 6

DENIS WHEELER EARTHMOVING MAIDEN 1600m

AVORIAZ (C Grylls) - Slow away. When questioned C Grylls had no excuse other than the filly may not have been suited to the tongue tie.

SIDE PIECE (C Dell) - Bounded at the start.

HERBERT (E Sole) - Raced wide in the early stages before being allowed to improve forward outside the leader near the 1100metres. Raced greenly under pressure in the straight.

Race 7

ENTAIN – NZB INSURANCE PEARL SERIES RACE MAIDEN 1600m

SALUTO (J Fawcett) - Slow away. J Fawcett was reminded of her obligations when shifting ground after angling her mount off heels approaching the home turn resulting in GOLDEN being buffeted for several strides.

PRINCESS TERESA (T Moodley) - Crowded leaving the barriers losing ground. Raced three-wide without cover.

XRATED (M Hashizume) - Raced keenly in the early stages.

GOLDEN (C Grylls) - Over-raced in the early and middle stages. Buffeted for several strides approaching the home turn. When questioned into the disappointing run C Grylls advised Stewards the filly had got worked up prior to the race, behind the barrier, over-raced and had little left at the finish.

Race 8 TRADIES RACEDAY SATURDAY 11[™] MAY 2024 1600m

LOCHWINNOCH (L Sutherland) - Crowded leaving the barriers losing ground.

BLUE RATA BOLDNESS (M Hashizume) - Buffeted between runners on jumping.

KHAFRE (T Mitchell) - Raced three-wide without cover.
