Race 6 - LINDAUER 2000m

AMAZON GODDESS (U Holmquist) - Trainer Mr K Moore advised Stewards that AMAZON GODDESS pulled up with swelling to the off-hind leg which has now subsided. K Moore further advised that the mare has now been sent for freshen up.

RACE COMMENTS

Race 1 P LYON SHEARING/MILTON & LAWRENCE NIGHT/DAY MAIDEN 1200m

PERFECT CALIFORNIA (R Jaun) - Proved difficult to load delaying the start approximately two minutes. Connections were advised that a barrier manners warning would be placed on the filly's racing record. When asked to comment on performance, the rider advised that the filly had been disappointing in its first up effort in nearly a year.

SANPERION (J Fawcett) - Began awkwardly losing ground.

NO FUSS (R Muniandy) - Slow to begin. Briefly steadied near the 600 metres when awkwardly placed on heels. Held up near the 100 metres having to shift ground outwards passing the 75 metres. Stewards spoke with Apprentice R Muniandy in the presence of the Riding Mentor regarding his ride particularly in the run home. Of concern to Stewards was the fact that near the 250 metres there was an opportunity to angle his mount wider on the track which would have meant clear running to the winning post. R Muniandy advised that had been his intention however his mount had hung inwards at that stage and he had taken the option to stay closer to the rail. After viewing replays R Muniandy agreed with Stewards he had erred on this occasion and he should have persevered with a run to the outside. R Muniandy was advised he would be expected to show better judgement in future.

SHINTO (T Moseley) - Slow to begin. Rider could offer no tangible excuse for the disappointing performance.

WARY (K Rathoar) - Raced three wide without cover through the early to middle stages.

GLITZAL (S Wynne) - Became awkwardly placed on heels near the 500 metres having to be steadied. Lay inwards throughout the run home having to be straightened by its rider on a number of occasions.

EL ULTIMO (T Comignaghi) - Lost the near hind plate during the running.

Race 2 LINDSAY MOYLE MEMORIAL & GREEN ISLAND GRIZZLIES 1200m

Co- trainers **M Walker/S Bergerson** (ANGELS WINGS) - Fined \$100 Under the Minor Infringement Schedule after presenting ANGELS WINGS with unnotified gear (blinkers).

KITH 'N' KIN (C Barnes) - Slow to begin. Lay inwards in the run home, with the rider swapping the whip to the left hand.

EXPRESS COUP (J Doyle) - Crowded and buffeted passing the 1100 metres when NOBELLEM shifted in and away from WESTWOOD which was improving forward. Again placed in restricted room near the 900 metres having to briefly steady when crowded for room.

WESTWOOD (D Cooper) - Shifted ground outwards under pressure over the concluding stages.

R Muniandy (NOBELLEM) - Issued with a warning after permitting his mount NOBELLEM to shift inwards crowding and buffeting EXPRESS COUP passing the 900 metres.

Race 3 HELENSBROOK PROPERTIES 2200m

LILY OF THE VALLEY (T Moseley) – Restrained behind runners to obtain cover shortly after the start.

JESSIE'S ROCK (R Muniandy) – From its wide barrier draw was restrained behind runners to obtain cover shortly after the start. When asked to comment on the disappointing performance, the rider could offer no tangible excuse. Trainer T Kennedy advised they would be reassessing the racing future of the gelding.

ZAMBEZI ZIPPER (K Bakker) - Raced keenly through the early and middle stages.

BAUBLE (C Campbell) - Lay in throughout the run home and was dictated inwards by WIND IN MY WINGS (K Chowdhoory) which shifted in near the 200 metres with BAUBLE continuing to lay in hampering SCARLETT'S PROMISE which had to briefly steady. Both C Campbell and K Chowdhoory were advised to exercise greater care and straighten their mounts sooner than they had on this occasion.

SCARLETT'S PROMISE (S Wynne) - Placed in restricted room having to briefly steady near the 100 metres.

Race 4 EDINBURGH REALTY MAIDEN 1600m

EPILOGUE (J Fawcett) - Slow to begin. Raced in restricted room near the 250 metres. Crowded near the 150 metres and forced across heels having to be steadied when denied a marginal run to the inside of EMPRESS SUIKO (S Wynne) which lay in under pressure at this point. S Wynne was advised to exercise greater care.

GENTLE BEN (D Bothamley) - Slow to begin.

WILD JAKKAL (K Chowdhoory) - From its wide barrier draw was restrained behind runners to obtain cover shortly after the start.

MR GEE (C Campbell) - Steadied passing the 1400 metres to take a trailing position. Lay inwards throughout the run home

VAMOS (D Cooper) - Raced three wide without cover throughout.

Race 5 ENTAIN – NZB INSURANCE PEARL SERIES RACE 1600m

CATALINA BAY (A Najib) - Slow to begin. After being slow to begin improved onto the heels of MISS BELLE having to be steadied near the 1400 metres. Had to be steadied when becoming awkwardly placed inside heels near the 1000 metres. Rider lost his whip near the 250 metres. Crowded near the 200 metres and had to be steadied when KOTIRO TERE (J Doyle) shifted in and away from ALBATROSS (D Cooper) which was also shifting inwards. Both J Doyle and D Cooper were advised to exercise greater care when shifting ground.

RADIANT REACH (T Moseley) - Slow to begin.

ALBATROSS (D Cooper) - Restrained behind runners to obtain cover shortly after the start.

CHEYENNE DREAMS (A Goindasamy) - Held up rounding the final bend and early in the run home and continued to have trouble obtaining clear running until near the 200 metres.

Race 6 INTERIOR CONSTRUCTION 1600m

PLENTY O' STYLE (A Goindasamy) - Raced keenly through the early and middle stages. When questioned regarding performance, the rider expressed disappointment but added that the gelding may be looking for tracks with less moisture in them. Underwent a post-race veterinary examination which revealed a slow recovery rate. Stewards will follow up with connections in coming days.

DESCARO (T Moseley) - Raced keenly for a distance passing the 1400 metres when being restrained to obtain cover.

Race 7 RMG PUBLICANS CUP 1500m

EXCHANGE (C Campbell) - Slow to begin. Raced keenly through the early to middle stages. Was not persevered with in the run home when well beaten. Rider could offer no tangible excuse for the disappointing performance.

FIERY RED (T Moseley) - Dropped its head as the start was effected and as a result lost ground.

JIMMY FIVE (S Wynne) - Slow to begin. Raced wide without cover from the 900 metres. Lost the left front plate during the running.

GO LOTTE (K Bakker) - Restrained behind runners to obtain cover shortly after the start.

TAP 'N' GO (T Comignaghi) - Raced keenly while leading in the early to middle stages.

GENERATION JOY (A Goindasamy) - Held up from the 200 metres and went to the line not fully tested by its rider.

WATCH OUT (J Doyle) - When asked to comment on performance, the rider was of the opinion the mare may have been feeling the effects of recent racing.

Race 8 TEMUKA TRANSPORT 1400m

KID ROC (K Chowdhoory) - Raced three wide without cover throughout. Steadied to avoid heels near the 200 metres when inside runners shifted out.

BLEAKHOUSE BURTIE (S Toolooa) - Lay outwards throughout the run home shifting wider on the track and near the 100 metres dictated CEDDY SMITH into the line of ARCEUS.

CEDDY SMITH (A Najib) - Dictated wider on the track throughout the run home.

ARCEUS (D Cooper) - Crowded and checked passing the 100 metres when inside runners shifted out.

SAUVAGE (C Campbell) - Made contact with ATOMIC near the 100 metres with both runners becoming briefly unbalanced. Crowded and unbalanced passing the 50 metres when inside runners shifted out.

ATOMIC (R Muniandy) - Briefly unbalanced near the 100 metres. Crowded, buffeted and unbalanced passing the 50 metres when inside runners shifted out. Shifted in under pressure near the 25 metres making contact with SAUVAGE, with both runners again becoming unbalanced.

MININJAGIRL (S Wynne) - When asked to comment on the performance of this favoured runner, the rider could offer no tangible excuse.

Connections of second placed horse SAUVAGE viewed replays of the final 100 metres before deciding not to proceed with a protest.

Connections of third placed horse CEDDY SMITH also viewed replays of the final 100 metres before deciding not to proceed with a protest.

S Toolooa (BLEAKHOUSE BURTIE) - Admitted a charge of careless riding in that he permitted his mount BLEAKHOUSE BURTIE to shift outwards throughout the run home dictating CEDDY SMITH outwards onto ARCEUS which was crowded and checked near the 100 metres and continued to shift out with SAUVAGE and ATOMIC both being contacted and unbalanced as a result. After considering submissions the Adjudicator imposed a suspension of S Toolooa's licence to ride in races from the conclusion of racing on Saturday 23 March until the conclusion of racing on Thursday 4 April, 6 national riding days.
