Race 2 VETS ON RIVERBANK HANDICAP 1600m

WAITUI ROSE (K Asano) – Trainer Mr. A Meadows advised Stewards, he was satisfied with the post-race condition of the mare, which has now been sent for a spell.

Race 1 HODGKISS REFRIGERATION HANDICAP 1400m

KICK START (J Doyle) - Slow away.

HAPPY HERO (L Sutherland) - Over-raced for a distance when being restrained from near the 1200 metres. When questioned into performance rider advised that after over-racing in the early stages, had little left at the finish.

RICHTER (L Hemi) - Briefly held up rounding the final bend.

J Doyle (KICK START) - Admitted a charge in that he struck his mount KICK START six times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 2 ENTAIN – NZB INSURANCE PEARL SERIES MAIDEN RACE 1600m

VICKEZZMARGAUX (B Jacobson) - Restrained to the rear.

MIYAZAWA (C Dell) - Slow away.

SWEET ENVY (J Doyle) - When questioned regarding performance, rider could offer no excuse. Underwent a post-race veterinary examination including an endoscopy, which revealed the filly to be suffering from a respiratory infection. Connections were advised a veterinary clearance is required prior to SWEET ENVY racing next.

Race 3 WAIBUILD MAIDEN 1600m

FIRST EDITION (J Doyle) - Began awkwardly, bumping WAL.

WAL (J Riddell) - Bumped at the start.

TRIATHLON (C Lindsay) - Raced wide throughout.

ZERNE (C Barnes) - Raced four-wide throughout. Raced greenly throughout.

WISH ME WELL (K Hercock) - Raced greenly over the concluding stages.

Race 4 SPEIRS FINANCE 1000m

There was a delay to the start of this race due to an area of rail having to be replaced at the gap. There was a further delay when GUESSING GAME reared in its stall, having to be removed to undergo a veterinary examination prior to being declared a late scratching at 3.04pm.

GUESSING GAME (L Sutherland) - Reared in its stall, removed to undergo a veterinary examination prior to being declared a late scratching. Connections were advised a veterinary clearance is required for GUESSING GAME and in addition must barrier trial to the satisfaction of Stewards prior to racing next.

ENERGIZE (B Jacobson) - Removed from its stall, underwent a pre-race veterinary examination and was cleared to start.

GURTLYN (T Davies) - Slow away.

HAVARTI (J Riddell) - Briefly held up rounding the final bend.

ORGULLO (K Hercock) - Lay inwards under pressure over the concluding stages.

Race 5 MITRE 10 MEGA MASTERTON MAIDEN 1300m

SNORT (K Hercock) - Began awkwardly hampering SPEED DIAL, which lost ground.

SPEED DIAL (L Sutherland) - Hampered at the start, losing ground.

SWISS BELT (J Chung) - Raced wide through the early stages.

PACIFICO (B Jacobson) - Held up rounding the final bend.

TIVACI'S JOY (C Barnes) - Held up rounding the final bend. Tightened 75 metres.

MAGGIE MCMUFFIN (L Allpress) - Hampered 75 metres.

THE SCUNNER (J Riddell) - Raced greenly over the concluding stages.

B Jacobson (PACIFICO) - Admitted a charge of careless riding in that he permitted PACIFICO to shift outwards when not sufficiently clear of TIVACI'S JOY which was tightened and MAGGIE MCMUFFIN which was hampered near the 75 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Friday, 8 March until the conclusion of racing on Thursday, 14 March, 4 national riding days.

Race 6 THE WRIGHT CABINS 2050m

NEVER LOOK BACK (C Lindsay) - Slow away.

BILLY EASTON (C Barnes) -Restrained to the rear from its wide draw.

WHANGAEHU (L Allpress) - Held up rounding the final bend.

RUBY ROCKS (T Davies) - Lay outwards under pressure over the concluding stages. T Davies was shown footage of her ride in the presence of senior jockey K Hercock and advised she is expected to keep her mount straight when circumstances permit.

LOVE JANIE (M Hashizume) - Lay inwards under pressure over the concluding stages.

WHANGAEHU (L Allpress) - Rider advised her saddle had slipped shortly after the start.

Race 7 AUTOGROOM-KOOLTINTZ MAIDEN 2050m

REDANA (M Hashizume) - Hampered at the start losing ground. Improved on to heels near the 600 metres having to be steadied.

TIMMY (T Davies) - Lay inwards under pressure over the concluding stages.

CALL A FRIEND (J Chung) - Lay inwards on several occasions over the concluding stages, having to be straightened. J Chung was shown footage of his ride in the presence of Trainer L Latta and advised he is expected to keep his mount straight when circumstances permit.

SOL DE OTONO (L Sutherland) - Raced greenly entering the home straight. Hampered over the concluding stages when CALL A FRIEND lay inwards.

Connections of the 2nd placed SOL DE OTONO viewed footage of the home straight but elected not to proceed with an objection against the 1st placed CALL A FRIEND.

KINGSTON HEATH (C Barnes) - Co-trainer J Benner advised the gelding's racing future would be reassessed after disappointing today.

REAL DIVINE (J Doyle) - Co-trainer J Benner advised the filly's racing future would be reassessed after disappointing today.
