Race 8 AUCKLAND CO-OP TAXIS 2100

REBECCHI (M McNab) – Trainer A Forsman reported to Stewards REBECCHI underwent a veterinary examination on Thursday 22 February which included an exercising ECG with results showing no abnormalities. A Forsman further reported the gelding has now been sent for a spell and will trial prior to its next race day start. RACE COMMENTS

Race 1 MATAMATA FUNCTION CENTRE MAIDEN 1600

MINOIL (P Graberg) - Crowded shortly after the start losing ground.

DEMBE (C Barnes) - Slow to begin. Lay outwards when placed under pressure in the final straight.

SOUL QUEEN (T Abel) - Raced greenly in the early stages and when making the junction onto the course proper, lay out running wider on the track. Rider T Abel reported that her saddle had slipped after SOUL QUEEN shifted abruptly placing her at a disadvantage.

VARALLO (M Hashizume) – Lay outwards when placed under pressure in the final straight inconveniencing BENNETON approaching the 200 metres.

BENNETON (R Elliot) - Inconvenienced approaching the 200 metres.

Following this race the track was upgraded to Soft 6.

Race 2 MATAMATA RACING CLUB MEMBERS 1400

CORBATIN (M Cameron) - Began awkwardly losing ground. Returned to the enclosure with blood present in both nostrils. Following a veterinary examination CORBATIN was confirmed to have bled. Trainer J Collett was advised that CORABATIN is now ineligible to race in New Zealand as this was its second attack of nasal bleeding.

FIRRIATO (O Bosson) - Slow to begin. Briefly steadied near the 200 metres when EVE'S SONG lay inwards. When questioned regarding performance the rider advised that the mare had over-raced through the early stages which had been detrimental to its chances.

CHANTARI BAY (T Mitchell) – Crowded shortly after the start losing ground.

MR BIG (N Hailey) - Improved onto heels having to be steadied near the 1100 metres. Commenced to give ground passing the 800 metres. Underwent a post-race veterinary examination which revealed no abnormality. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

EVE'S SONG (W Kennedy) – Raced three wide without cover throughout. Lay inwards when placed under pressure in the final straight.

Race 3 FAREWELL DAVE BRADFORD MAIDEN 1400

LIGHTNING DREAM (O Bosson) – Began awkwardly then knuckled shortly after the start, losing ground. Shifted outwards to obtain clear running near the 100 metres.

UP WITH CHARM (L Satherley) - Crowded shortly after the start losing ground. Held up for a distance passing the 350 metres.

ROSIE'S DREAM (J Doyle) - Began awkwardly then hampered shortly after.

PENSAMOI (W Kennedy) - Over-raced through the early stages.

LEMON CURD (U Holmquist) - Raced three wide without cover throughout. Inconvenienced near the 100 metres.

TOA TUAHINE (N Hailey) - Lay outwards when placed under pressure in the final straight.

FULL MOON FEVER (P Graberg) – Lay outwards when placed under pressure in the final straight.

ALATION (C Barnes) - Shifted out and away from LIGHTNING DREAM inconveniencing LEMON CURD and LOVELY FRIENDS near the 100 metres.

TROUT (M Cameron) - Hampered passing the 100 metres when LOVELY FRIENDS was forced outwards.

LIVING IN HOPE (T Mitchell) - Inconvenienced near the 50 metres when FULL MOON FEVER lay outwards.

LOVELY FRIENDS (M McNab) - When questioned regarding performance the rider advised that being caught wide had been detrimental to the gelding's chances. Inconvenienced near the 100 metres.

Race 4 CONGRATS CAPTURED BY LOVE & TE AKAU RACING MAIDEN 1200

ENDUED (M McNab) – Began awkwardly losing ground.

I'M ALL IN (W Kennedy) - Began awkwardly losing ground. Raced keenly in the early stages when being restrained.

ALTARI (O Bosson) - Raced three wide without cover throughout.

STONE STREET (M Hashizume) - Improved onto heels near the 150 metres when racing greenly.

LITTLE THIEF (R Elliot) - Had difficulty obtaining clear running until the 100 metres. Lay inwards when placed under pressure in the final straight.

R Elliot (LITTLE THIEF) - Issued with a warning after using his whip in two consecutive strides on his mount near the 50 metres.

Race 5 MATAMATA RACING CLUB – LIFE MEMBERS MAIDEN 1200

IMPERIAL EMPRESS (M McNab) – Began awkwardly losing ground.

FINNT (K Myers) - Slow to begin. Briefly steadied when placed in restricted room to the inside of KING'S MOUNT which was laying inwards and outside of FASCINATION near the 100 metres. N Hailey (KING'S MOUNT) was advised exercise greater care in similar circumstances.

KING'S MOUNT (N Hailey) - Raced keenly through the early stages when being restrained.

SPACE LAB (J Fawcett) - Raced keenly through the early stages. Steadied to avoid heels near the 900 metres then raced three wide without cover.

CINTIVEE (W Kennedy) - Lay inwards when placed under pressure in the final straight. Had to be briefly steadied when lay inwards across heels approaching the 200 metres.

YOUNG DIVA (L Satherely) - Had difficulty obtaining clear running for the majority of the straight.

FASCINATION (O Bosson) - Raced in restricted room to the outside of CINTIVEE having to briefly steady near the 50 metres.

CHLOE'S COMET (M Cameron) - When questioned regarding performance the rider advised that the mare was unable to find the lead today which was detrimental to its chances. Underwent a post-race veterinary examination which revealed no abnormality.

Race 6 **CONGRATS SAVAGLEE & BALLYMORE STABLES MAIDEN 1200** BAMBI (J Fawcett) - Contacted and crowded at the start losing ground. When questioned regarding performance the rider advised that the filly would be better suited to a rain affected track. Underwent a post-race veterinary examination which revealed the filly to have an abrasion to the right hind fetlock. **BERNIE'S EGO** (N Hailey) – Restrained at the start to obtain cover from a wide barrier. SURF QUEEN (S Weatherley) - Restrained at the start to obtain cover from the outside barrier. BALLS OF FIRE (B Jacobson) - Raced three wide without cover throughout. EMMY DAZZLER (A Lawson-Carroll) - Had difficulty obtaining clear running throughout the final straight. **REMEMBERING DAVID BENJAMIN 2000** Race 7 **MOTUMAN** (B Jacobson) - Slow to begin (5L). Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next. **ORSOME DUDE** (N Hailey) – Raced keenly through the early stages. Lay outwards rounding the final bend. Inconvenienced approaching the 100 metres. YOU KNOW (J Fawcett) - Raced three wide without cover until improving to race outside the leader near the 1400 metres. HOARD THE BOURBON (M McNab) – Raced three wide without cover throughout. Lay outwards rounding the final bend. **DEVOTED** (J Allen) – Lay outwards when placed under pressure in the final straight inconveniencing ORSOME DUDE approaching the 100 metres. SOUTH WAIKATO RC RACING @ MATAMATA 13TH MARCH 2024 MAIDEN 2000 Race 8 ZLATNA (M Cameron) - Slow to begin. Underwent a post-race veterinary examination including an endoscopic examination which revealed the filly to be 2/5 lame in the left hind leg. Connections were advised a veterinary clearance would be required prior to racing next. UPLIFTING (S Weatherley) - Slow to begin. SLEDGE HAMMER (B Jacobson) - Had to be steadied to avoid heels passing the 1900 metres then commenced to over-race in the early and middle stages. **MAGICAL ROAD** (N Hailey) – Raced three wide without cover throughout. ROCKY BALBOA (C Grylls) - Firmly contacted and unbalanced being forced wider near the 600 metres. KARASAWA (J Fawcett) - Underwent a post-race veterinary examination which revealed no abnormality.

P Graberg (SLEDGE HAMMER) - Issued with a minor infringement and fined \$200 after he broke a riding engagement. B Jacobson replaced P Graberg.

U Holmquist (NORTHERN RAIDER) - Admitted a charge of careless riding in that she directed her mount NORTHERN RAIDER outwards when not sufficiently clear of ROCKY BALBOA which was firmly contacted and unbalanced being

forced wider near the 600 metres. After considering submissions the Adjudicative Committee imposed a suspension of U Holmquist's licence to ride in races from the conclusion of racing on Saturday 9 March up to and including racing on Wednesday 20 March, 6 national riding days.
