RACE COMMENTS

Race 1 CAT'S KARAKA PICK LOT 265 HANDICAP 1600m

HEY HEY HEY (K Asano) - Slow to begin.

PHOENICIANPRINCESS (L Sutherland) - Contacted at the start.

SCRIPT (E Nicholas) - Raced wide without cover until approaching the 1000 metres. Raced keenly through the early and middle stages.

MAHOE (J Doyle) - Lay outwards when placed under pressure in the final straight.

Race 2 VENUE SOLUTIONS MAIDEN 1400m

KNIGHTS REALM (E Nicholas) - Began awkwardly. Raced keenly in the early stages when being restrained. Lay inwards when placed under pressure in the final straight. Hampered by MAGPIE, which had gone amiss shortly after the winning post, resulting in KNIGHTS REALM falling and dislodging rider E Nicholas. Stewards will follow-up with Trainer C Isdale in coming days regarding the post-race condition of KNIGHTS REALM. E Nicholas was attended to by St John personnel and stood down for the remainder of the day. E Nicholas is required to provide a medical clearance prior to riding next.

WHO KNOWS (M Hudson) - Contacted at the start when MOKOHINAU jumped outwards. Raced keenly in the early stages, having to be steadied passing the 1200 metres. Lay outwards rounding the final bend and continued to do so when placed under pressure in the final straight.

WISH ME WELL (K Hercock) - Crowded at the start. Over-raced through the early and middle stages.

TIVACI'S JOY (J Doyle) - Raced wide without cover for the majority of the event.

DYNAMO EXPRESS (W Pinn) - Raced wide without cover until improving to sit outside the leader near the 900 metres.

HASBULLA (K Asano) - Had difficulty obtaining clear running until passing the 200 metres.

MAGPIE (T Moodley) - Went amiss when racing free from interference shortly after the winning post, dislodging rider T Moodley. MAGPIE was immediately attended to by the oncourse veterinarian with the horse ambulance being deployed. The gelding was found to have suffered a fetlock dislocation to the right foreleg and was subsequently humanely euthanised. T Moodley was attended to by St John personnel and cleared of any injury.

Following the running of this race a number of riders expressed concern regarding the surface of the track which was described as inconsistent in final straight. A track Safety Review Panel consisting of Stewards and Senior Jockeys was convened. Following a track inspection and a subsequent meeting with all riders and club officials, the remainder of the race meeting was abandoned due to the inconsistencies of the track.
