<b>Race 1</b>	<b>DAKOTA BUTIQUE + LIFESTYLE 820m</b>

**JETSTREAM** (A Najib) - Slow to begin.

**MORE SASS** (K Williams) - Slow to begin. Treated post-race by the on-course Veterinarian after being found to be non-weight bearing in the left hind leg. Connections were advised that a veterinary clearance is required prior to racing next.

**MAMAEA** (J Fawcett) - From its wide barrier draw restrained behind runners to obtain cover.

**NUCLEOZOR** (A Goindasamy) - Raced wide without cover through the early to middle stages.

**GREAT TIME** (S Wynne) - Raced wide without cover throughout. Shifted outwards under pressure over the concluding stages.

**PERFECT GLORY** (L Callaway) - Steadied off heels near the 650 metres when DISCRETION RULES shifted inwards at this point. Required post-race veterinary treatment when found to be lame in the left-foreleg. Stewards will follow up with connections in coming days. Trainer S Muniandy was advised that a veterinary clearance is required prior to racing next.

**L Sutherland** (DISCRETION RULES) - Issued with a warning after permitting her mount DISCRETION RULES to shift inwards when not fully clear of PERFECT GLORY which had to be steadied near the 650 metres.

<b>Race 2</b>	<b>GRAND CASINO MAIDEN 1600m</b>

**HAKAHARRY** (B Rogerson) - Slow to begin. Got its head up when being steadied off heels near the 700 metres when the tempo came out of the race.

**SALAAM NAMASTEY** (R Muniandy) - Slow to begin. Steadied off heels near the 900 metres.

**ALMANAC** (K Williams) - Slow to begin. Improved wide from the 800 metres.

**RACCOURCI** (S Wynne) - Began awkwardly crowding MISS ENZED. Crowded when tiring near the 50 metres.

**IMPERATIVE** (B Grylls) - Taken back from a wide draw to obtain cover shortly after the start.

**MISS ENZED** (L Sutherland) - Crowded shortly after the start losing ground. Steadied off the heels of PEEKAY which was forced outwards near the 350 metres.

**SUGAR TIME** (A Goindasamy) - Raced keenly through the early and middle stages.

**PATRAINE** (C Campbell) - Raced three wide without cover throughout.

**QUICK CALL** (L Hemi) - Got its head up when being steadied off heels near the 700 metres when the tempo came out of the race. Held up early in the run home and when shifting ground to find clear racing room near the 200 metres hampered MISS ENZED.

**DANZA** (L Callaway) - Steadied off heels near the 700 metres when the tempo came out of the race.

**PEEKAY** (T Moseley) - Contacted and unbalanced near the 350 metres on two occasions when SALAAM NAMASTEY shifted out looking for clear racing. Contacted by SALAAM NAMASTEY on a number of occasions in the run home when both runners shifted ground.

**L Hemi** (QUICK CALL) - Issued with a warning after shifting ground outwards passing the 200 metres hampering MISS ENZED which had to be steadied away from heels.

**R Muniandy** (SALAAM NAMASTEY) - Admitted a charge of careless riding after permitting his mount SALAAM NAMASTEY to shift outwards near the 350 metres when not sufficiently clear of PEEKAY which was contacted and forced wider hampering MISS ENZED. After considering submissions the Adjudicator imposed a suspension of R Muniandy's licence to ride in races from the conclusion of racing on Saturday 2 March until the conclusion of racing on Saturday 9 March, 5 national riding days.

Following the running of the race the trainer of the third placed horse PEEKAY, Mr T Kennedy, lodged a protest with the Adjudicator alleging interference throughout the run home by the second placed horse SALAAM NAMASTEY. After considering submissions the Adjudicator dismissed the protest with the placings standing 1<sup>st</sup> PATRAINE, 2<sup>nd</sup> SALAAM NAMASTEY, 3<sup>rd</sup> PEEKAY, 4<sup>th</sup> ALMANAC.

<b>Race 3</b>	<b>DUNEDIN CITY MOTORS 2200m</b>

**VERISMO** (B Grylls) - Slow to begin. When questioned regarding performance, the rider advised that the mare had lay outwards during the running and in her opinion may have come to the end of its current campaign.

**LEAVE IT TO ME** (S Wynne) - Slow to begin.

**PONTARDAWE** (U Holmquist) - Slow to begin and then ridden with urgency to recover.

**BAUBLE** (L Callaway) - Jumped away awkwardly losing ground. Became awkwardly placed on heels having to steady when MAYOR OF NORWOOD (C Campbell) shifted inwards near the 2000 metres. C Campbell was advised to exercise greater care.

**REELROSE** (L Hemi) - Raced wide in the early stages before taking the lead near the 1500 metres.

**STAR BALLOT** (T Comignaghi) - Over raced for a distance passing the 1200 metres then shifting outwards across heels and being obliged to race wide without cover for the remainder of the race.

**MAYOR OF NORWOOD** (C Campbell) - Inclined to lay inwards throughout the run home with the rider swapping the whip to the left hand.

<b>Race 4</b>	<b>POSITIVE SIGNS + PRINT 1200m</b>

**MILLEFIORI** (L Sutherland) - After becoming fractious in its barrier was removed to undergo a veterinary inspection which showed the mare to be lame in the near-hind leg with an abrasion to the near-hind cannon bone with blood present, being declared a late scratching at 1:46pm with the horse ambulance deployed. Connections were advised

that MILLEFIORI is required to provide a veterinary clearance prior to racing next. As a result of the late scratching the start was delayed approximately 2½ minutes.

**ZOULANDER** (K Williams) - Slow to begin.

**OUR ECHO** (T Comignaghi) - Lay inwards near the 200 metres having to be straightened by its rider.

**SPARTAN** (D Montes de Oca) - Rider could offer no tangible excuse for the disappointing performance.

**Race 5**

**SPEIGHT'S 1200m**

**RU BRADAR** (A Goindasamy) - Began awkwardly making contact with MAGNETO.

**MAGNETO** (K Williams) - Contacted at the start losing ground. Held up early in the run home, gaining clear racing room passing the 250 metres.

**BLEAKHOUSE BURTIE** (B Grylls) - Slow to begin and out paced through the early and middle stages despite the efforts of the rider.

**PERFECT MOMENT** (K Bakker) - Slow to begin.

**JUSTANACE** (A Najib) - Raced three wide without cover throughout.

**BOURBON CHIQUE** (B Rogerson) - Held up early in the run home.

**ONCEACONNER** (L Callaway) - Crowded and had to steady near the 275 metres when TUMUCH lay in before being straightened by its rider, with some outwards movement from RUN BABY RUN which was tiring at this point.

**TUMUCH** (J Fawcett) - Lay in in the run home having to be straightened on a number of occasions, with the rider swapping the whip to the left hand over the concluding stages.

**Race 6**

**BE MY GUEST DESIGN 1600m**

Co-trainers **M & M Pitman** were fined \$50 under the Minor Infringement Schedule after presenting TOMYTURBO with the incorrect saddle cloth number.

**CHEYENNE DREAMS** (A Goindasamy) - Underwent farrier attention behind the barriers after losing a plate on the way to the start. From its wide barrier draw was restrained behind runners to obtain cover.

**SCARLETT'S PROMISE** (S Toolooa) - Began awkwardly making contact with WHINY MEOW and as a result lost ground.

**WHINY MEOW** (J Fawcett) - Contacted at the start losing ground. Got its head up when being steadied off heels near the 700 metres.

**DAVID MOSS** (K Mudhoo) - Slow to begin.

**ON THE RIVET** (T Moseley) - Slow to begin.

**TWILIGHT GEM** (B Grylls) - Slow to begin.

**TOMYTURBO** (K Chowdhoo) - Slow to begin.

**TELLING TALES** (L Hemi) - Restrained behind runners to obtain cover shortly after the start.

**MISS BELLE** (C Campbell) - Restrained behind runners to obtain cover shortly after the start. Held up in the middle part of the run home, going to the line not fully tested by its rider.

**LUCIENNE** (R Muniandy) - Raced wide without cover throughout.

**Race 7** | **NELLIES RESTAURANT & BAR 1400m**

**ALBAZINGA** (L Callaway) - Shifted outwards at the start crowding KITH 'N' KIN before being corrected by its rider. Held up early in the run home. Shifted in to take a marginal run passing the 300 metres and then crowded and checked passing the 200 metres.

**KITH 'N' KIN** (U Holmquist) - Crowded at the start losing ground and then forced outwards contacting outside runners. Shifted inwards under pressure in the run home.

**GO LOTTE** (D Cooper) - Contacted at the start.

**HENLEY** (C Campbell) - Contacted at the start.

**DIVINE REGULUS** (B Rogerson) - Blundered at the start and then contacted losing ground as a result.

**MADAM DUBAI** (A Goindasamy) - Began awkwardly making contact with DIVINE REGULUS. Held up rounding the final bend and early in the run home. Placed in restricted room early in the run home when ALBAZINGA shifted ground looking for clear racing room. Was then crowded and checked passing the 200 metres when TIKKI was taken inwards by KITH 'N' KIN.

**COLLECT YOUR CASH** (T Moseley) - From its wide barrier draw was restrained to obtain cover shortly after the start.

**DIVINE SAVA** (B May) - Raced three wide without cover throughout.

**L Callaway** (ALBAZINGA) - Issued with a warning after permitting his mount ALBAZINGA to shift inwards when not sufficiently clear of MADAM DUBAI which was placed in restricted room passing the 300 metres.

**U Holmquist** (KITH 'N' KIN) - Issued with a warning after permitting her mount KITH 'N' KIN to shift inwards dictating TIKKI inwards onto ALBAZINGA and MADAM DUBAI which were both crowded and checked passing the 200 metres.

**A Comignaghi** (TIKKI) - Issued with a warning after permitting her mount TIKKI to shift inwards crowding and checking ALBAZINGA and MADAM DUBAI passing the 200 metres.

**Race 8** | **NZB AIRFREIGHT STAKES 1400m**

**LADY SASS** (K Williams) - Underwent a veterinary inspection on arrival at the barriers and was cleared to race. Stood flat footed as the start was effected and took no part in the race. Connections were advised that LADY SASS is required to barrier trial on at least two occasions to the satisfaction of a Stipendiary Steward prior to racing next. Connections advised it was their intention to send LADY SASS for a spell.

**AMIINIT** (L Callaway) - Knuckled badly at the start dislodging its rider. L Callaway was attended to by St John Paramedics and cleared to fulfil his remaining riding engagements. AMIINIT underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**RAPTYLIGHT** (T Moseley) - Shifted outwards at the start dictating outside runners wider on the track. Contacted and forced wider near the 400 metres.

**THE REAL TREASURE** (C Campbell) - Dictated wider at the start making contact with LADY OF COURT and losing ground. Crowded and checked when DRAKAINA was taken in by the riderless horse near the 400 metres.

**LADY OF COURT** (L Sutherland) - Contacted at the start losing ground. Crowded and forced inwards across heels having to be checked near the 150 metres.

**DRAKAINA** (J Fawcett) - Shifted outwards at the start crowding SENSE OF TIMING. After the winning post was taken outwards abruptly by the riderless horse, with DRAKAINA making contact with the outside fence and the rider being dislodged. J Fawcett was uninjured in this incident. DRAKAINA was found to have minor superficial lacerations to the right hind and right shoulder.

**SENSE OF TIMING** (A Goindasamy) - Crowded at the start. Held up early in the run home and when attempting a run near 200 metres was taken inwards onto HOT COCO near the 150 metres..

**EPEE BEEL** (T Comignaghi) - Raced in restricted room passing the 900 metres and then raced three wide without cover from the 800 metres. Crowded and forced wider onto RAPTYLIGHT passing the 400 metres.

**WARNING SIGNAL** (S Wynne) - Dictated wider on the track passing the 400 metres when inside runners shifted out.

**HOT COCO** (K Chowdhooory) - Placed in restricted room and had to be steadied when SENSE OF TIMING shifted in and away from TEXAS DOLLY (L Hemi) which shifted in under pressure passing the 150 metres. L Hemi was advised to exercise greater care.

**B May** (BLINK OF AN EYE) - Admitted a charge of careless riding in that he permitted his mount BLINK OF AN EYE to shift inwards under pressure passing the 150 metres forcing LADY OF COURT inwards across heels having to be checked. After considering submissions the Adjudicator imposed a suspension of B May's licence to ride in races from the conclusion of racing on Sunday 10 March until the conclusion of racing on Friday 22 March, 6 national riding days.

**L Hemi** (TEXAS DOLLY) - Admitted a charge of careless riding in that she angled her mount TEXAS DOLLY outwards passing the 400 metres forcing EPEE BEEL and RAPTYLIGHT wider on the track, with WARNING SIGNAL being hampered as a result. After considering submissions the Adjudicator imposed a suspension of L Hemi's licence to ride in races from the conclusion of racing on Saturday 9 March until the conclusion of racing on Sunday 17 March, 5 national riding days.

**NAMIBIA MISS** (L Sutherland) - Began awkwardly losing ground.

**AYREON** (L Hemi) - Slow to begin.

**CHARBANO** (L Callaway) - Slow to begin.

**THE GREY GOOSE** (K Williams) - Slow to begin.

**SPROCKET ROCKET** (T Moseley) - Restrained behind runners to obtain cover shortly after the start.

**UNUSUAL AFFAIR** (R Muniandy) - Restrained behind runners to obtain cover from a wide draw shortly after the start.

**TURF WAR** (S Wynne) - Raced three wide without cover throughout.

**INFLAMED** (C Campbell) - Raced in restricted room near the 50 metres when outside runners shifted in.

**K Williams** (THE GREY GOOSE) - Issued with a warning after allowing her mount THE GREY GOOSE to shift inwards under pressure dictating POVERY BAY inwards onto GENERATION JOY which was forced inwards across heels having to steady near the 200 metres.

**K Williams** (THE GREY GOOSE) - Admitted a charge of careless riding in that she allowed her mount THE GREY GOOSE to shift inwards passing the 50 metres crowding TURF WAR which was checked. This matter was adjourned for hearing on Thursday 7 March at the Canterbury Jockey Club meeting at Riccarton Park due to Ms Williams having flight commitments.

**ALBATROSS** (K Bakker) - Slow to begin.

**IT'S THE VIBE** (D Montes de Oca) - Slow to begin. Raced wide without cover throughout.

**UNLEASHED** (L Hemi) - Restrained behind runners to obtain cover shortly after the start.

**JESSIE'S ROCK** (A Goindasamy) - From a wide barrier draw restrained behind runners to obtain cover shortly after the start.

**GINTYS GIRL** (B May) - Raced keenly through the early and middle stages.

**RHAEGAR** (R Muniandy) - Raced three wide without cover throughout.

**SHE'S AN ACE** (L Callaway) - Held up rounding the final bend and for the majority of the final straight, only obtaining clear running passing the 150 metres.

**FINGERPRINTED** (K Chowdhoo) - Lay out rounding the final bend and when being corrected by its rider shifted in abruptly passing the 375 metres having to be corrected by its rider.

**HUGS** (T Moseley) - When spoken to regarding the performance of this favoured runner, rider T Moseley was of the opinion that being trapped on the fence was a disadvantage and that the gelding battled on fairly over the concluding stages.
