Race 5 PLUNKET ELECTRICAL 2200m

MILFORD SOUND (A Goindasamy) – Trainer Ms. A Tuthill advised Stewards, that upon return to the stable the gelding underwent blood tests which revealed a respiratory infection, further blood tests will be taken Wednesday 31 July. A Tuthill further advised MILFORD SOUND has been treated with antibiotics for the infection and will continue on with the gelding's current preparation.

Race 9 EASY MADE MARMALADE LTD 1200

THEE AULD MINX (K Williams) - Stable representative Mr. R Mildon reported to Stewards, that on Monday 22 July, THEE AULD MINX, underwent a veterinary examination which included blood tests which revealed a high white blood cell count, with further blood tests being taken on Thursday 25 July which confirmed THEE OLD MINX'S white blood cell count to be back to normal. R. Mildon further advised the mare was given a few days break and it is the stables intention to look to nominate THEE AULD MINX for the Canterbury JC meeting on Saturday 3 August.

RACE COMMENTS

Race 1 SUMMIT ULTRA ON TAP MAIDEN HURDLE (3100m)

MR FABULOUS (J Kozaczek) - Crowded between runners at the start losing ground.

MURPHY (D Parker) – Put in a poor jump at the second fence unbalancing its rider. Mixed its jumping throughout. Landed awkwardly after jumping the last fence.

TREATY OF PARIS (H McNeill) - Jumped the fence near the 800 metres awkwardly then came under pressure shortly after, failing to respond and becoming tailed off. Blundered after jumping the second last fence. Put in a poor jump at the final fence dislodging its rider. H McNeill was attended to by oncourse St John Personnel and found to be uninjured. Lost a front plate during the running. When questioned regarding the performance rider advised that the gelding had travelled well until placed under pressure where it had been quickly beaten and, in his opinion had found today's track conditions too testing. Underwent a post-race Veterinary examination which revealed the gelding to have a slow recovery and a high heart rate. The stable representative was advised a veterinary clearance would be required prior to the gelding racing next and indicated that TREATY OF PARIS was now likely to be spelled.

TEEN TITAN (P Matthews) - Put in a poor jump at the second to last fence. Rider dropped her whip just short of the finish.

CHOLULA (S Karnicnik) - Had a tendency to run down its fences throughout.

H McNeill (TREATY OF PARIS) - Admitted a charge in that he failed to retire his mount TREATY OF PARIS from the race when out of contention. After considering submissions the Adjudicative Committee imposed a fine of \$900.

J Parker (ZAC FLASH) - Issued with a warning after making contact with connections when unsaddling.

Race 2 AVON CITY FORD SYDENHAM HURDLES (3100m)

METALLO (J Kozaczek) - Blundered on landing after jumping the first fence.

OBRIGADO (S Karnicnik) - Badly misjudged the fence near the 800 metres and fell. Underwent a post-race veterinary examination which did not reveal any abnormality. S Karnicnik was attended to by oncourse St John Personnel and found to be uninjured.

RUN JAKKO RUN (D Parker) - Put in a poor jump at the second to last fence.

DICTATION (H McNeill) - Put in a poor jump at the final fence and blundered badly on landing dislodging its rider. Underwent a post-race veterinary examination which did not reveal any abnormality. H McNeill was attended to by oncourse St John Personnel and found to be uninjured.

LORD SPENCER (L Douglas) - Hampered by the riderless horse after jumping the final fence.

Race 3 PROWESS SELLING NOW ON GAVELHOUSE PLUS + 3YO (1200m)

MR PACQUIAO (K Bakker) - Began awkwardly losing ground.

LIQUID BLUE (D Cooper) - Began awkwardly making contact with JETSTREAM. Rider reported that the filly had hung inwards throughout.

JETSTREAM (W Kennedy) - Contacted on jumping.

TARVOS (L Sutherland) - Briefly held up making the junction near the 600 metres having to be steadied and shifted outwards across heels to obtain clear running. Raced greenly shifting ground under pressure in the straight.

Race 4 CHRISTCHURCH CASINO 29TH SOUTH ISLAND AWARDS - 13 SEPTEMBER HANDICAP (1200m)

EPEE BEEL (W Kennedy) - Began awkwardly losing ground.

BENAUD (A Najib) - Crowded at the start losing ground.

MIDNIGHT RUNNER (R Muniandy) - Over-raced in the early stages on a moderate tempo.

LOUIE LOUIE (J Doyle) - Had some difficulty obtaining clear running until near the 150 metres.

THE GOOD SHEPHERD (A Goindasamy) - Briefly steadied passing the 50 metres when MAKABAR (K Williams) shifted inwards under pressure. K Williams was advised to exercise greater care.

A Najib (BENAUD) - Admitted a charge in that he struck his mount BENAUD 8 times prior to the 100 metres mark. After considering submissions the Adjudicative Committee imposed a suspension of Mr Najib's licence to ride in races from the conclusion of racing on Wednesday 7 August until the conclusion of racing on Wednesday 21 August 2024, 9 national riding days.

Race 5 RACECOURSE HOTEL & MOTOR LODGE KORAL STEEPLCHASE (4250m)

CAPTAINS RUN (J Kozaczek) - Slow into stride. Jumped the first fence hesitantly losing momentum.

DONARDO (P Matthews) - Retired from the event after putting in a poor jump at the fence near the 800 metres. Underwent a post-race veterinary examination which revealed the gelding to be lame in the right hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

Race 6 AIRPARK CANTERBURY (1200m)

GAME DUKE (G Jogoo) - Began awkwardly losing ground.

THE IMMIGRANT (K Williams) - Jumped away awkwardly losing ground. Inclined to lay inwards throughout the final straight.

TONIA'S DRAGON (K Myers) - Shifted outwards at the start crowding outside runners. Inclined to lay outwards under pressure in the straight. Rider dropped her whip passing the 250 metres.

VICTOR ROUGE (D Tait) - Crowded at the start losing ground. Had to be steadied when placed in restricted room near the 1000 metres when racing to the inside of RADIANT ROSIE which was dictated inwards by OUR CLARRY (K Bakker). K Bakker was issued with a warning with Stewards also taking into account some outward movement from TONIA'S DRAGON.

OUR CLARRY (K Bakker) - Raced keenly through the early stages when leading.

ON THE WALL (L Sutherland) - Lay inwards under pressure in the straight.

CHENEY (C Barnes) - Crowded and raced in restricted room having to be steadied near the 50 metres when ON THE WALL shifted in and away from THE IMMIGRANT which was also laying in at this point.

THEE AULD MINX (A Goindasamy) - When questioned regarding performance rider advised that the mare had failed to handle today's holding track conditions.

K Bakker (OUR CLARRY) - Issued with a warning after permitting her mount OUR CLARRY to shift inwards crowding RADIANT ROSIE onto VICTOR ROUGE which had to be steadied near the 1000 metres.

Race 7 GOLD CLUB (1800m)

PROSERVE (W Kennedy) - Slow to begin.

SMOOTH OPERATOR (T Moseley) - Slow to begin. Inconvenienced passing the 250 metres when FIVE PRINCES (T Jonker) shifted outwards to obtain clear running. T Jonker was advised to exercise greater care.

RIVIERA REBEL (Y Atchamah) - Raced keenly in the early stages with the saddle shifting forward badly disadvantaging its rider for the remainder of the race.

CAPTAIN OUMUAMUA (K Bakker) - Raced three wide without cover throughout.

R Muniandy (TAIMATE DIVA) - Admitted a charge in that he struck his mount TAIMATE DIVA 9 times prior to the 100 metres mark. After considering submissions the Adjudicative Committee imposed a suspension of Mr Muniandy's licence to ride in races from the conclusion of racing today until the conclusion of racing on Sunday 11 August 2024, 6 national riding days.

T Jonker (FIVE PRINCES) - Admitted a charge in that she struck her mount FIVE PRINCES 7 times prior to the 100 metres mark with a further 4 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 8 WINTER FASHIONS HERE 10 AUGUST (1400m)

JESTIN CASE (C Dell) - Began awkwardly losing ground.

MININJAGIRL (A Goindasamy) - Slow to begin.

REDFORD (K Bakker) - Slow to begin then being restrained to obtain cover.

IN DISGUISE (C Barnes) - Raced wide without cover throughout.

Race 9 WINNING EGDE PRESENTATIONS 127TH WINTER CUP (GROUP 3) (1600m)

BAUBLE (K Chowdhoory) - Fractious in the barriers then bounded at the start losing ground.

TARAMEA LAD (K Williams) - Slow to begin.

ALJAY (L Sutherland) - Slow to begin.

HACKSAW RIDGE (K Kalychurun) - Very slow to begin.

BRADMAN (C Grylls) - Checked to avoid the heels of GREEN LUCK near the 1400 metres then being inclined to get its head up and race ungenerously before improving forward to lead near the 1000 metres.

CONOR O'CEIRIN (C Barnes) - Raced three wide without cover for the majority of the event.

JUSTASKME (S Weatherley) - Angled wider on the track near the 300 metres to obtain clear running.

FREEZE FRAME (W Kennedy) - Lay inwards under pressure over the concluding stages.

LOQUITA (K Hercock) - Held up over the final 100 metres after improving onto heels.

B May (GREEN LUCK) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of BRADMAN which was checked near the 1400 metres. After considering submissions the Adjudicative Committee imposed a suspension of Mr May's licence to ride in races from the conclusion of racing on Wednesday 7 August until the conclusion of racing on Wednesday 21 August 2024, 9 national riding days.

W Kennedy (FREEZE FRAME) - Admitted a charge in that he struck his mount FREEZE FRAME 6 times prior to the 100 metres mark with a further 6 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

S Weatherley (JUSTASKME) - Issued with a warning after weighing in 0.5kgs in excess of the weight at which he had weighed out.

Race 10 GROUP 1 RACEDAY PARTY – 14 SEPTEMBER (1600m)

MADISON ROSE (C Barnes) - Bounded at the start losing ground.

FABLUE (C Grylls) - Slow to begin.

HE'S TUNZA GRUNT (S Toolooa) - Slow to begin. Over-raced through the early and middle stages.

ON THE RIVET (A Goindasamy) - Taken back from a wide draw to obtain cover shortly after the start.

DRAKE'S DRUM (L Callaway) - Raced three wide without cover for the majority of the event.

HARMONIOUS (L Sutherland) - Held up rounding the final turn and early in the straight.

WHO'S SAM (K Hercock) - Lay inwards under pressure in the straight having to be steadied away from the heels of I HOPE I NEVER passing the 200 metres.
