Race 1	MICHAEL "MICKEY" BEECROFT MEMORIAL 0-1 WIN HURDLES 3100m
<p>JOLLY MOLLY (C Wiles) - Crowded at the start losing ground. Crowded passing the 2400 metres.</p> <p>MURPHY (N Downs) - Raced wide without cover through the early stages.</p> <p>CHOLULA (S Karnicnik) - Crowded passing the 2400 metres.</p> <p>SEMPER MAGICO (P Matthews) - Inclined to run its fences down throughout.</p> <p>DICTION (H McNeill) - Put in a poor jump at the fence near the 2000 metres and again at the final fence.</p> <p>ZAC FLASH (J Parker) - Mixed its jumping throughout. Blundered badly after putting in a poor jump at the third last fence. Hit the final fence. When questioned regarding performance, rider advised that the gelding had not jumped as well as on the first day and in his opinion had failed to back up.</p> <p>MR FABULOUS (J Kozaczek) - Misjudged the final fence and landed awkwardly.</p> <p>J Parker (ZAC FLASH) and C Wiles (JOLLY MOLLY) were both spoken to regarding their obligation to retire their mounts from the race when out of contention.</p> <p>N Downs (MURPHY) - Issued with a warning after permitting his mount MURPHY to shift inwards passing the 2400 metres placing CHOLULA and JOLLY MOLLY in restricted room.</p>	
Race 2	HOSPITALITY NZ 134TH GRAND NATIONAL HURDLES 4200m
<p>RUN JAKKO RUN (D Parker) - Began awkwardly losing ground.</p> <p>METALLO (J Kozaczek) - Jumped the second fence awkwardly. Rider dropped his whip approaching the 200 metres.</p> <p>TEEN TITAN (J Parker) - Raced wide for the majority of the race.</p> <p>NEDWIN (H McNeill) - Raced keenly in the lead in the early and middle stages. Badly misjudged the fence passing the 3000 metres unbalancing the rider. Landed awkwardly after jumping the second last fence when well beaten then being retired from the race. When questioned regarding performance, rider advised that after over racing and putting in a couple of poor jumps the gelding had then found today's track conditions too testing. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p>LORD SPENCER (N Downs) - Was inclined to lay out when placed under pressure. Put in a poor jump near the 550 metres and landed awkwardly.</p> <p>OBRIGADO (S Karnicnik) - Contacted near the 600 metres. Hampered after jumping the fence near the 550 metres when LORD SPENCER put in a poor jump and landed awkwardly.</p> <p>BERRY THE CASH (P Matthews) - Improved inside the heels of TEEN TITAN approaching the 600 metres becoming awkwardly placed for a distance.</p> <p>J Kozaczek (METALLO) - Issued with a warning after shifting his mount outwards across the heels of LORD SPENCER which was laying out and in doing so made contact with OBRIGADO near the 600 metres.</p>	
Race 3	ZILCO 1200m

EXPRESS COUP (K Williams) - Underwent a pre-race veterinary examination behind the barriers following an incident in the mounting yard and was cleared to race. Began awkwardly then further hampered losing ground when inside runners shifted out.

MOVIE GIRL (D Subramaniam) - Jumped outwards at the start hampering KITH 'N' KIN.

KITH 'N' KIN (A Goindasamy) - Hampered at the start.

BENAUD (L Callaway) - Slow to begin.

VICTOR ROUGE (D Tait) - Began awkwardly making contact with ANALYST becoming unbalanced and losing ground.

ANALYST (T Moseley) - Contacted at the start.

Race 4 | **VERNON & VAZEY TRUCK PARTS 2000m**

ALBATROSS (A Goindasamy) - Crowded shortly after the start losing ground.

MARGHERITA VELOCE (T Moseley) - Jostled with TAIMATE DIVA for a distance passing the 1600 metres. When questioned regarding performance, rider was unable to offer any excuse.

HARMONIOUS (L Sutherland) - Over raced through the middle stages on a moderate tempo which the rider reported had been detrimental to the mare's chances.

BILLY BOY (K Hercock) - Gave ground from the 800 metres and was not persevered with in the run home. Rider was unable to offer any excuse, advising that the gelding had felt a beaten runner at the 1000 metres. Underwent a post-race veterinary examination which revealed the gelding to have suffered cardiac arrhythmia. Trainer J Rathbone was advised that BILLY BOY will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

Race 5 | **SCENIC HOTEL GROUP 1600m**

HACKSAW RIDGE (L Callaway) - Slow to begin then further hampered when crowded shortly after the start.

JESTIN CASE (K Hercock) - Slow to begin. Raced in restricted room early in the straight. Rider reported the mare had been unable to quicken in today's holding track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

POWERFUL MOSS (K Bakker) - Lay out under pressure passing the 250 metres.

PERFECT TEST (T Moseley) - Rider was of the opinion the mare had found today's conditions too testing in its first race for a month.

Race 6 | **RACECOURSE HOTEL 149TH GRAND NATIONAL STEEPLE CHASE 5600m**

AFTERALLTHISTIME (D Parker) - Slow to begin. Dipped on landing after jumping Cutts Brush near the 2000 metres. Put in a poor jump at the fence near the 1000 metres losing ground then becoming tailed off before being retired from the race after jumping the third last fence near the 800 metres.

INTERLLECTUS (J Kozaczek) - Restrained after jumping from a wide draw.

DONARDO (P Matthews) - Put in a poor jump at the first of the Stand Double on the first occasion then again at the second of the double unbalancing its rider who was dislodged. Rider P Matthews was attended to by St John Paramedics and found to be uninjured. A post-race veterinary examination did not reveal any obvious abnormality.

CAPTAINS RUN (N Downs) - Put in a poor jump at the third last fence losing ground.

AL'S RED ZED (H McNeill) - Raced keenly in the lead in the early to middle stages. Knuckled on landing after jumping the final fence and fell. AL'S RED ZED then lay on the track for some time being attended to by the on-course Veterinarian before regaining its feet.

Race 7 | **STEPHANIE MURRAY MORTGAGES OPEN HANDICAP 1800m**

PROSERVE (K Williams) - Slow to begin.

FREEZE FRAME (A Goindasamy) - Over raced in the early stages on a moderate tempo.

ALJAY (L Sutherland) - Over raced in the early stages on a moderate tempo.

Race 8 | **FRANTIC BLOODSTOCK 1800m**

WAIHORA MIST (K Bakker) - Slow to begin. Held up near the 400 metres.

I HOPE I NEVER (T Moseley) - Slow to begin.

MININJAGIRL (L Callaway) - Slow to begin.

KOYAMA (S Wynne) - Bounded at the start and refused to hit out taking no part in the race. Connections were advised that KOYAMA is required to trial to the satisfaction of a Stipendiary Steward prior to racing next.

MADISON ROSE (A Balloo) - Raced wide without cover throughout.

MISS BELLE (D Subramaniam) - Shifted outwards abruptly over the concluding stages.

MR TWINKLETOES (D Tait) - When questioned regarding performance, rider was of the opinion the gelding failed to back up from its first day run.

MAGIC ACE (D Cooper) - When questioned regarding performance, rider advised that the gelding had felt disinterested.

D Subramaniam (MISS BELLE) - Admitted a charge in that he struck his mount MISS BELLE 12 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of D Subramaniam's licence to ride in races from the conclusion of racing on Friday 16 August until the conclusion of racing on Thursday 29 August, 7 national riding days.

B Murray (CAPTAIN OUMUAMUA) - Admitted a charge in that he struck his mount CAPTAIN OUMUAMUA 10 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of B Murray's licence to ride in races from the conclusion of racing on Friday 16 August until the conclusion of racing on Wednesday 28 August, 6 national riding days.

Race 9 | **HEATSTORE OPEN HANDICAP 1400m**

MASTER MARKO (Y Atchamah) - Jumped away awkwardly.

CHARBANO (S Wynne) - Restrained to obtain cover after jumping from a wide barrier.

MAKABAR (K Williams) - Crowded and checked near the 1100 metres.

LORD DARCI (D Tait) - Dictated inwards having to be checked to avoid heels near the 1100 metres.

LOUIE LOUIE (K Hercock) - Disappointed for a run near the 300 metres having to shift outwards across heels to obtain clear running.

CONOR O'CEIRIN (A Goindasamy) - When asked to comment on performance, rider advised that the gelding had travelled well until placed under pressure in the home straight and had failed to respond to his riding and been disappointing.

A Balloo (STREET FIGHTIN MAN) - Admitted a charge in that he struck his mount STREET FIGHTIN MAN 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of A Balloo's licence to ride in races from the conclusion of racing on Friday 16 August until the conclusion of racing on Wednesday 28 August, 6 national riding days.

L Callaway (THE GOOD SHEPHERD) - Admitted a charge of careless riding in that he permitted his mount THE GOOD SHEPHERD to shift inwards when not sufficiently clear of SEVEN TWENTY which was dictated inwards causing crowding to LORD DARCI and MAKABAR which were both checked near the 1100 metres. After considering submissions the Adjudicative Committee imposed a suspension of L Callaway's licence to ride in races from the conclusion of racing on Saturday 10 August until the conclusion of racing on Friday 23 August, 6 national riding days.

AVITUS (K Hercock) - Slow to begin. Steadied when improving onto heels passing the 900 metres.

TAKE THE DEEL (G Jogoo) - Slow to begin.

THE IMMIGRANT (K Williams) - Slow to begin. Crowded near the 900 metres.

YELLOW JERSEY (B Murray) - Began awkwardly and blundered leaving the barriers. Had to be steadied to avoid the heels of SLIPPERY near the 900 metres.

SLIPPERY (L Sutherland) - Crowded and checked near the 900 metres.

GIANNIS (A Goindasamy) - Crowded near the 900 metres.

EXPLOSIVE LASS (A Balloo) - Crowded near the 900 metres.

S Wynne (IFFIN DOUBT DANCE) - Issued with a warning after using the whip in 2 consecutive strikes on IFFIN DOUBT DANCE just short of the finish.

S Wynne (IFFIN DOUBT DANCE) - Admitted a charge in that she struck her mount IFFIN DOUBT DANCE 7 times prior to the 100 metre mark with a further 6 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Saturday 10 August until the conclusion of racing on Wednesday 28 August, 9 national riding days.

D Tait (VICTORIAN CHARM) - Admitted a charge of careless riding in that she permitted her mount VICTORIAN CHARM to shift inwards when insufficiently clear causing crowding to THE IMMIGRANT, GIANNIS, EXPLOSIVE LASS and SLIPPERY, with SLIPPERY being checked near the 900 metres. After considering submissions the Adjudicative Committee imposed a suspension of D Tait's licence to ride in races from the conclusion of racing on Saturday 10 August until the conclusion of racing on Saturday 17 August, 4 national riding days.
