## RACE COMMENTS

### Race 1 "GIVE A LITTLE" RAHUL SHINDE MAIDEN 1550

**ASPARK PARK** (J Doyle) - Slow to begin. When questioned regarding the performance rider advised that the entire had got back in the running on a moderate tempo and would appreciate a step up in distance.

**OVERTRICK** (T Newman) - Slow to begin.

**DESERT SECRET** (J Nishizuka) – Raced three wide without cover throughout.

**MARCOS** (W Pinn) - Raced keenly through the early and middle stages.

**DANCIN IN THE DARK** (T Mitchell) - Raced keenly through the early and middle stages.

**PRINCESS JASMINE** (M Sanson) – Steadied off heels when racing keenly near the 1100 metres.

**CLAIMED GIFT** (L Sutherland) - Briefly held up behind a weakening runner near the 400 metres.

**RETROSTAR** (C Grylls) - When questioned regarding the improved performance trainer A Forsman advised that the gelding appreciated a step up in distance and the addition of blinkers.

**P Lock** (JAZZ WITH DRAGON) - Admitted a charge in that he was neglectful in saddling JAZZ WITH DRAGON. Stewards investigated the reason as to why K Myers could not draw proper weight when weighing in. It was found post-race that two pieces of lead had become displaced from the leadbag when saddling with rider K Myers weighing in 0.9 kgs under the weight at which she weighed out at. After considering submissions the Adjudicator imposed a fine of \$100.

Following the running of this race the rider of the eighth placed runner JAZZ WITH DRAGON was unable to draw the proper weight being 0.9 kgs under the weight allotted by the handicapper. A Request for a Ruling was filed with the Adjudicator and after hearing submissions JAZZ WITH DRAGON was disqualified from eighth place.

**Race 2** | **CAMBRIDGE EQUINE HOSPITAL 1550**

**NO AGENDA NIGEL** (B Rogerson) – Raced keenly in the early stages. Raced three wide without cover throughout.

**POSTER BOY** (R Goyaram) – Held up rounding the final bend.

**EVANA TRUMPALOT** (K Myers) - Raced keenly through the early stages. When questioned regarding the performance rider advised that the gelding failed to respond when placed under pressure in the final straight.

**Race 3** | **SADDLERY WAREHOUSE MAIDEN 1300**

**SPREZZATURA** (K Myers) – Knuckled leaving the barriers unbalancing its rider, losing ground.

**PROBOY** (J Doyle) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

**VIGOR HAPPINESS** (V Colgan) - Lay outwards when leading through the early and middle stages.

**Race 4** | **WAIPA EARTHWORKS MAIDEN 1300**

**SHAJRA** (J Doyle) - Began awkwardly losing ground. Raced ungenerously through the early and middle stages.

**COSTAE** (K Myers) – Restrained in the early stages to obtain cover after jumping from a wide barrier. Improved onto heels having to be steadied rounding the final bend. Shifted outwards abruptly passing the 100 metres hampering **FINEST HOUR** before being corrected by its rider.

**LADY HIKA** (B Rogerson) - Lay outwards throughout placing the rider at a disadvantage.

**WHAT A YARN** (C Grylls) - Raced three wide without cover throughout.

**ALICANTE** (G Lahoud) – Lay in when placed under pressure in the final straight.

**FINEST HOUR** (R Goyaram) – Contacted and hampered passing the 100 metres.

<b>Race 5</b>	<b>MAJESTIC HORSE FLOATS 1300</b>
<p><b>SIDE EYE</b> (T Mitchell) - Began awkwardly losing ground. Steadied when placed in restricted room near the 50 metres when racing to the inside of HASSTOBEFAST (S Weatherley) which shifted in and outside of ALFRISTON which shifted out slightly. Rider S Weatherley was advised to exercise greater care in similar circumstances.</p> <p><b>DEAR OH DEAR</b> (R Goyaram) - Slow to begin. Raced keenly in the early stages. Returned to the enclosure with blood present in both nostrils. Following a veterinary examination DEAR OH DEAR was confirmed to have bled. DEAR OH DEAR shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.</p> <p><b>KEEGAN</b> (J Doyle) - Slow to begin then restrained to obtain cover after jumping from the outside barrier.</p> <p><b>HASSTOBEFAST</b> (S Weatherley) - Held up rounding the final bend having to shift ground outwards to obtain clear running near the 250 metres.</p>	
<b>Race 6</b>	<b>NZ HORSE AMBULANCE 970</b>
<p>This race was delayed by 8 minutes due to a power outage on-course.</p> <p><b>RUBELLITE</b> (M Hashizume) - Slow to begin. When questioned regarding the performance rider advised that in his opinion the mare was not suited to the synthetic surface.</p> <p><b>SIMSALA</b> (A Lawson-Carroll) - Slow to begin. Lay outwards when placed under pressure over the concluding stages.</p> <p><b>A Lawson-Carroll</b> (SIMSALA) - Issued with a warning after allowing his mount to shift outwards when not fully clear of RUBELLITE which had to be steadied off heels passing the 200 metres.</p>	
<b>Race 7</b>	<b>TAB 2000</b>
<p><b>HEART OF ALLADIN</b> (S Weatherley) - Restrained in the early stages to obtain cover from a wide barrier.</p> <p><b>THE HOUND</b> (T Mitchell) - Restrained in the early stages to obtain cover from the outside barrier. Finished a distant last. When questioned, rider advised that the gelding was unsuited by the synthetic surface.</p> <p><b>SAN SIMEON</b> (W Pinn) - Raced wide in the early stages before being allowed to stride forward to lead near the 1100 metres.</p> <p><b>PATSYS LAD</b> (T Newman) - Hung outwards throughout.</p> <p><b>BRUCEY LEE</b> (L Satherley) - Lost the near hind plate during the running.</p>
