Race 5 SINCLAIR ELECTRICAL & REFRIGERATION OPUNAKE CUP 1400m

SAMOOT (M Hashizume) – Co-trainer Mr. R Wellwood reported to Stewards, that upon return to the stable, SAMOOT, underwent a veterinarian examination which found the mare to have slight bruising in a heal. R. Wellwood further advised the mare has now been sent for a spell.

Manawatu Racing Club @ Awapuni Synthetic, Thursday 25 July 2024

Race 6 HUMPHRIES CONSTRUCTION 1400m

LUXURIANT (L Allpress) – Te Akau Racing Manager, Mr. R Trumper advised Stewards, the stable was satisfied with the post-race condition of LUXURIANT and will continue with the current preparation. R Trumper further advised the stable will look to nominate the gelding at Awapuni Synthetic meeting in a few weeks time.

RACE COMMENTS

Race 1 NORWOOD HAWERA MAIDEN 2100m

AFTERALLTHISTIME (J Chung) - Slow to begin.

MONGOLIAN JUBILEE (L Sutherland) - Restrained to obtain cover from a wide draw.

CRAFTY COLIN (C Dell) - Began awkwardly.

TAKES TIME (E Sole) - Began awkwardly then restrained to obtain cover.

PIPER'S SON (K Hercock) - Lay outwards under pressure over the final 100 metres, dictating VERARDINO wider on the track. K Hercock was advised she is expected to straighten her mount sooner than she did on this occasion.

VERARDINO (M Hashizume) - Dictated wider on the track over the final 100 metres.

Following the running of the race the rider of the 2nd placed VERARDINO, M Hashizume, lodged a protest with the Adjudicative Committee alleging interference in the final straight by the 1st placed PIPER'S SON. After considering submissions the Adjudicative Committee dismissed the protest with placings standing; 1st PIPER'S SON, 2nd VERARDINO.

Race 2 LA NUOVA 2100m

IRRIGATE (C Butler) - Restrained to obtain cover from a wide draw.

KID WARRIOR (R Elliot) - Began awkwardly contacting GLENAMADDY.

GLENAMADDY (C Grylls) - Contacted at the start. Finished last. When questioned regarding performance rider could offer no excuse.

CASCATELLA (L Allpress) - Raced wide in the early stages.

WANNABE 'N' VEGAS (A Riddell) - Restrained to obtain cover from a wide draw shortly after the start.

PERFECTMANZ (J Parkes) - Raced keenly in the early stages.

ROCABURY (L Sutherland) - Finished towards the rear. When questioned rider was of the opinion the gelding would prefer a more rain-affecting footing.

MAGGIESCLAN (E Sole) - Lost the off-hind plate during the running.	
Race 3	PETER KUKLINSKI RETIREMENT MAIDEN 1200m
<p>IMNOTAHARLEY (L Douglas) - Dislodged rider in the preliminary and cantered a short distance prior to being recaptured. Underwent a pre-race veterinary examination behind the barrier and was cleared to start. Rider L Douglas was uninjured. Began awkwardly losing ground.</p> <p>CONFETTI (L Allpress) - Began awkwardly. Raced greenly over the concluding stages.</p> <p>STEWART (J Chung) - Raced greenly throughout.</p> <p>ROZEL (K Hercock) - Raced keenly near the 900 metres having to steady off heels.</p> <p>BELLES FATE (C Grylls) - Raced greenly over the concluding stages.</p>	
Race 4	HILAL @ GRANGEWILLIAM STUD 1200m
<p>FANCYPANTS (C Barnes) - Raced keenly throughout. Lay outwards under pressure over the concluding stages.</p> <p>ROSESRRED (M Hashizume) - Shifted inwards shortly after the start contacting OUR SASSIE ANNE.</p> <p>OUR SASSIE ANNE (L Allpress) - Contacted shortly after the start losing ground.</p> <p>THE WITCH (C Butler) - Raced three-wide from the 800 metres. Lay inwards, having to be straightened near the 200 metres.</p>	
Race 5	PAUL JONES CONSTRUCTION 1200m
<p>FLEMING (M Hashizume) - Reared at the start, then contacted shortly after.</p> <p>STREET GOSSIP (L Allpress) - Began awkwardly.</p> <p>PAPA SURF (J Chung) - Crowded shortly after the start, contacting FLEMING. Lay outwards over the concluding stages.</p> <p>AMOSIA (L Sutherland) - Began awkwardly, crowding inside runners.</p> <p>SINBIN (C Grylls) - Finished towards the rear. When questioned rider was of the opinion the mare may be feeling the effects of recent racing. Trainer R Patterson advised the mare would be sent for a spell.</p>	
Race 6	ECOLAB MAIDEN 1400m
<p>FLORIN (A Riddell) - Began awkwardly.</p> <p>TARQUIN (L Douglas) - Began awkwardly, contacting BOY.</p> <p>BOY (L Allpress) - Contacted at the start, shifting outwards hampering BELFIE. Shifted inwards under pressure in the home straight, having to be straightened.</p> <p>TRIGGER HAPPY (K Hercock) - Shifted outwards marginally near the 250 metres.</p> <p>BELFIE (E Sole) - Was unruly parading to the start, then very awkwardly into stride after being tightened, losing contact with the field. Tailed off, finishing some distance last. Connections were advised that the mare must trial to</p>	

the satisfaction of Stewards prior to its next start. Trainer K Lawrence advised BELFIE will no longer be persevered with as a racing proposition from her stable.

PASSENGER (K Chowdhooory) - Raced keenly in the early stages. Over-raced, having to be steadied near the 950 metres. Had to be steadied near the 250 metres when BOY (L Allpress) shifted inwards under pressure simultaneously as TRIGGER HAPPY (K Hercock) shifted outwards marginally. K Chowdhooory viewed video footage but elected not to proceed with an objection against the 1st placed TRIGGER HAPPY. L Allpress and K Hercock were both advised to exercise greater care when shifting ground.

E Sole (BELFIE) - Issued with a warning for the use of her whip on a runner out of contention.

Race 7 | **GREAT VALUE SIRES @ GRANGEWILLIAM STUD 1600m**

COMEDY (A Riddell) - Slow to begin. Lay outwards over the concluding stages having to be straightened.

HARDTIMES (E Sole) - Began awkwardly.

COCKTAIL LAD (L Douglas) - Raced wide in the early and middle stages.

Race 8 | **ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1600m**

DOJAKATA (L Douglas) – Restrained early stages to take cover.

EXPLOSIVE IMPACT (L Allpress) - Raced keenly through the early stages.

FIVE BELLS (K Chowdhooory) – Slow away. Over-raced in the back straight. Checked near the 300 metres.

TRICK THIMBLE (K Kalychurun) – Raced wide throughout. Made the home bend awkwardly and was inclined to hang outwards and a short distance further was hampered when EXPLOSIVE IMPACT shifted inwards marginally simultaneously as KEEN ON BUBBLES was angled outwards. After questioning riders Stewards took into consideration the racing manners of TRICK THIMBLE when assessing the interference, and could not be fully satisfied that either rider was at fault.

E Sole (KEEN ON BUBBLES) - Admitted a charge of careless riding in that she permitted her mount KEEN ON BUBBLES to shift outwards near the 300 metres when not sufficiently clear of FIVE BELLS, which was checked. After hearing submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing today, Sunday, 4 August, up to and including racing on Sunday, 11 August, 5 national riding days.
