### RACE COMMENTS

**Race 1** | **SPEIGHT'S SUMMIT ULTRA ON TAP MAIDEN 1400m**

**YAK SHA** (K Mudhoo) - Reared as the start was effected losing ground.

**MANZAPPEAL** (T Comignaghi) - Slow away. Held up early in the straight.

**LUV ROSAY** (S Wynne) - Slow away.

**HEADING TO NOOSA** (T Moseley) - Slow away.

**BANDROSSAN** (B May) - Raced ungenerously when being restrained shortly after the start. Steadied when placed in restricted room near the 350 metres to the outside of INSPIRATION which was taken out by TRANQUIL EYES (G Jogoo). G Jogoo was advised to exercise greater care.

**CHEQUERED** (D Cooper) - Over raced when being restrained passing the 1200 metres. Hung outwards in the straight.

**TOMMY SHELBY** (L Hemi) - Steadied when placed in restricted room to the inside of LONE SPIRIT which lay in passing the 1000 metres. Again steadied when awkwardly placed inside the heels of LONE SPIRIT near the 800 metres.

**OUR BRAVEHEART** (R Muniandy) - Held up near the 250 metres having to be checked off heels.

**C Campbell** (SHINTO) - Admitted a charge in that he struck his mount SHINTO 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

**Race 2** | **CHCH CASINO 29<sup>TH</sup> SOUTH ISLAND AWARDS 13 SEPTEMBER 1000m**

**THATS CHARMING** (K Williams) - Slow away. Held up for clear racing room passing the 100 metres having to be restrained away from heels.

**VIVACIOUS** (W Pinn) - Slow away.

**MOGUL** (Y Atchamah) - Began awkwardly making contact with OUR CLARRY then being restrained to obtain cover but racing wide throughout.

**OUR CLARRY** (L Hemi) - Contacted leaving the barriers.

The track was upgraded to Good 4 retrospective to Race 2.

**Race 3** | **PRYDE'S EASIFEED OPEN SPRINT 1000m**

**STREET FIGHTIN MAN** (A Balloo) - Proved difficult to load delaying the start. Raced wide throughout.

**LOUIE LOUIE** (A Goindasamy) - Jumped away awkwardly then clipped a heel and blundered shortly after when THIRD DECREE lay in away from STREET FIGHTIN MAN leaving the barriers.

**VICTOR ROUGE** (D Tait) - Over raced in the early stages.

**BLEAKHOUSE BURTIE** (A Najib) - Lay in throughout the run home having to be straightened by its rider on a number of occasions. Rider dropped his whip near the 50 metres.

**Race 4** | **VALE KEVIN HICKMAN 3YO 1000m**

The start of this race ran approximately 4 minutes late due to the pony race following Race 3 delaying runners entering the mounting yard.

**ENTERPRISE** (D Subramaniam) - Raced wide and lay in under pressure throughout the straight having to be corrected by its rider.

**JETSTREAM** (S Weatherley) - Hampered leaving the barriers when LAVENDER HAZE shifted inwards losing ground.

**LAVENDER HAZE** (K Williams) - Jumped away awkwardly then lay in hampering JETSTEAM which lost ground.

**TEMBO** (T Moseley) - Slow to begin then being further crowded and hampered losing ground.

**TIMEISRUNNINGOUT** (A Goindasamy) - Raced ungenerously when being restrained in the early to middle stages.

**CONFLICT** (A Balloo) - Held up early in the straight and did not obtain clear running until shifting ground passing the 300 metres.

**Race 5** | **NZ CUP WEEK TICKETS ON SALE 1 SEPTEMBER 1200m**

**CONTEMPLATION BAY** (C Barnes) - Began awkwardly then lay in making contact with SAY SATONO which forced GOLDIE'S CHANCE across heels losing ground. Over raced in the early stages. When questioned regarding performance, rider advised that the mare had raced in a very fresh state today and would derive benefit from the race. A post-race veterinary examination did not reveal any obvious abnormality.

**SAY SATONO** (K Williams) - Hampered when contacted at the start. Had to be steadied when placed in restricted room passing the 450 metres.

**GOLDIE'S CHANCE** (T Comignaghi) - Hampered at the start losing ground.

**PAPAGENA** (S Toolooa) - Over raced in the early to middle stages. Lay out rounding the final turn forcing VICTORIAN CHARM, FRENCH ROSE and EL VIENTO wider on the track.

**VICTORIAN CHARM** (D Tait) - Inconvenienced when forced wider near the 450 metres.

**FRENCH ROSE** (J Allen) - Inconvenienced when forced wider near the 450 metres.

**EL VIENTO** (W Pinn) - Inconvenienced when forced wider near the 450 metres.

**MOVIE GIRL** (A Najib) - Had to steady after improving onto heels over the concluding stages.

**Race 6** | **GROUP 1 RACEDAY PARTY 14 SEPTEMBER 1800m**

**TAKE THE DEEL** (G Jogoo) - Slow to begin.

**TELLME YOU LOVEME** (D Cooper) - Raced three wide without cover throughout.

**ALBATROSS** (D Tait) - Steadied when placed in restricted room near the 1500 metres when CEE ARE EL shifted outwards when being restrained and EULOGY SHOW when being steadied to avoid heels.

**EULOGY SHOW** (A Balloo) - Had to be steadied to avoid the heels of PEECEE PUSSYCAT which shifted inwards when not fully clear near the 1500 metres.

**S Wynne** (PEECEE PUSSYCAT) - Issued with a warning after permitting her mount PEECEE PUSSYCAT to shift inwards when not fully clear of EULOGY SHOW near the 1500 metres.

**L Hemi** (LOMBARDI) - Admitted a charge in that she struck her mount LOMBARDI six times prior to the 100 metre mark with a further six strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**Race 7** | **CJC STALLION TENDER OPEN NOW 1800m**

**JUSTASKPERCY** (D Tait) - Slow away.

**IFFIN DOUBT DANCE** (S Wynne) - Slow away. Held up rounding the final bend only obtaining clear running passing the 200 metres. Had to be shifted away from heels over the concluding stages.

**SASSY CHOUXS** (L Hemi) - Slow away. Steadied when briefly placed in restricted room to the inside of OUR KIWI GIRL (S Weatherley) near the 1500 metres. S Weatherley was advised to exercise greater care.

**SPROCKET ROCKET** (R Muniandy) - Over raced passing the 1600 metres and when being restrained shifted inwards when not fully clear of CAPTAIN OUMUAMUA. R Muniandy was advised to exercise greater care.

**CAPTAIN OUMUAMUA** (D Cooper) - Hung badly throughout.

**ANNELIESE** (T Moseley) - Raced three wide without cover through the middle stages.

**FABLUE** (A Balloo) - Lay out throughout the run home having to be straightened.

**D Cooper** (CAPTAIN OUMUAMUA) - Admitted a charge of using the whip in two consecutive strides near the 700 metres. After considering submissions the Adjudicative Committee imposed a fine of \$200.

**STAR BALLOT** (W Pinn) - Slow away.

**MASTER MARKO** (Y Atchamah) - Began awkwardly then blundered shortly after the start.

**JON OL ROCCO** (K Williams) - Steadied when placed in restricted room to the inside of GREEN LUCK near the 1300 metres getting its head up. JON OL ROCCO was then inclined to over race through the middle stages.

**TARAMEA LAD** (C Barnes) - Raced three wide without cover for the majority of the race.

**FIERCE FLIGHT** (J Allen) - Was inclined to lay inwards under pressure in the straight.

**JACKMAN** (Y Atchamah) – Declared a late scratching on veterinary advice behind the barriers due to having blood present in the left nostril. Subsequently underwent an endoscopic examination which was clear.

**THE IMMIGRANT** (S Weatherley) - Slow away

**GAME DUKE** (G Jogoo) - Slow away.

**BUGATTI** (K Mudhoo) - Slow away.

**PING** (A Goindasamy) - Over raced in the early to middle stages. Contacted by BLANCHE which lay in near the 1000 metres.

**TONIA'S DRAGON** (T Moseley) - Raced three wide without cover throughout.

**BLANCHE** (A Najib) - Unbalanced when receiving contact to its hindquarters near the 700 metres.

**EXPLOSIVE LASS** (A Balloo) - Held up early in the final straight.

**RETAIL THERAPY** (T Comignaghi) - Lay inwards under pressure over the concluding stages making contact with CINNAMON GIRL passing the winning post.

**A Najib** (BLANCHE) - Admitted a charge in that he struck his mount BLANCHE eight times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of A Najib's licence to ride in races from the conclusion of racing on Sunday 8 September until the conclusion of racing on Sunday 22 September, 8 national riding days. Due to his poor record under this rule A Najib was further directed to meet with an NZTR Rider Skills Review Panel under the provisions of Rule 356.

**W Pinn** (KABUGEE) - Admitted a charge in that he struck his mount seven times prior to the 100 metre mark with a further four strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$350.
